Weekly setup

Constructive, but selective

The weekly trend is active. Price is 39.6% above the Trend Line and sits at 62.3% of its 52-week range. The latest completed week returned 1.0%, after a 14.4% four-week move. The latest factor snapshot indicates quality ranks weakly versus its universe; growth is moderate; valuation is expensive relative to peers. Options positioning is volatility with 57/100 conviction, while the latest news-sentiment score is 59/100. Near-term considerations: volume confirmation is below normal; earnings are due in 7d.

Technical setup score 55/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

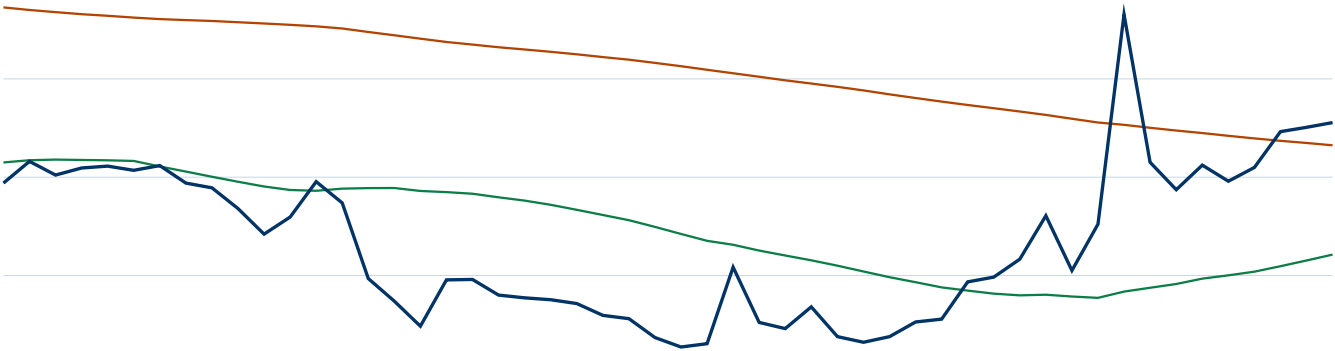

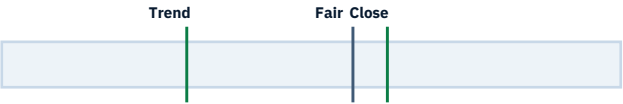

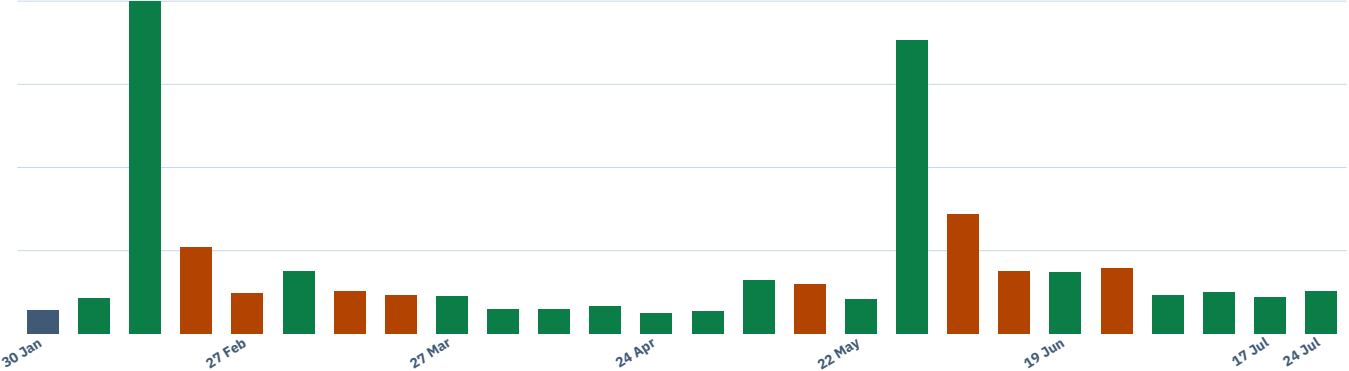
02 · VOLUME AND DEMAND

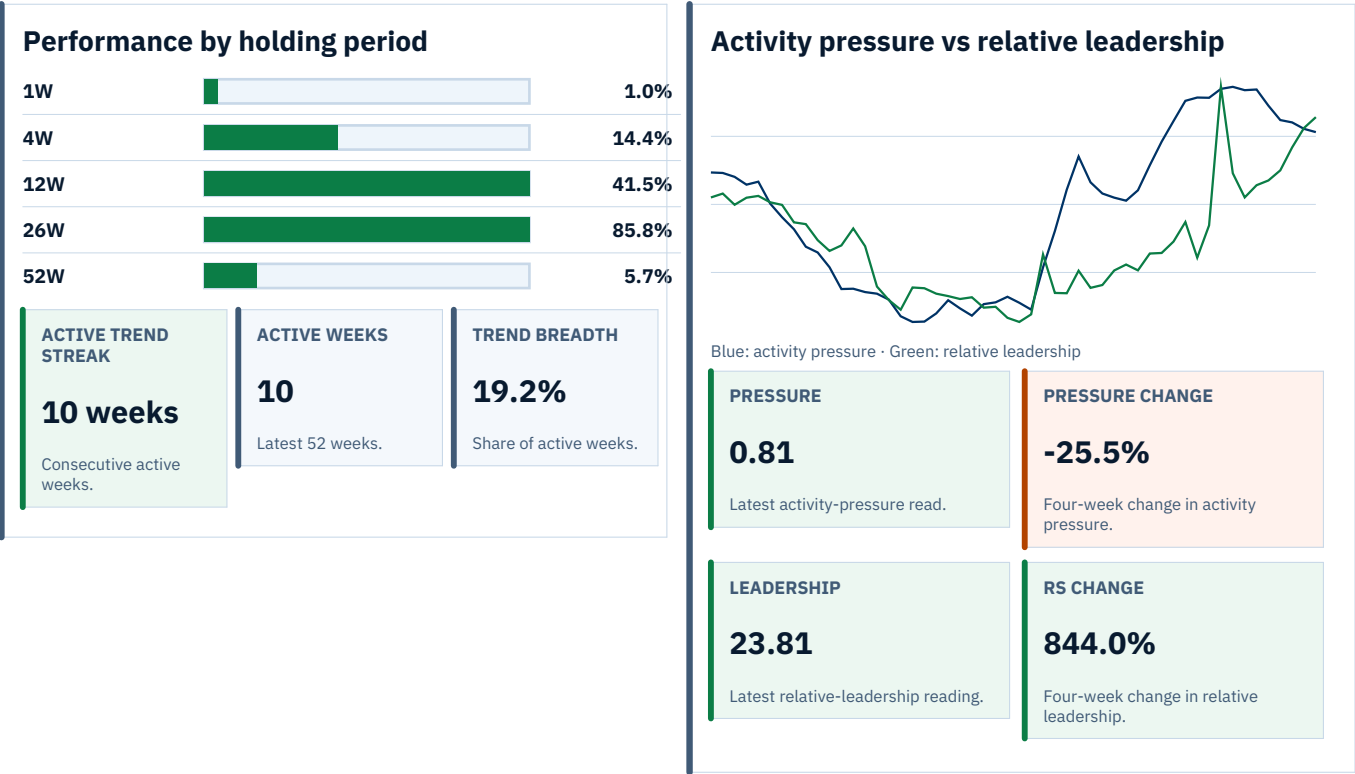

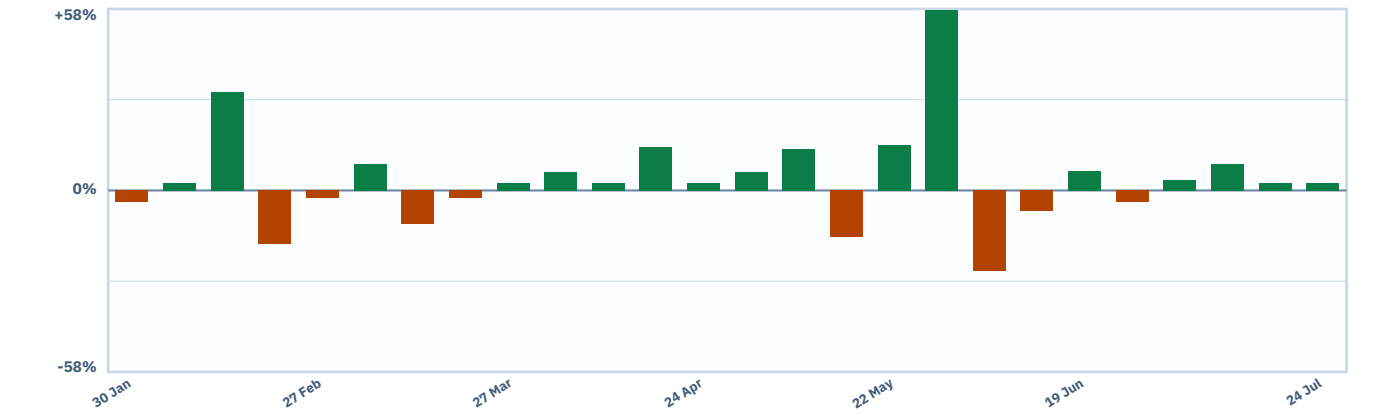
