The weekly trend is active. Price is 11.2% above the Trend Line and sits at 69.5% of its 52-week range. The latest completed week returned -1.9%, after a -6.7% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth is moderate; valuation is expensive relative to peers. Options positioning is volatility with 55/100 conviction, while the latest news-sentiment score is 54/100. Near-term considerations: volume confirmation is below normal; earnings are due in 1d.

Technical setup score 58/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

What could go wrong

- Activity pressure is negative, which weakens the current setup.
- 12 reversal markers appear in the recent smart-money tape.

What to watch next

- Trend Line remains the key weekly regime level.
- Activity pressure is the gauge to monitor for confirmation or fade.
- A volume ratio above 1.5x would show stronger participation in the next move.

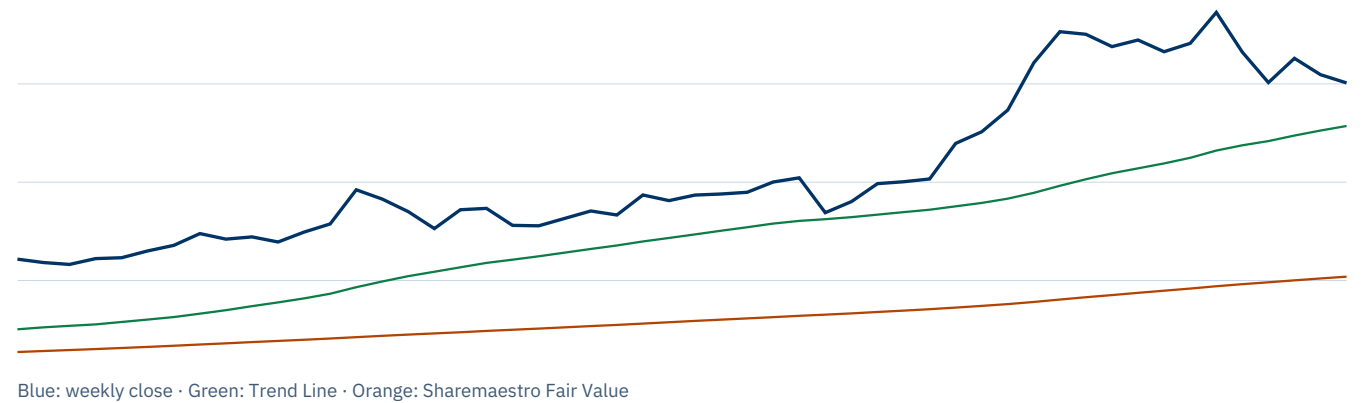

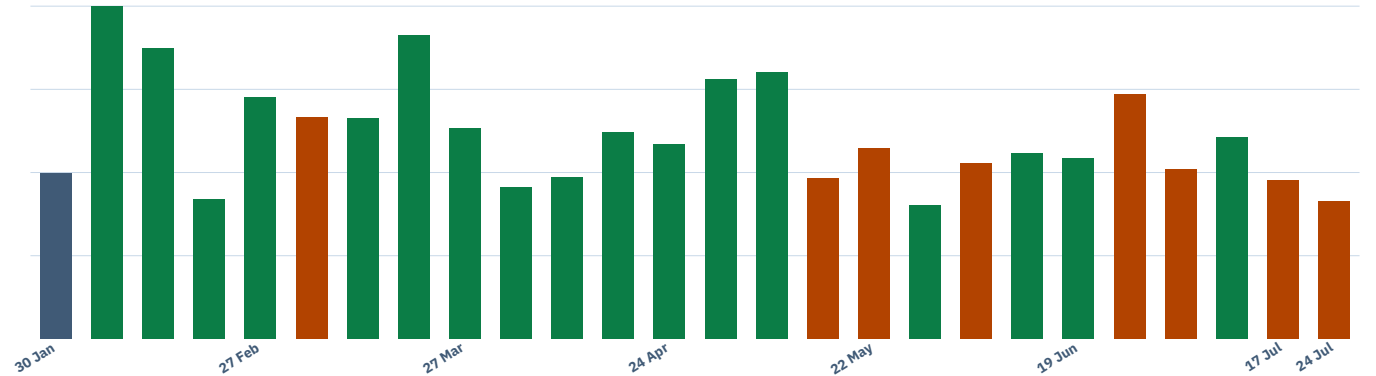
02 · VOLUME AND DEMAND

Bar height shows weekly volume. Green marks an up week; orange marks a down week.

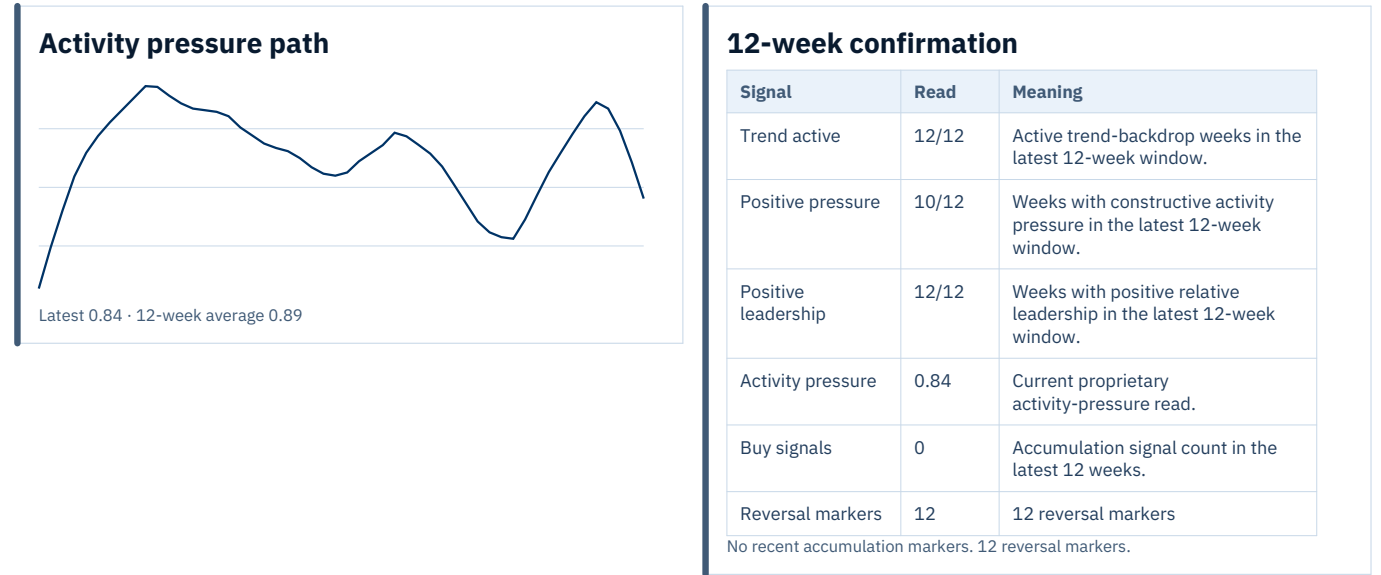

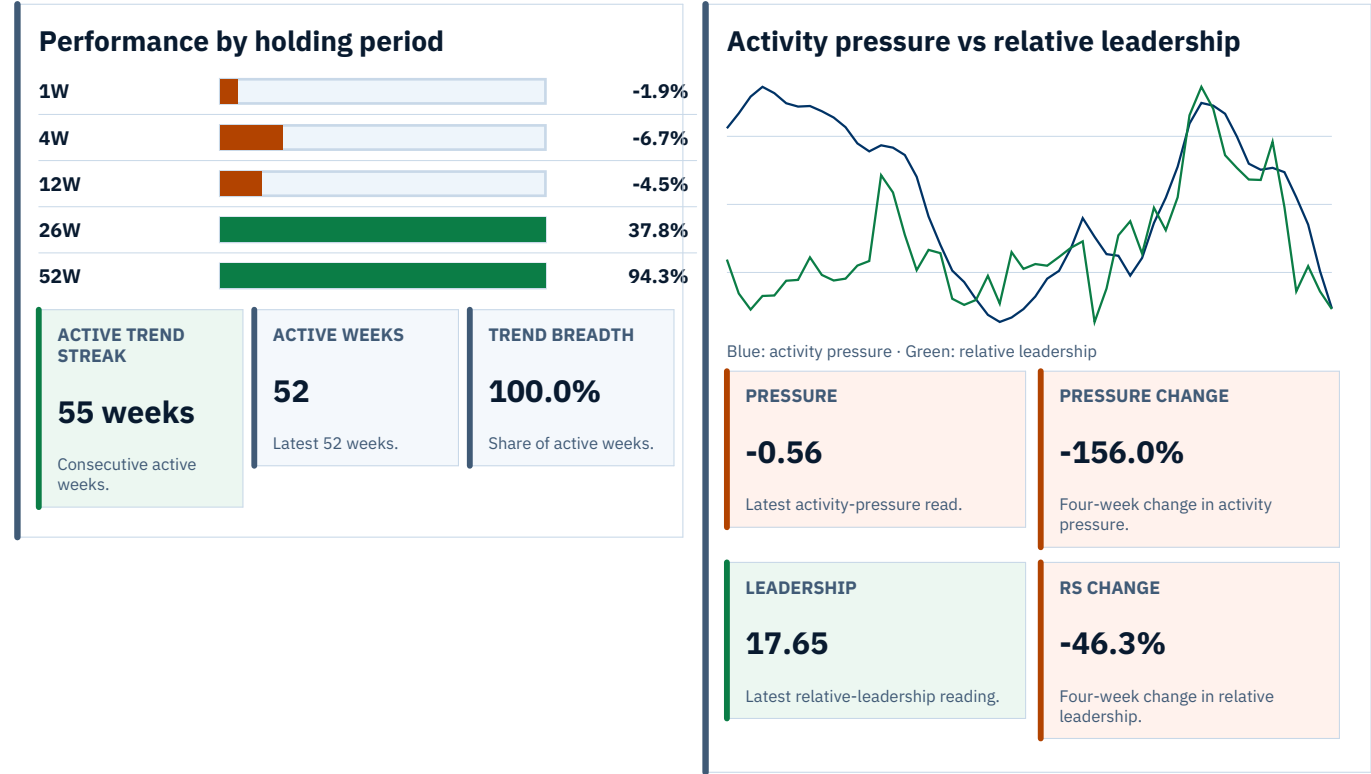

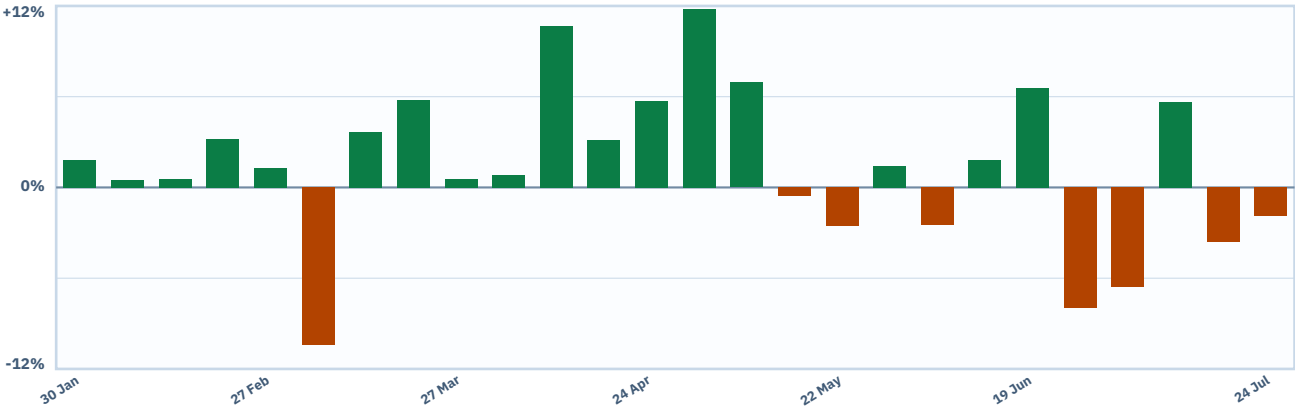
