Weekly setup

Constructive, but selective

The weekly trend is active. Price is 16.6% above the Trend Line and sits at 92.5% of its 52-week range. The latest completed week returned 0.0%, after a 3.2% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth is moderate; valuation is inexpensive relative to peers. Options positioning is bullish with 48/100 conviction, while the latest news-sentiment score is 57/100. Near-term considerations: price is close to its 52-week high; earnings are due in 84d.

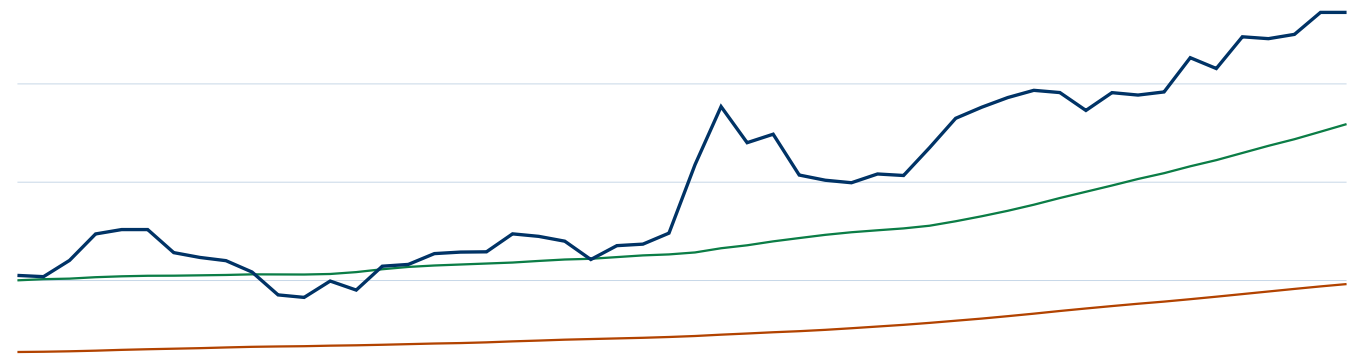

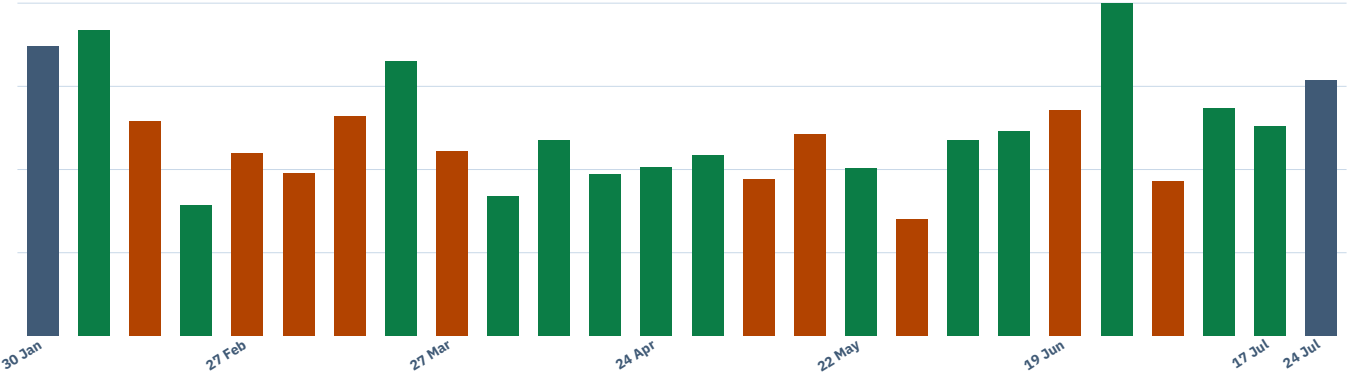

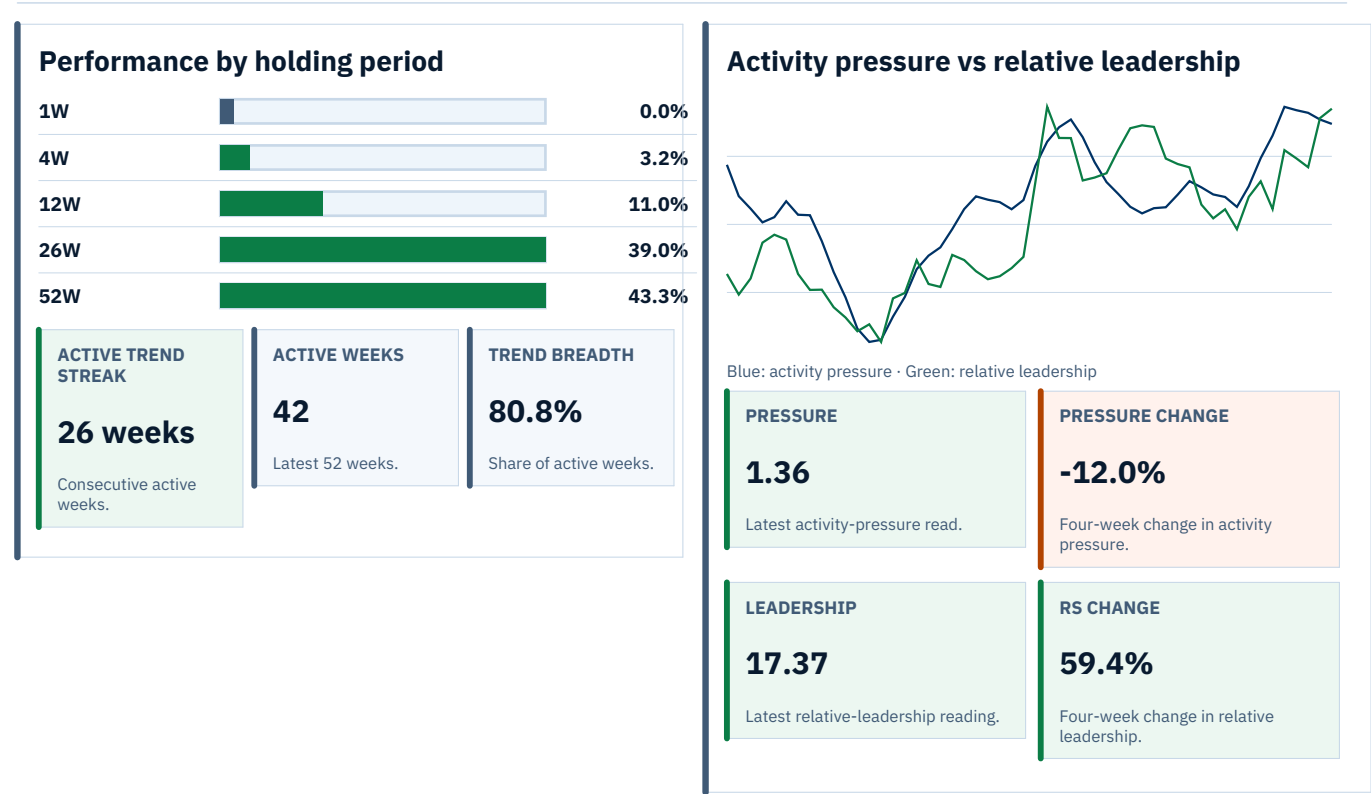

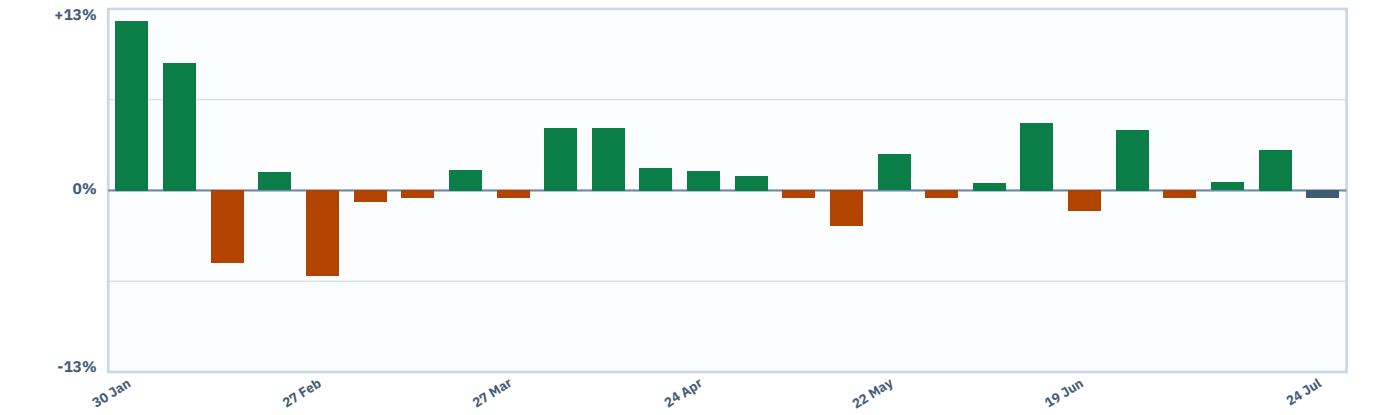
