Options positioning is mixed with 29/100 conviction, while the latest news-sentiment score is 58/100. Near-term considerations: earnings are due in 81d.

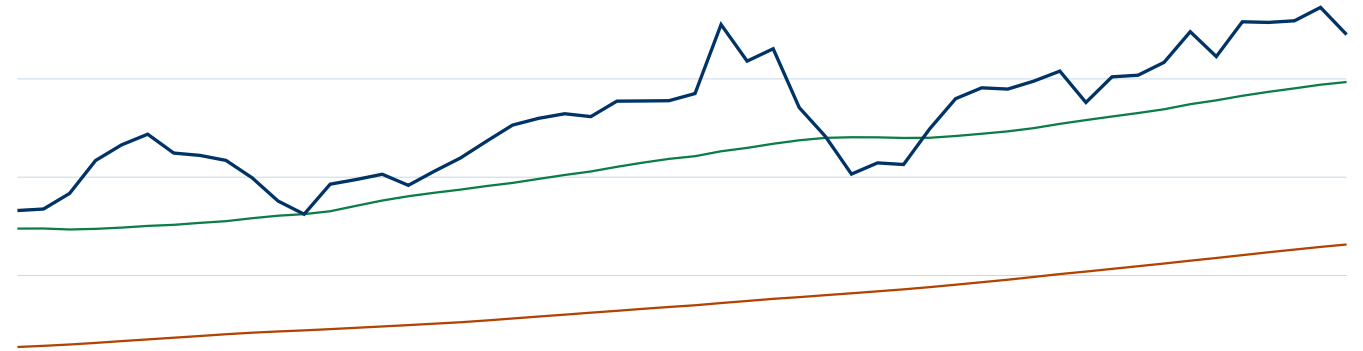

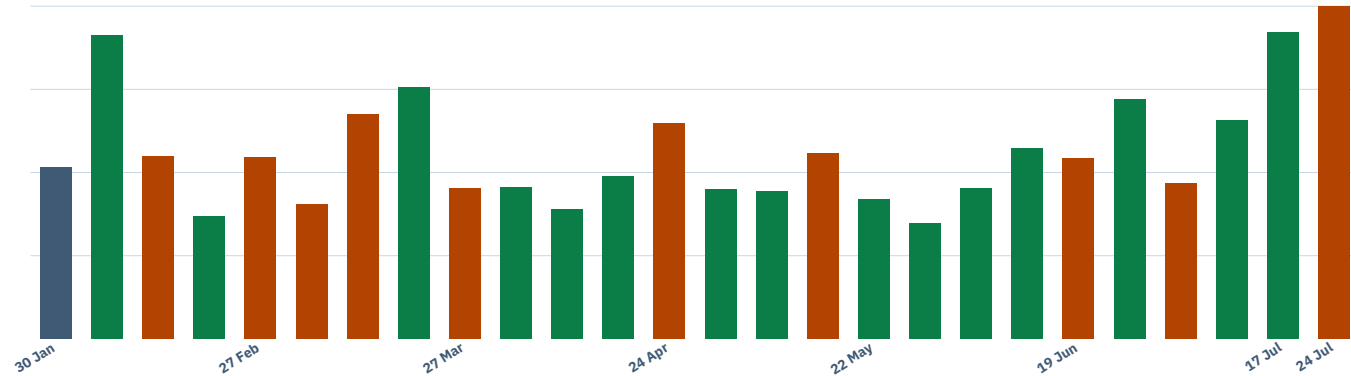
02 · VOLUME AND DEMAND

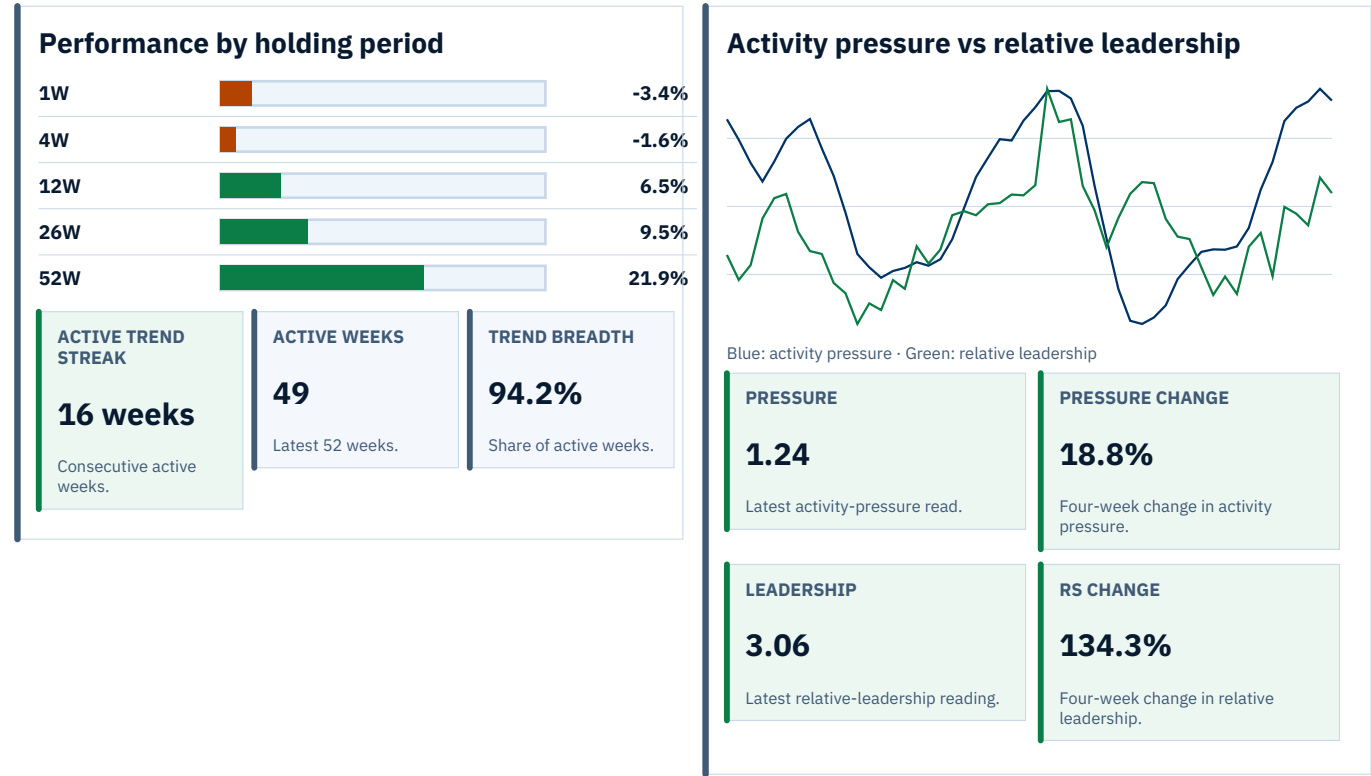

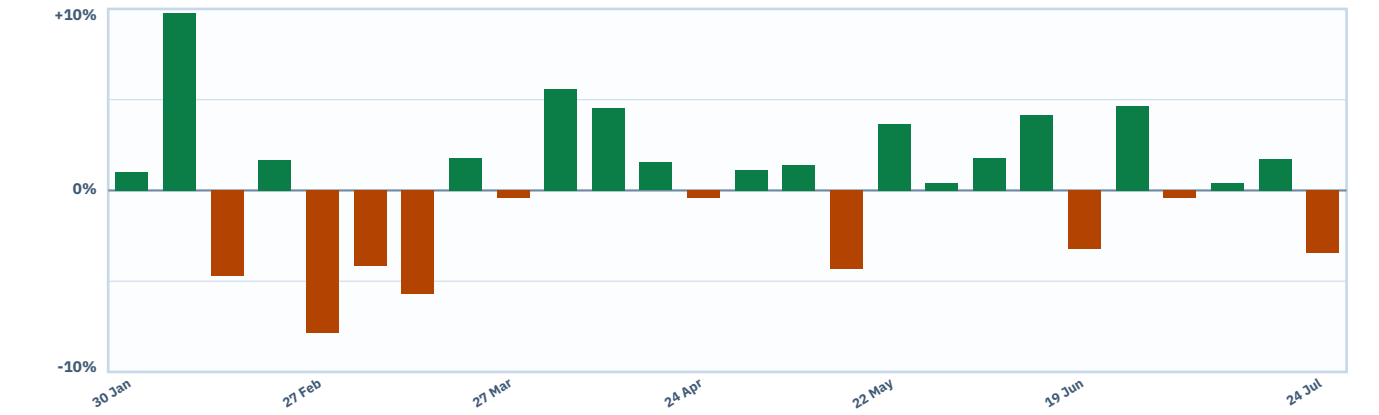
