# Constructive, but selective

The weekly trend is active. Price is 27.5% above the Trend Line and sits at 89.1% of its 52-week range. The latest completed week returned -2.2%, after a 20.7% four-week move. The latest factor snapshot indicates quality ranks strongly versus its universe; growth is moderate; valuation is neither clearly cheap nor expensive. Options positioning is volatility with 57/100 conviction, while the latest news-sentiment score is 54/100. Near-term considerations: volume confirmation is below normal; earnings are due in 6d.

Technical setup score 75/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

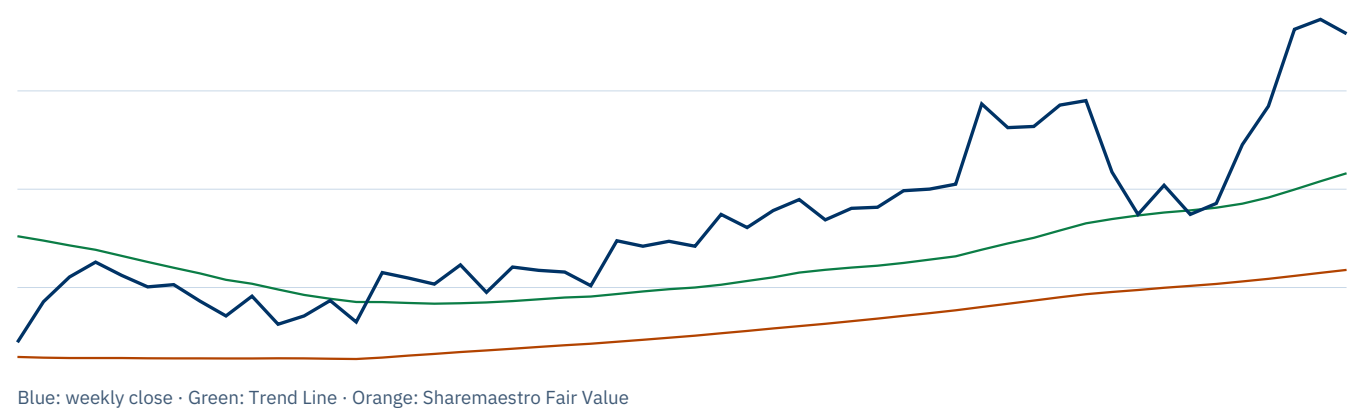

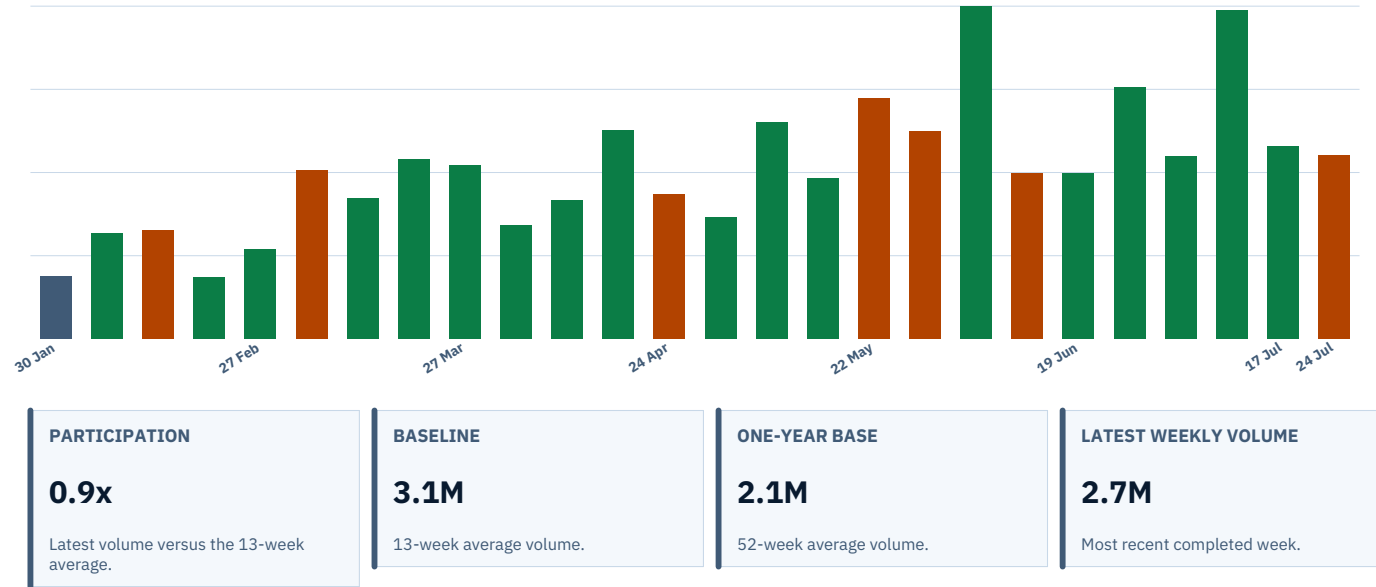

## Activity pressure and institutional-style signals

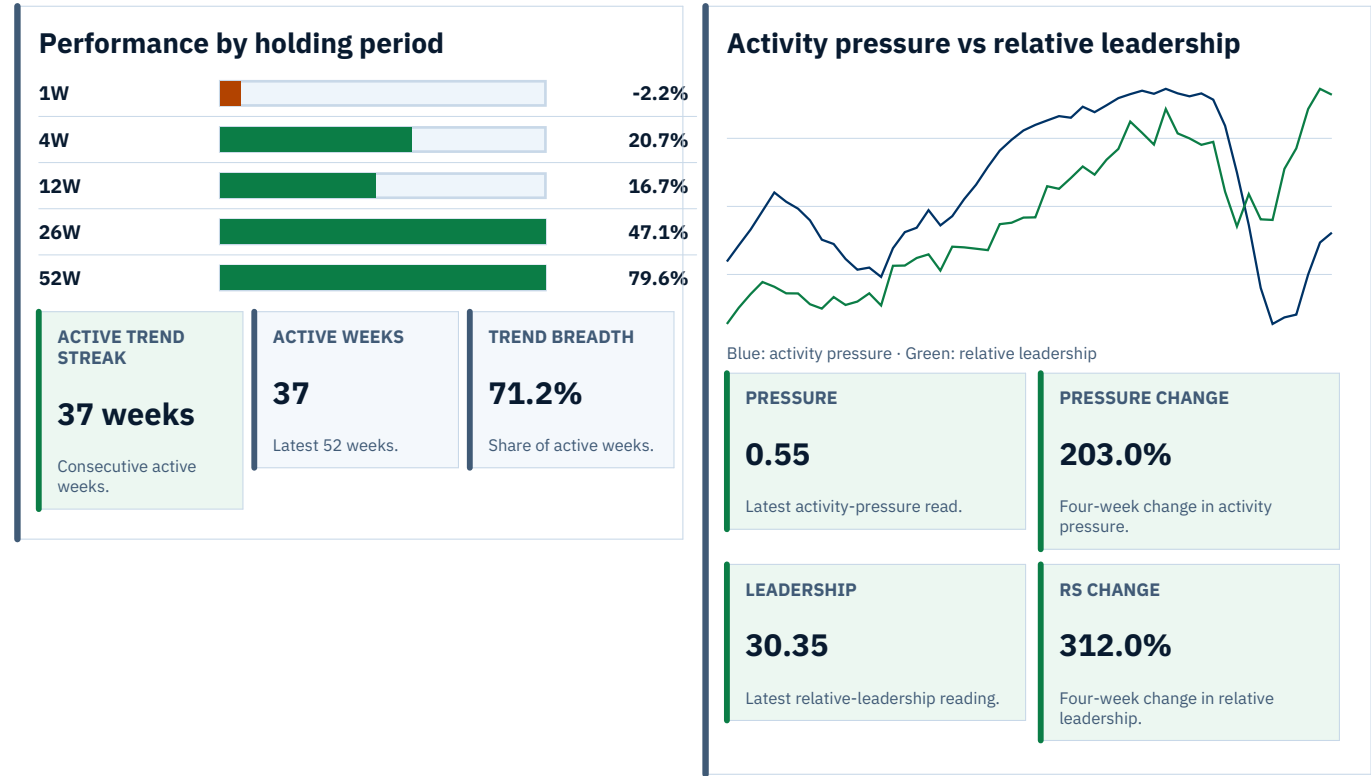

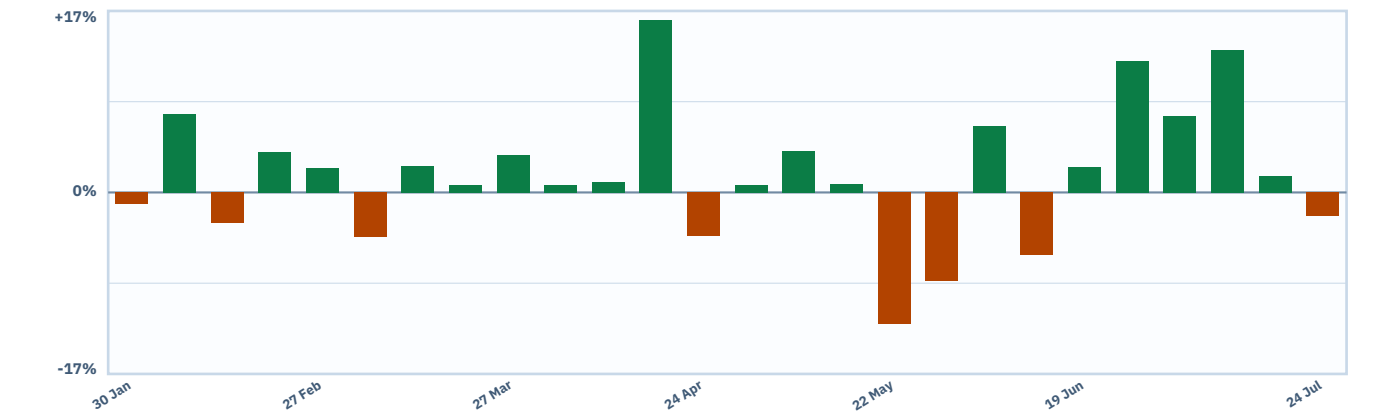
