Weekly setup

Constructive, but selective

The weekly trend is active. Price is 14.1% above the Trend Line and sits at 96.4% of its 52-week range. The latest completed week returned 3.0%, after a 3.2% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth ranks strongly; valuation is inexpensive relative to peers. Options positioning is bullish with 43/100 conviction, while the latest news-sentiment score is 55/100. Near-term considerations: price is close to its 52-week high; earnings are due in 82d.

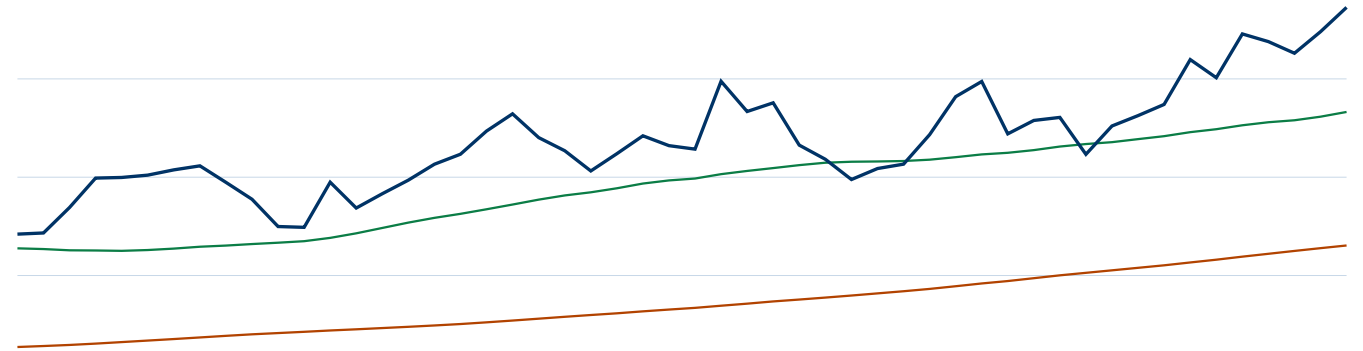

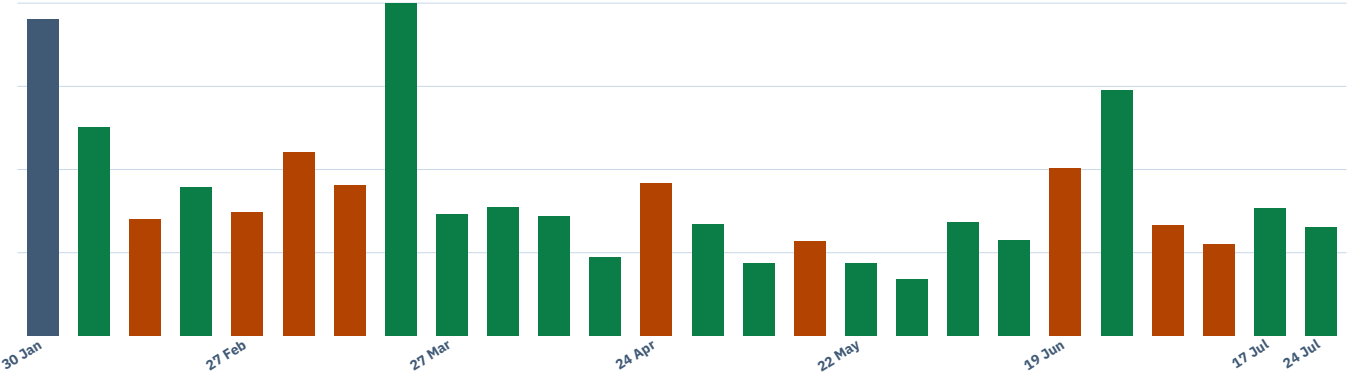

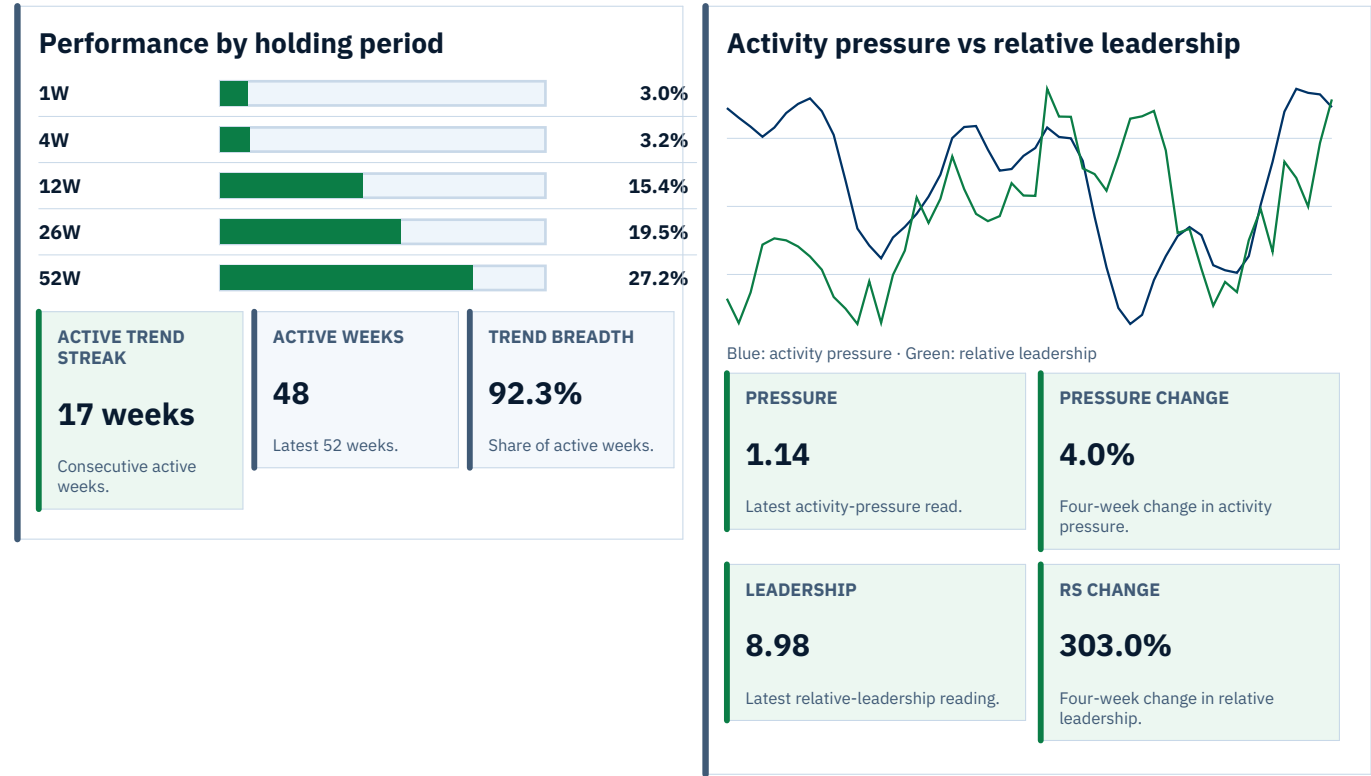

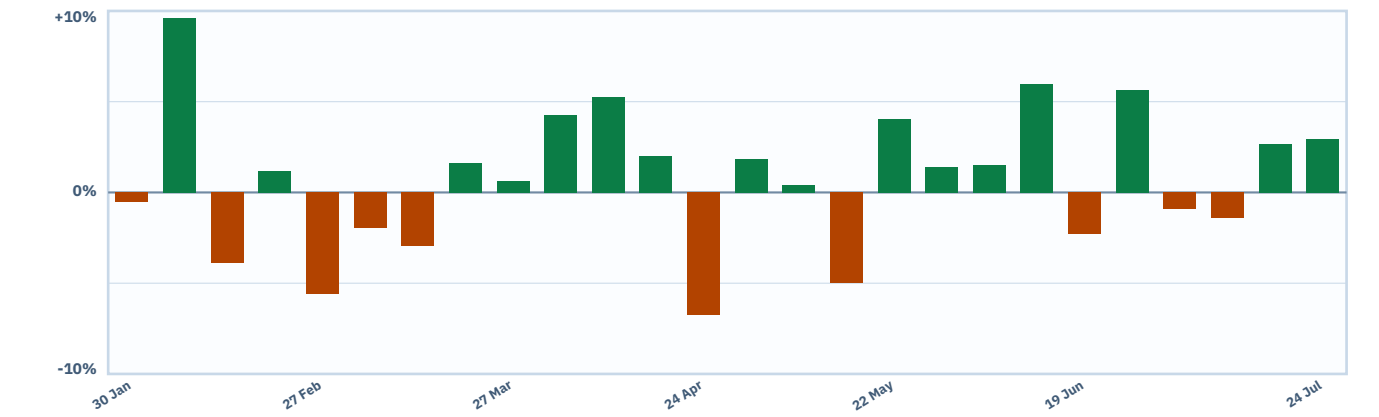
