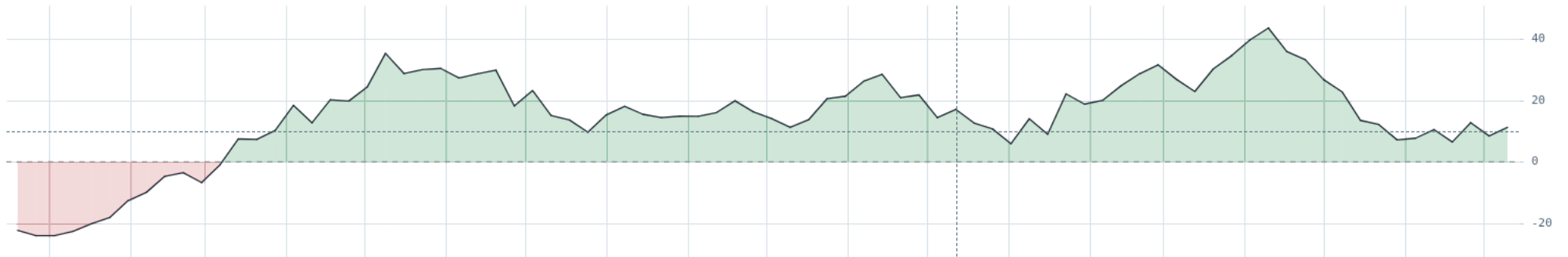

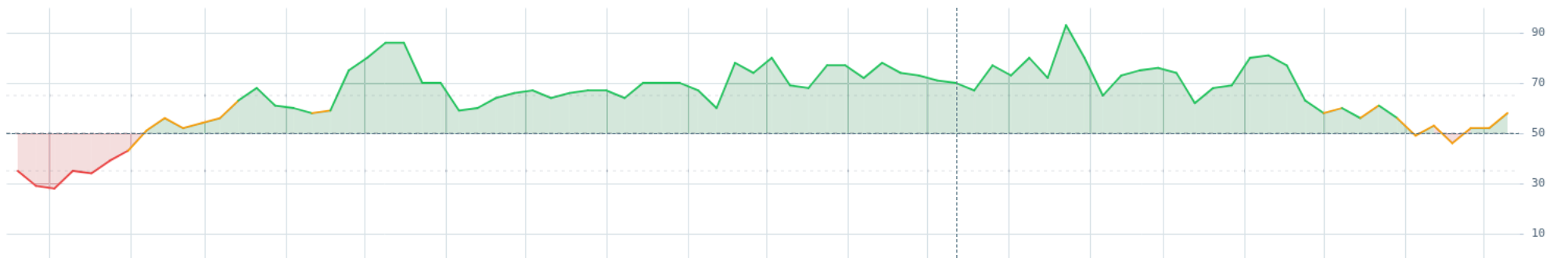

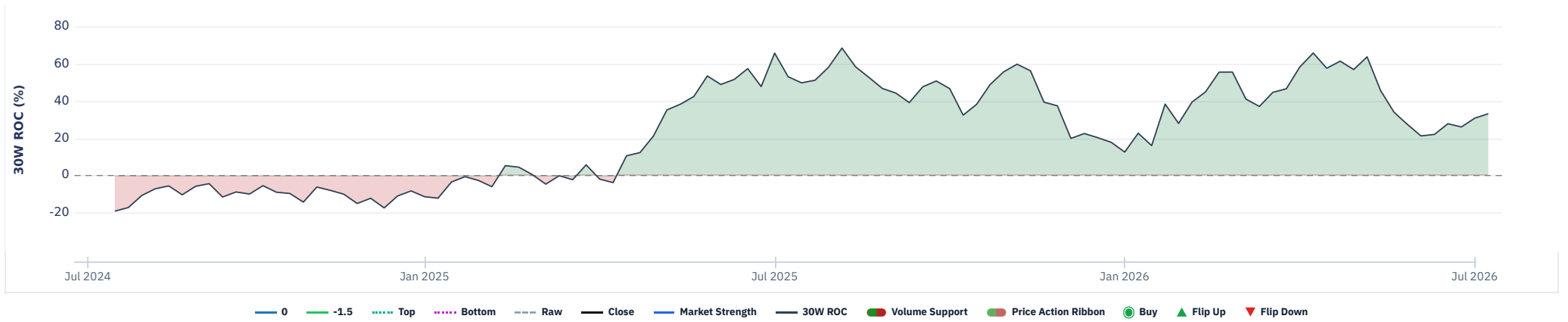

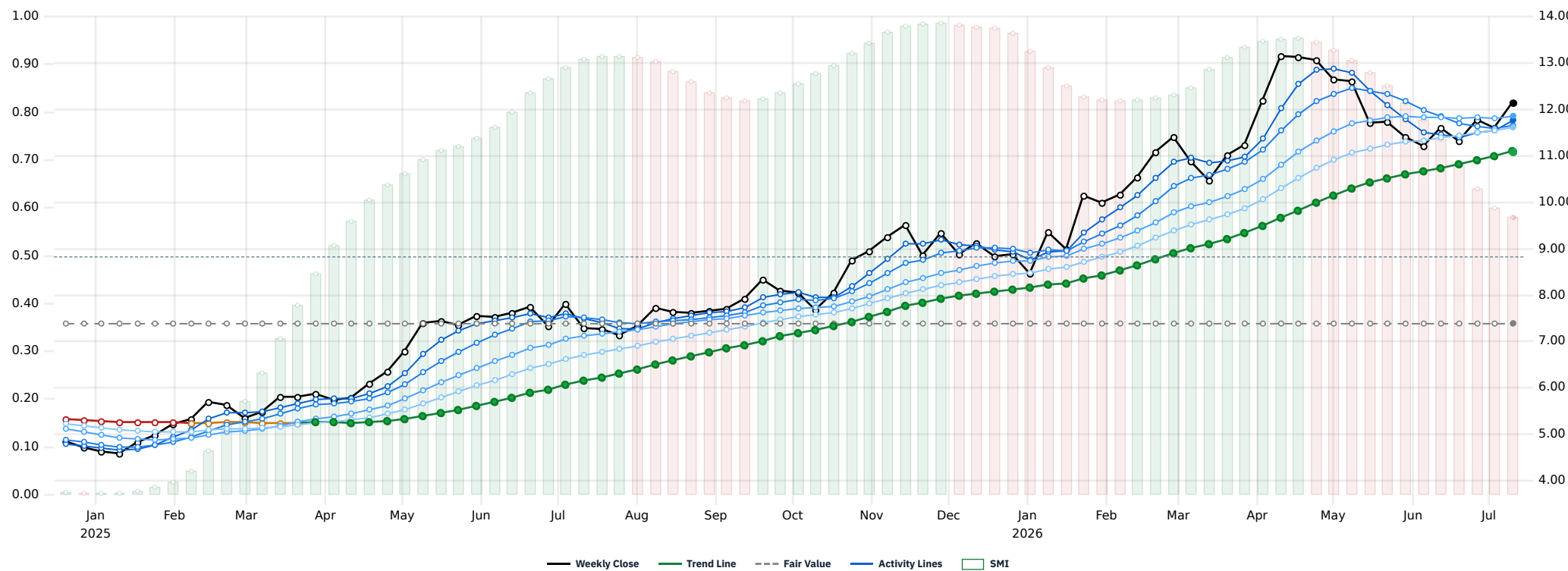

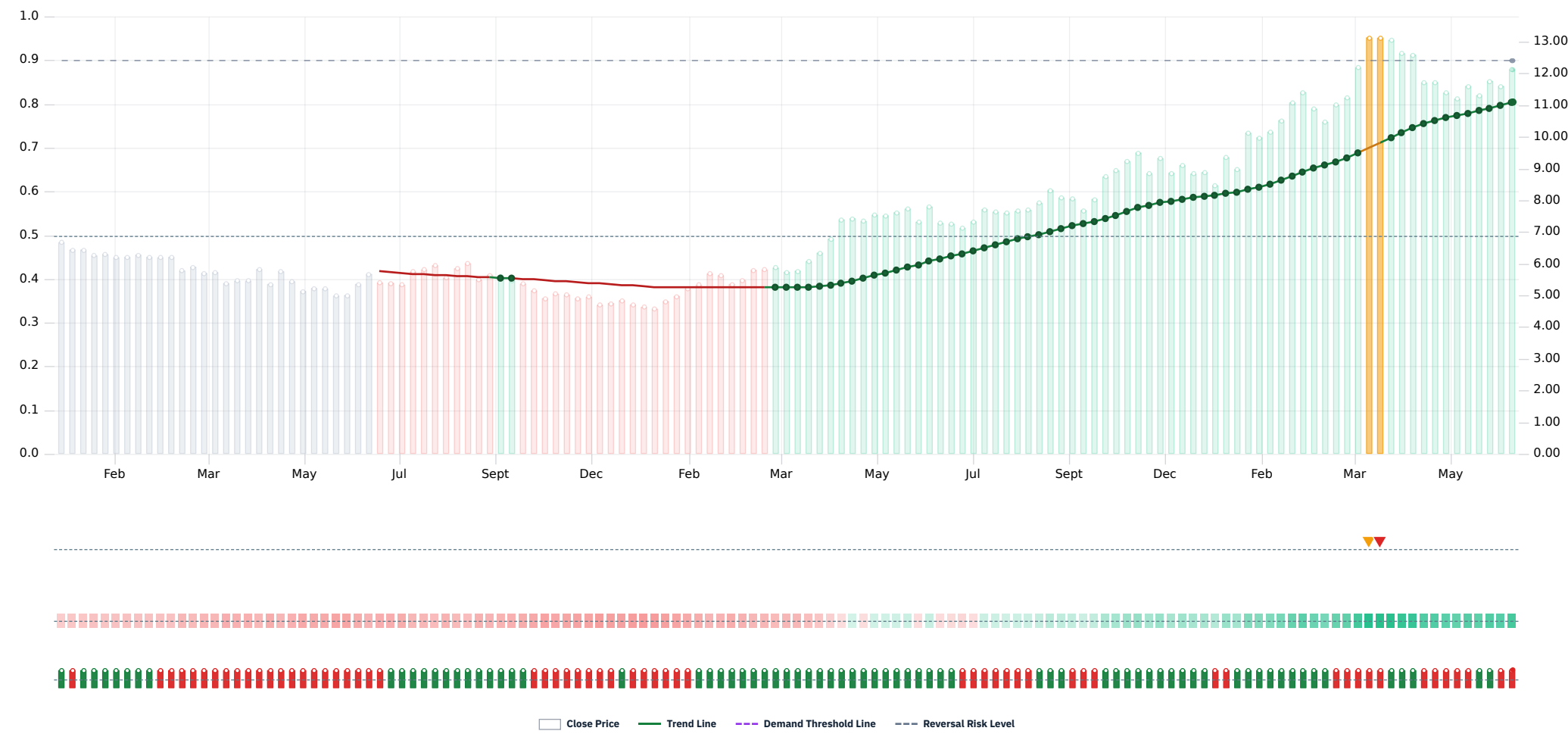

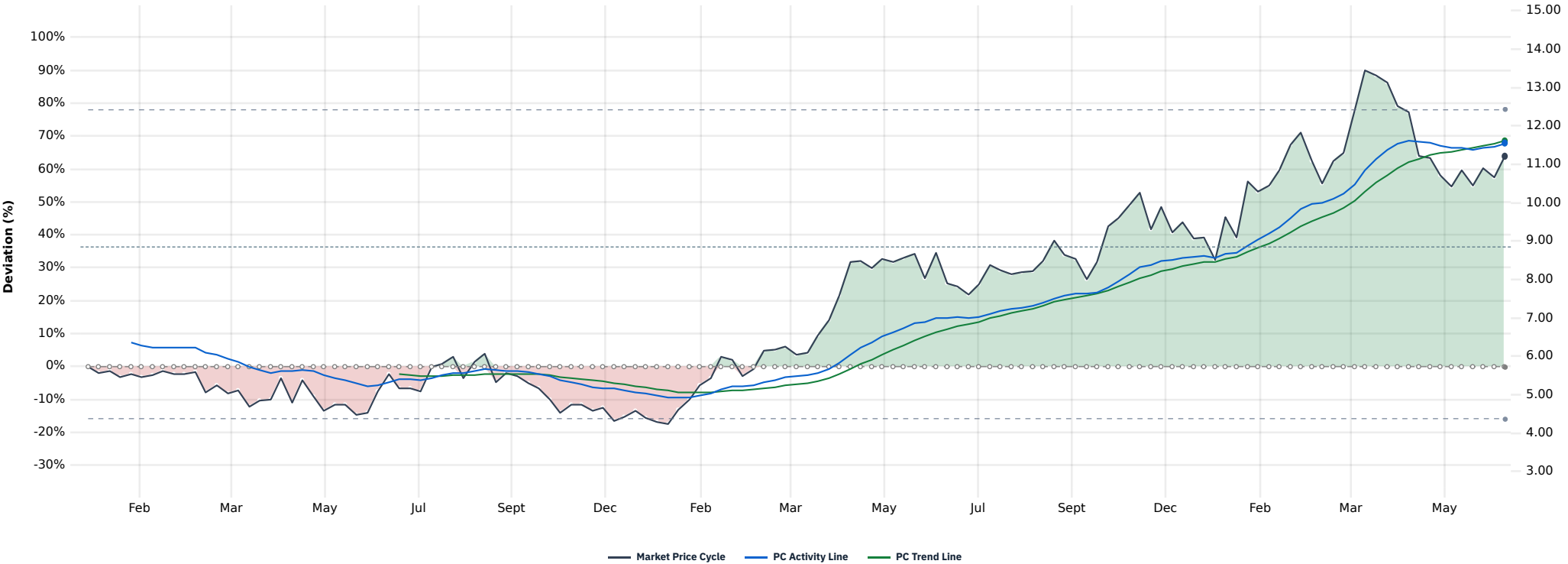

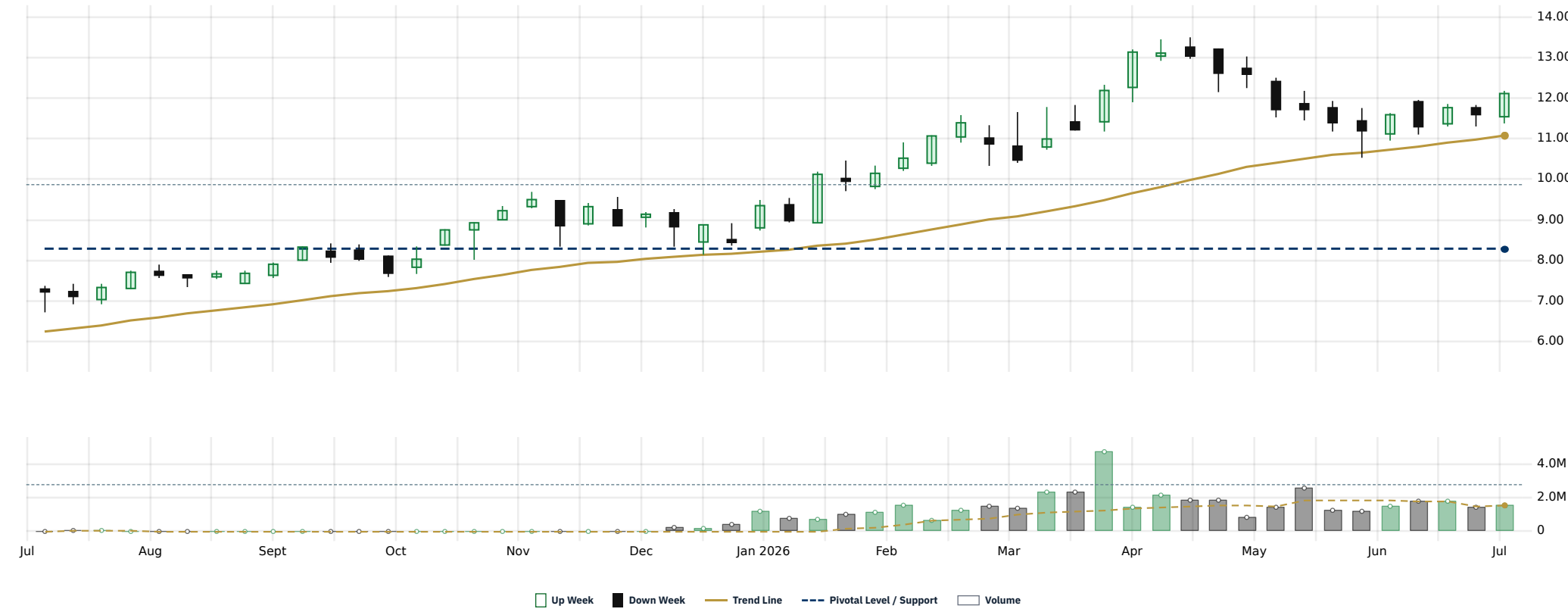
Price Cycle

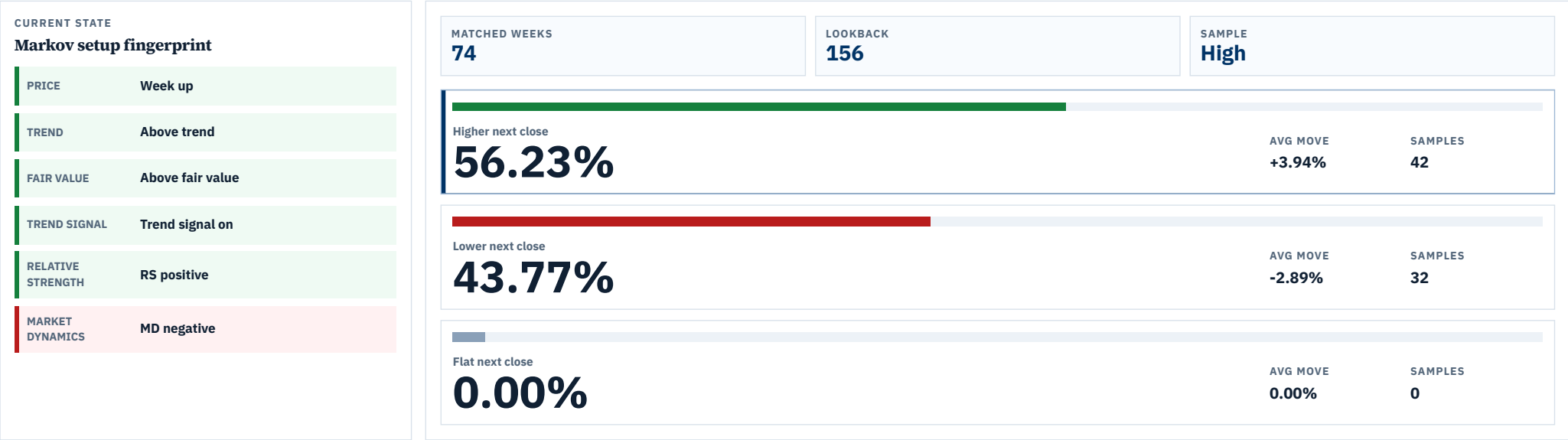
