Weekly setup

Constructive, but selective

The weekly trend is active. Price is 32.1% above the Trend Line and sits at 89.9% of its 52-week range. The latest completed week returned 1.1%, after a 2.1% four-week move. The latest factor snapshot indicates quality ranks weakly versus its universe; growth ranks weakly; valuation is expensive relative to peers. Options positioning is volatility with 46/100 conviction, while the latest news-sentiment score is 56/100. Near-term considerations: volume confirmation is below normal; earnings are due in 70d.

Technical setup score 63/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

What to watch next

- Trend Line remains the key weekly regime level.

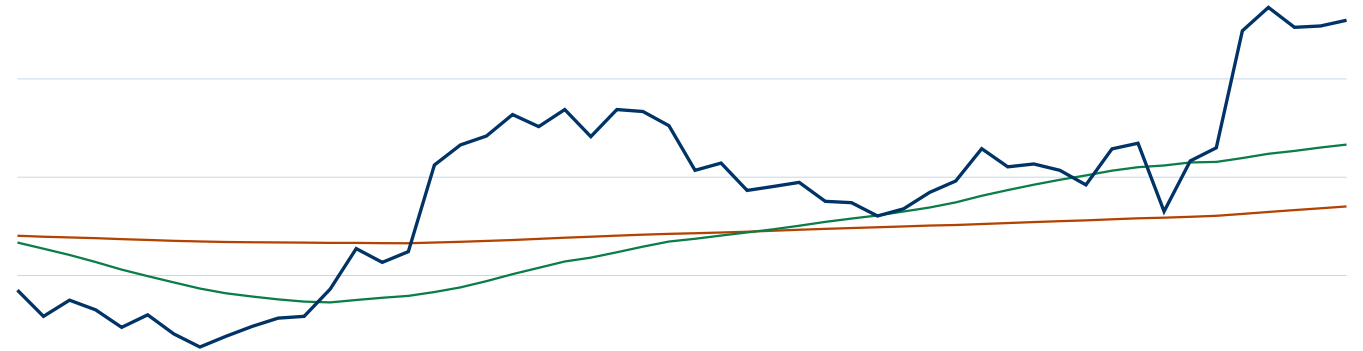

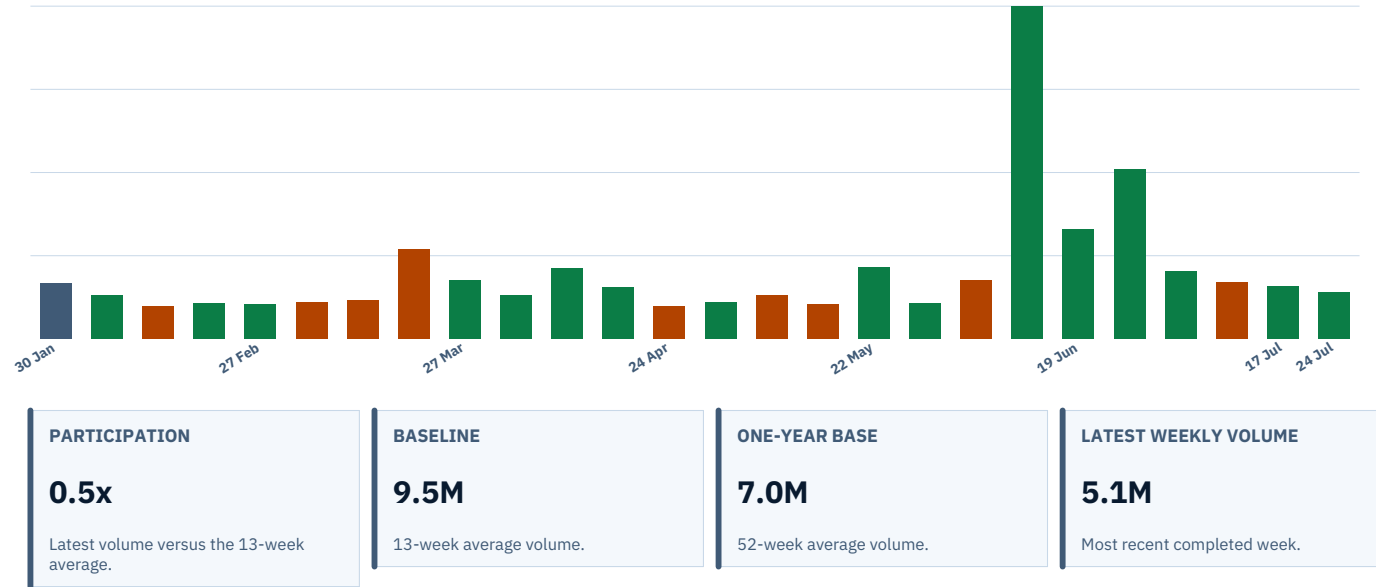
02 · VOLUME AND DEMAND

Activity pressure and institutional-style signals

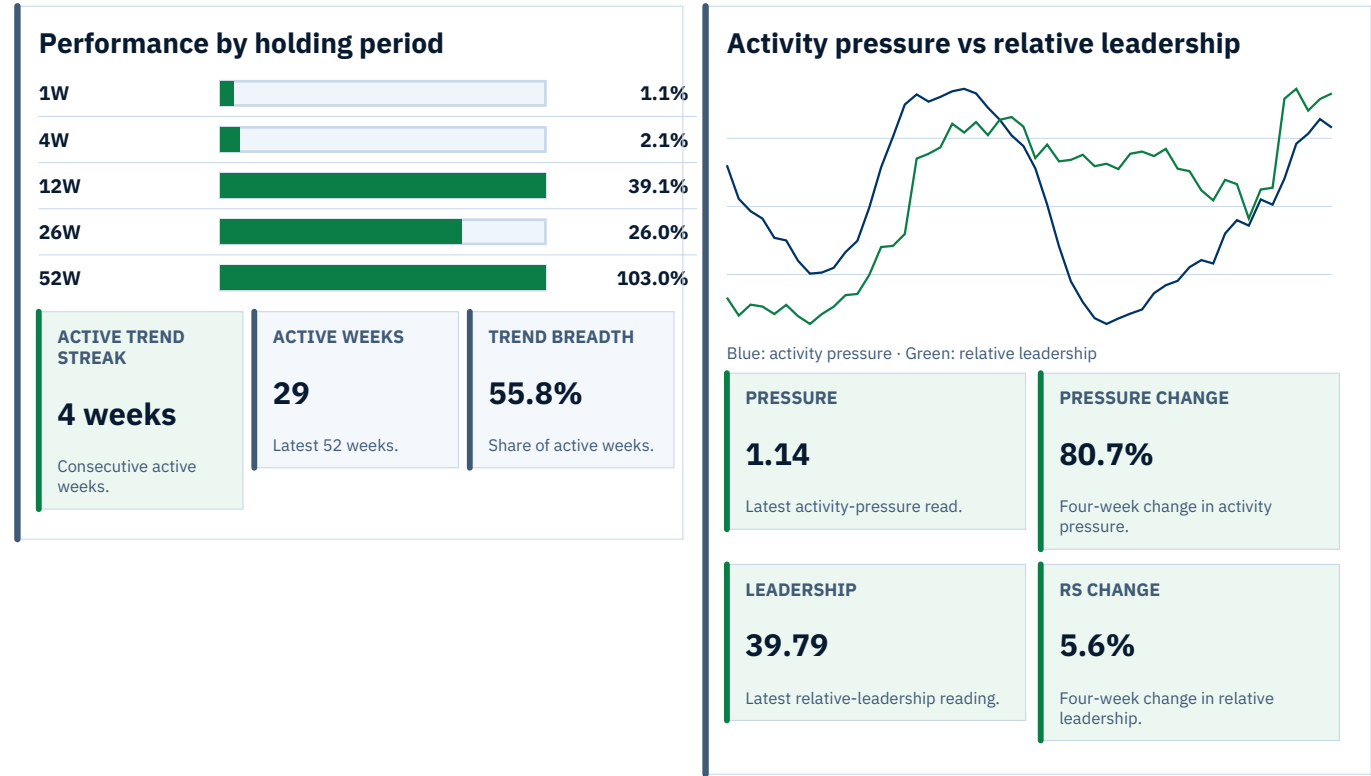
These indicators assess whether participation is improving beneath price. They are supporting evidence, not proof of institutional buying.

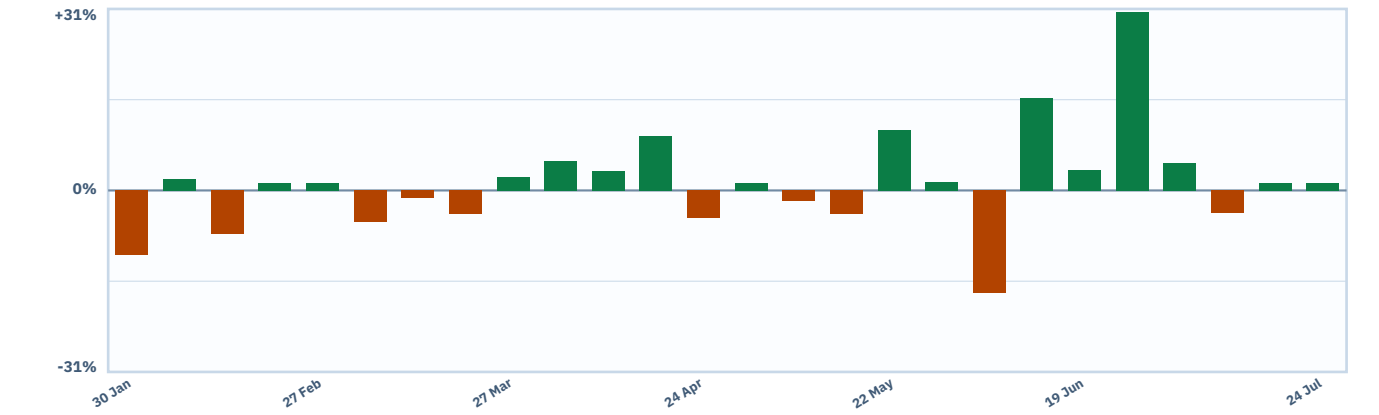
