Weekly setup

Constructive, but selective

The weekly trend is active. Price is 17.3% above the Trend Line and sits at 87.1% of its 52-week range. The latest completed week returned -1.5%, after a 2.6% four-week move. The latest factor snapshot indicates quality ranks strongly versus its universe; growth ranks weakly; valuation is neither clearly cheap nor expensive. Options positioning is bullish with 48/100 conviction, while the latest news-sentiment score is 56/100. Near-term considerations: earnings are due in 84d.

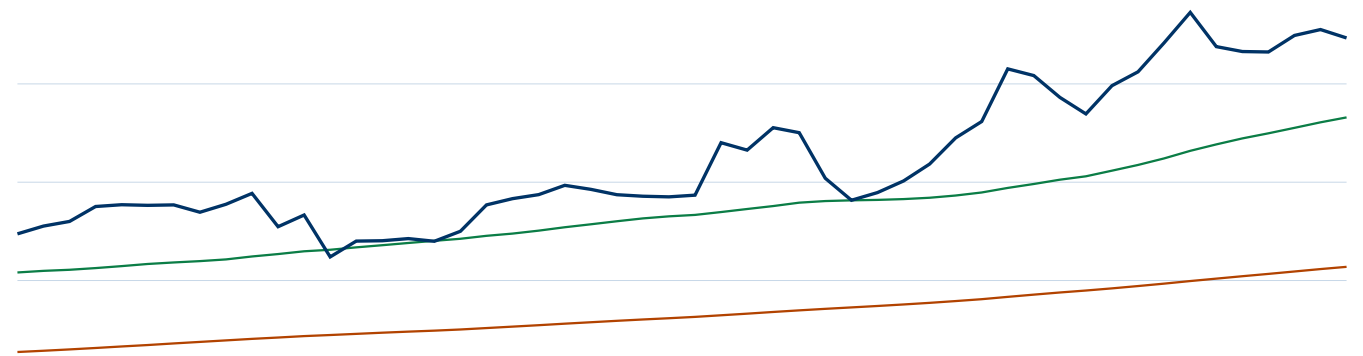

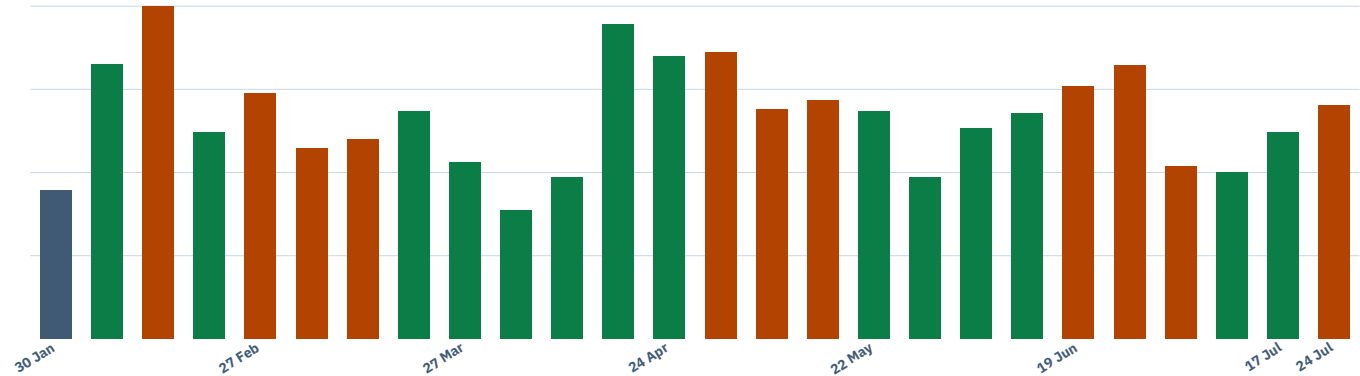
02 · VOLUME AND DEMAND

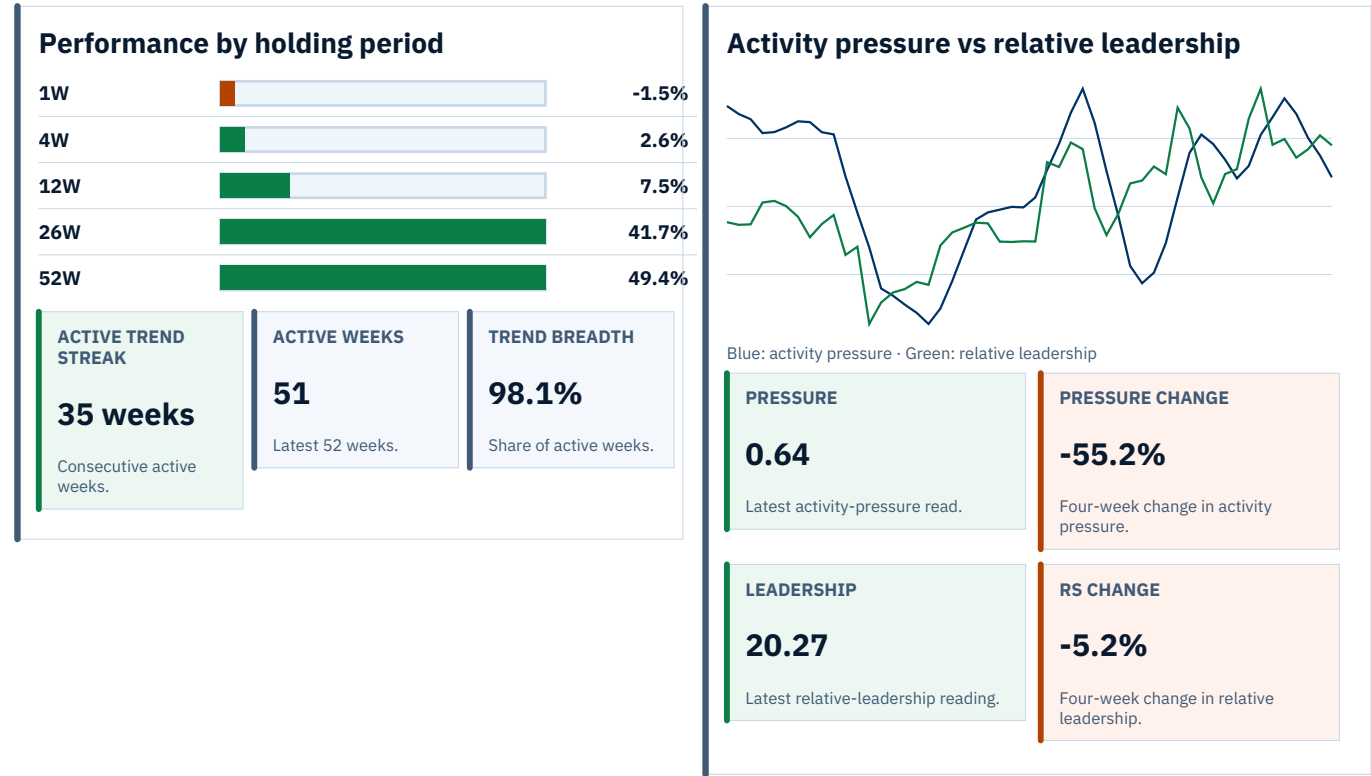

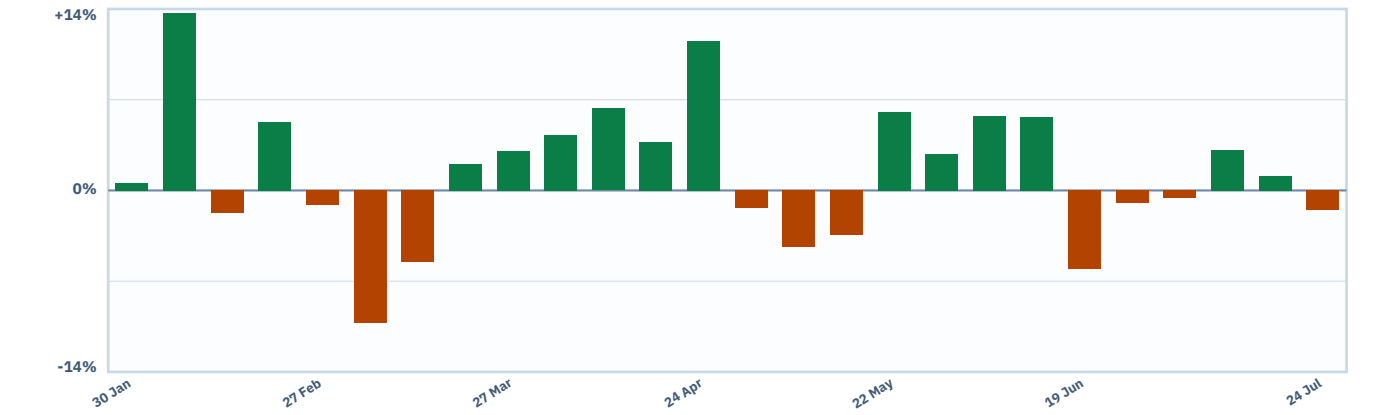
