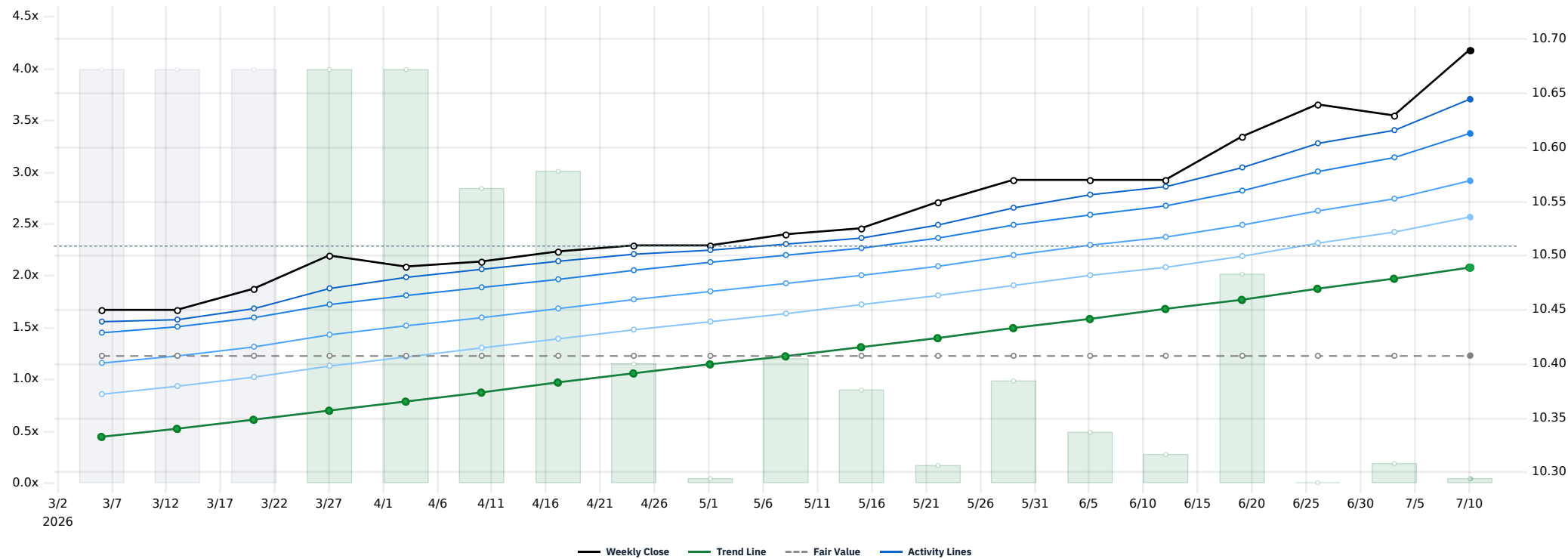

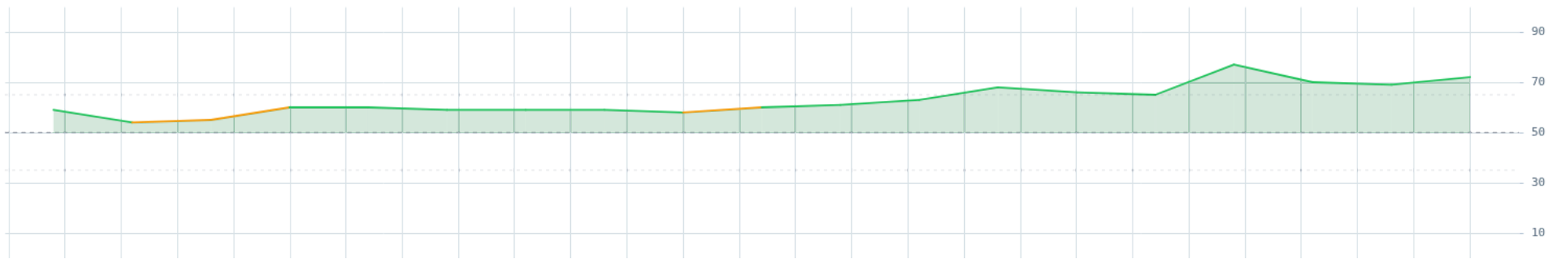

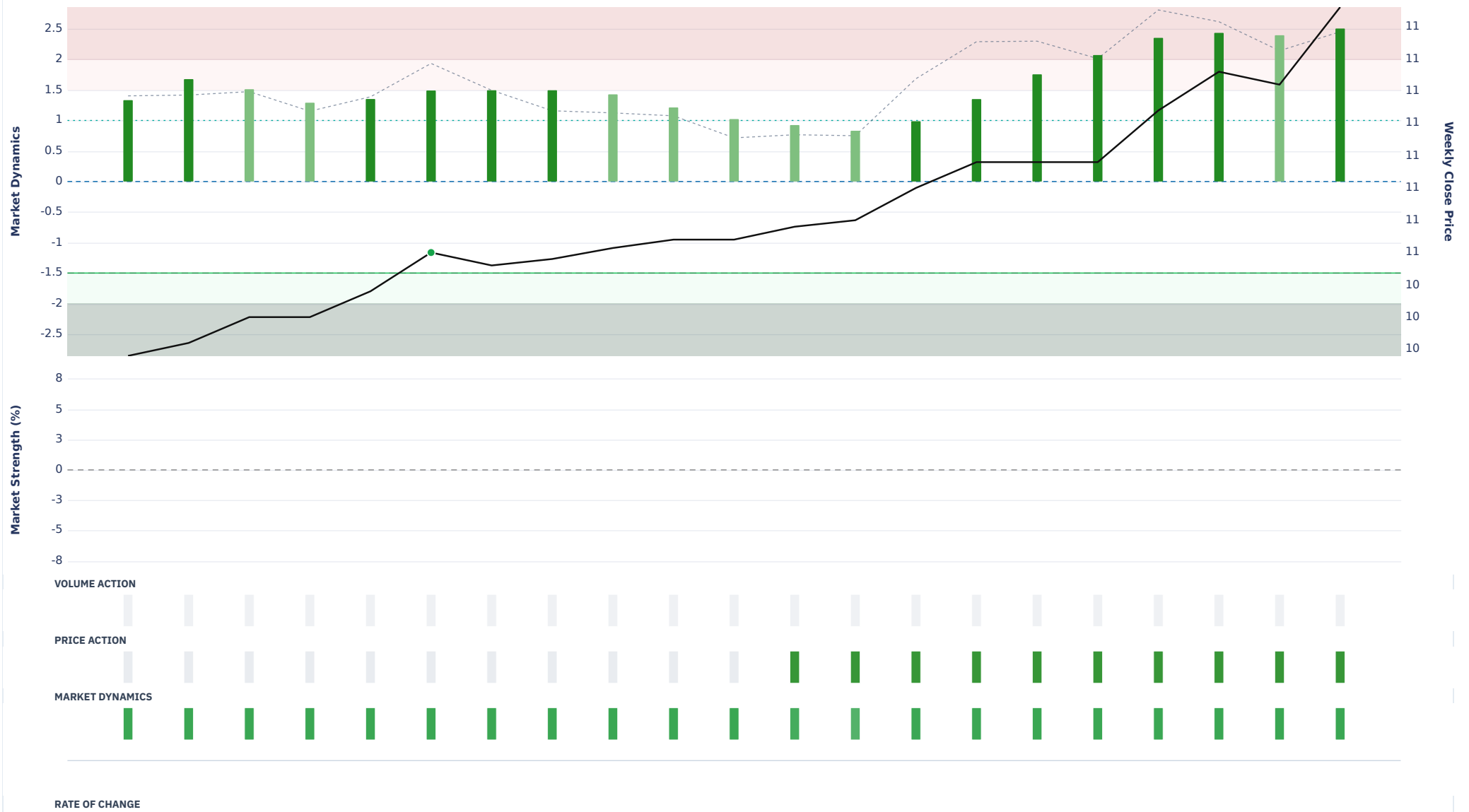

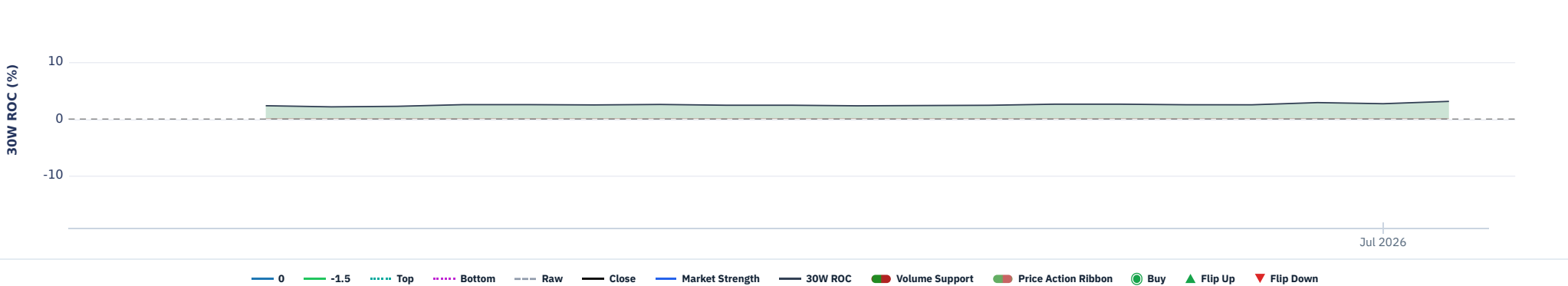

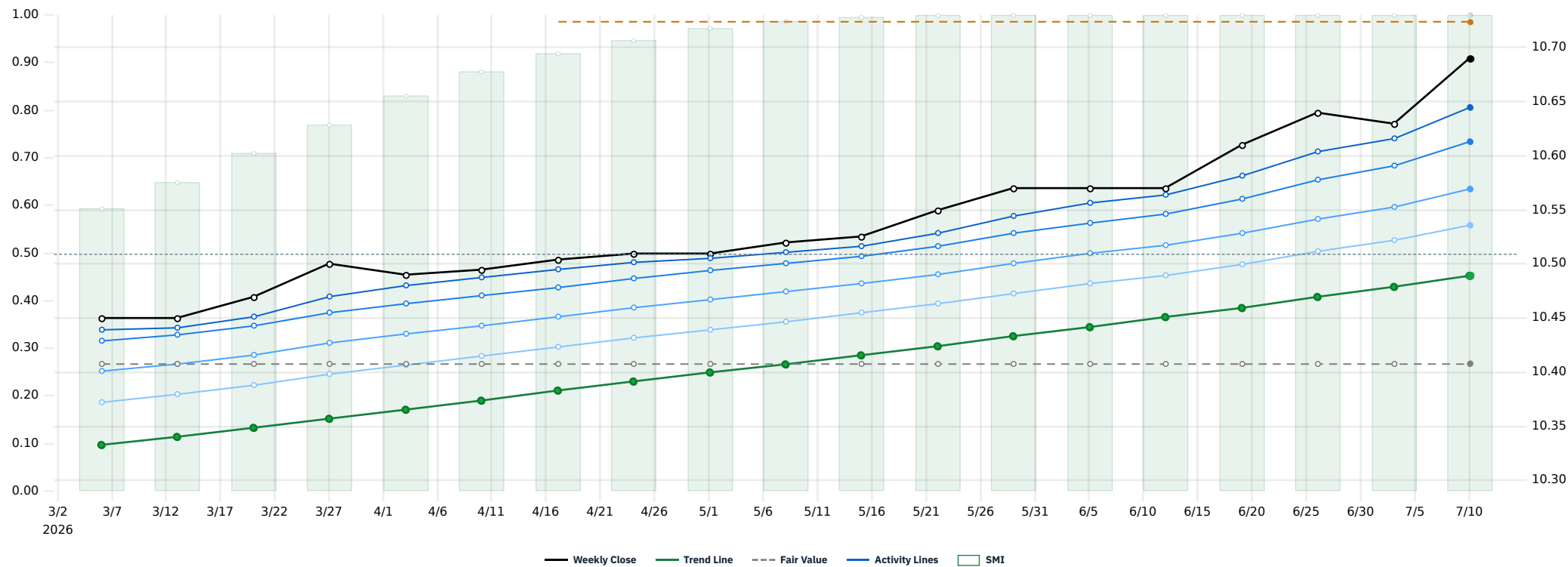

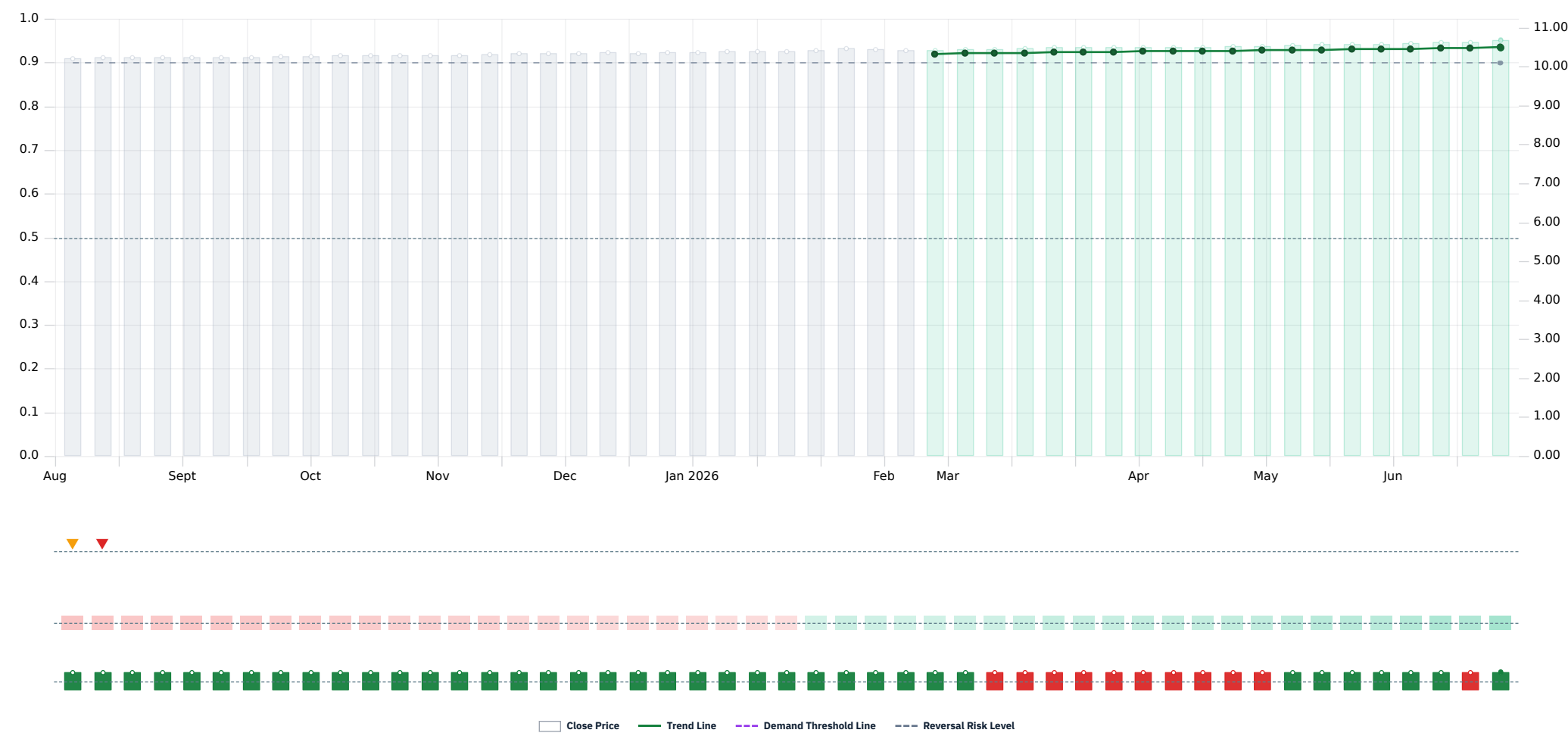

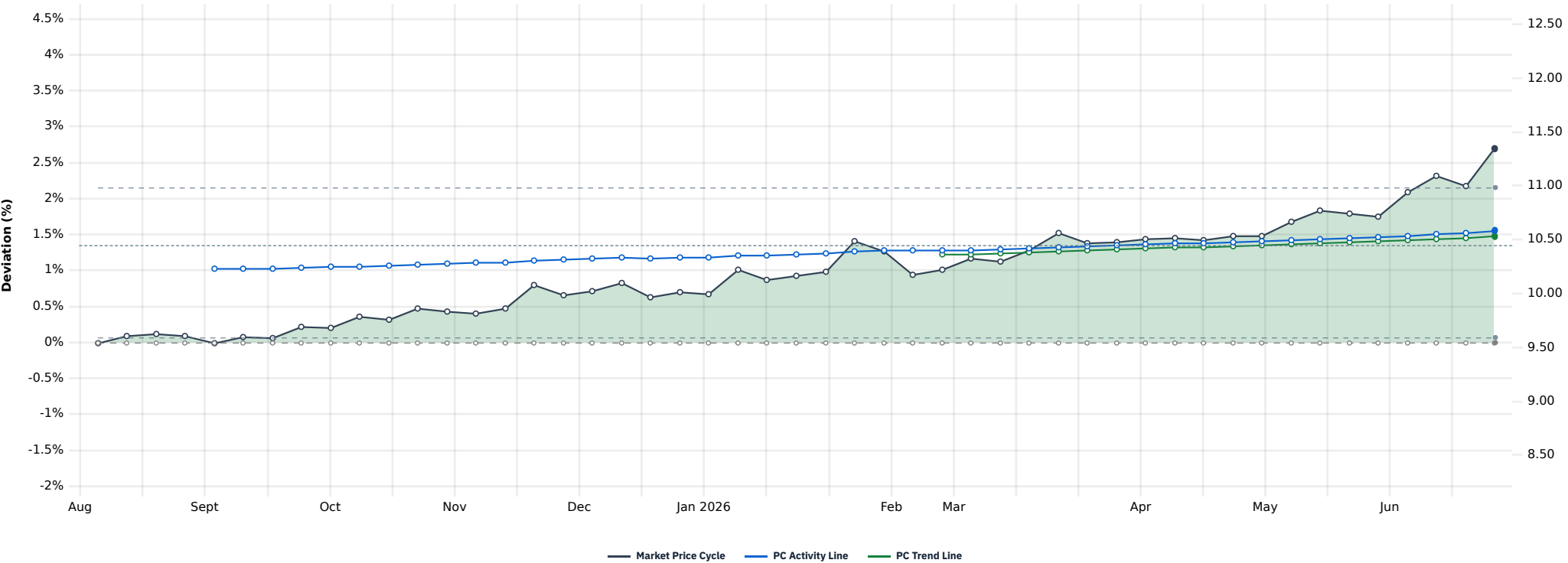

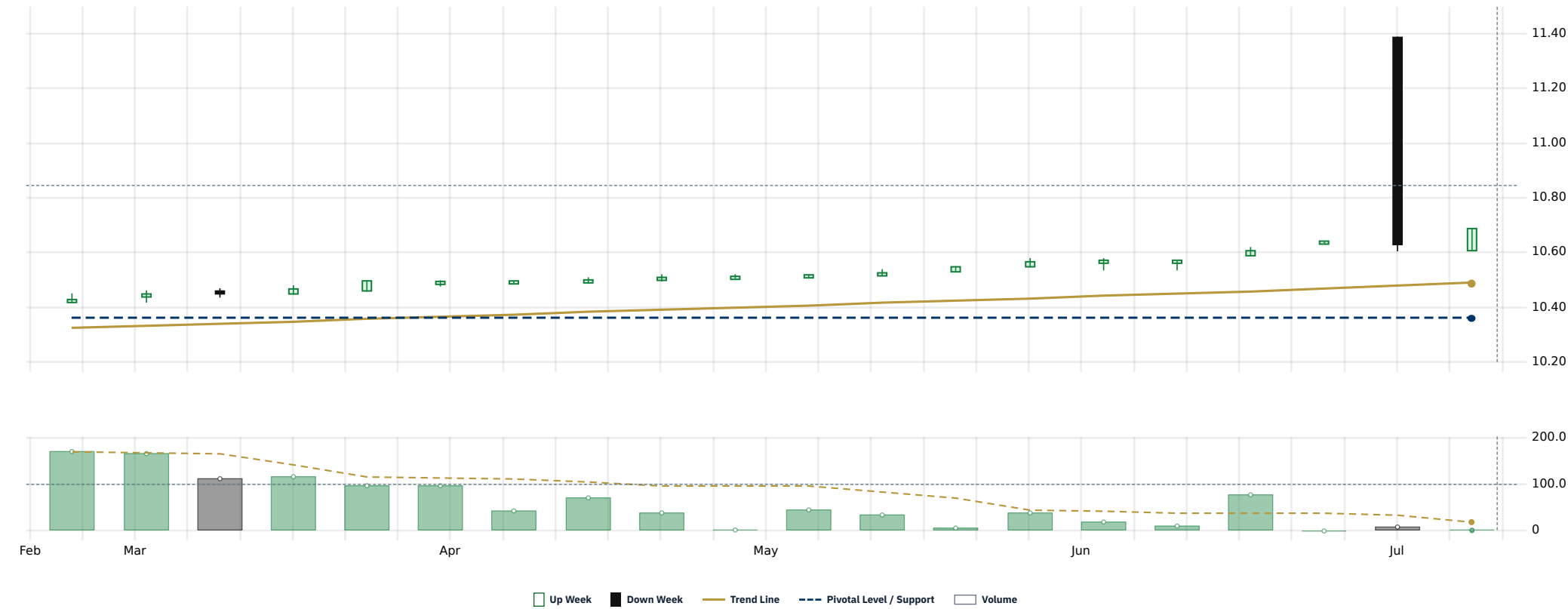
Price Cycle

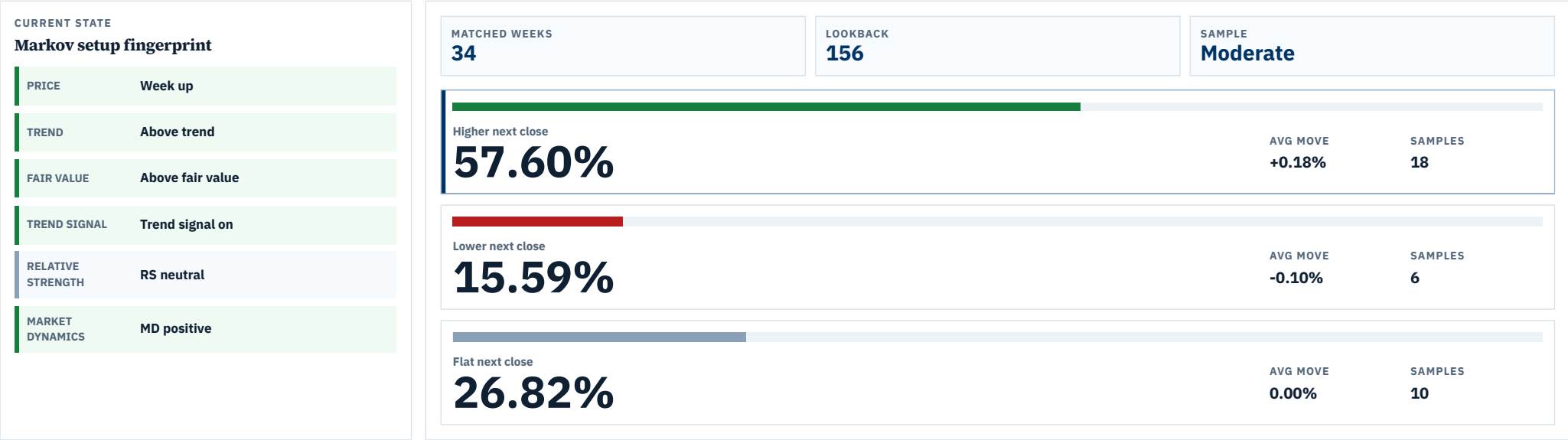
