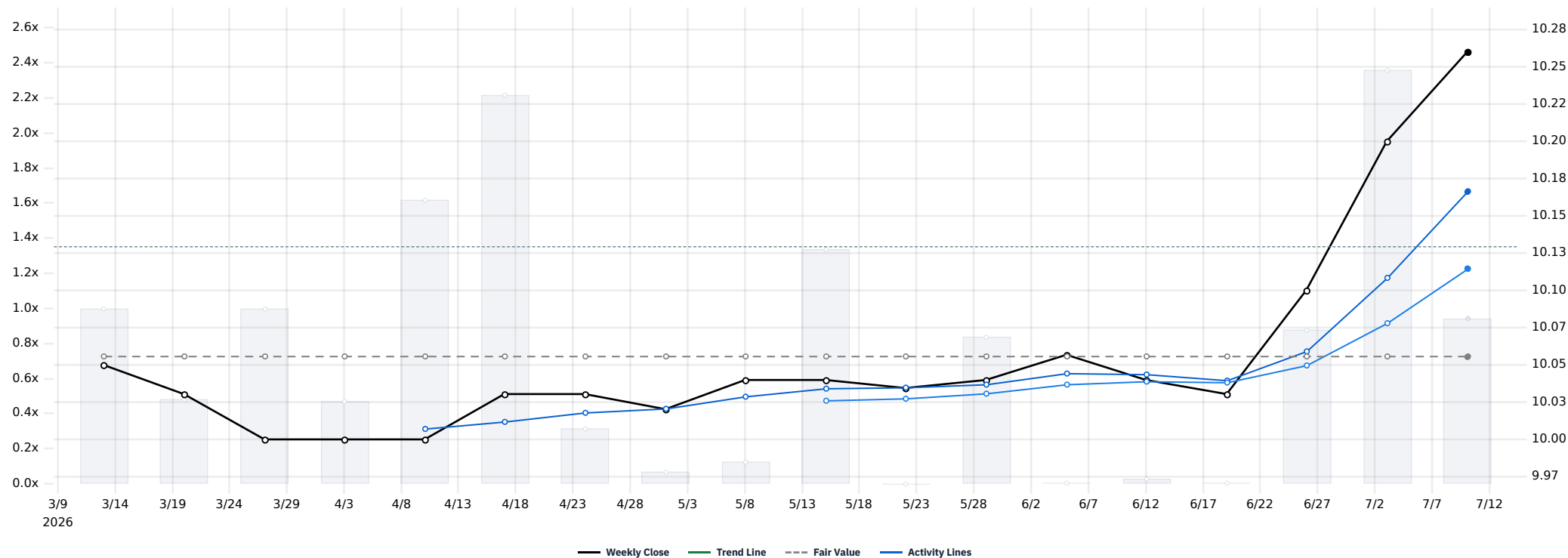

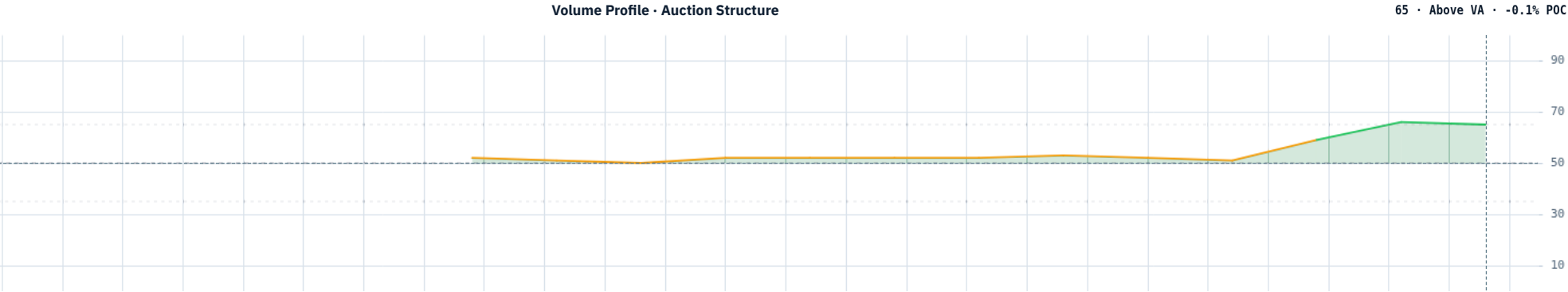

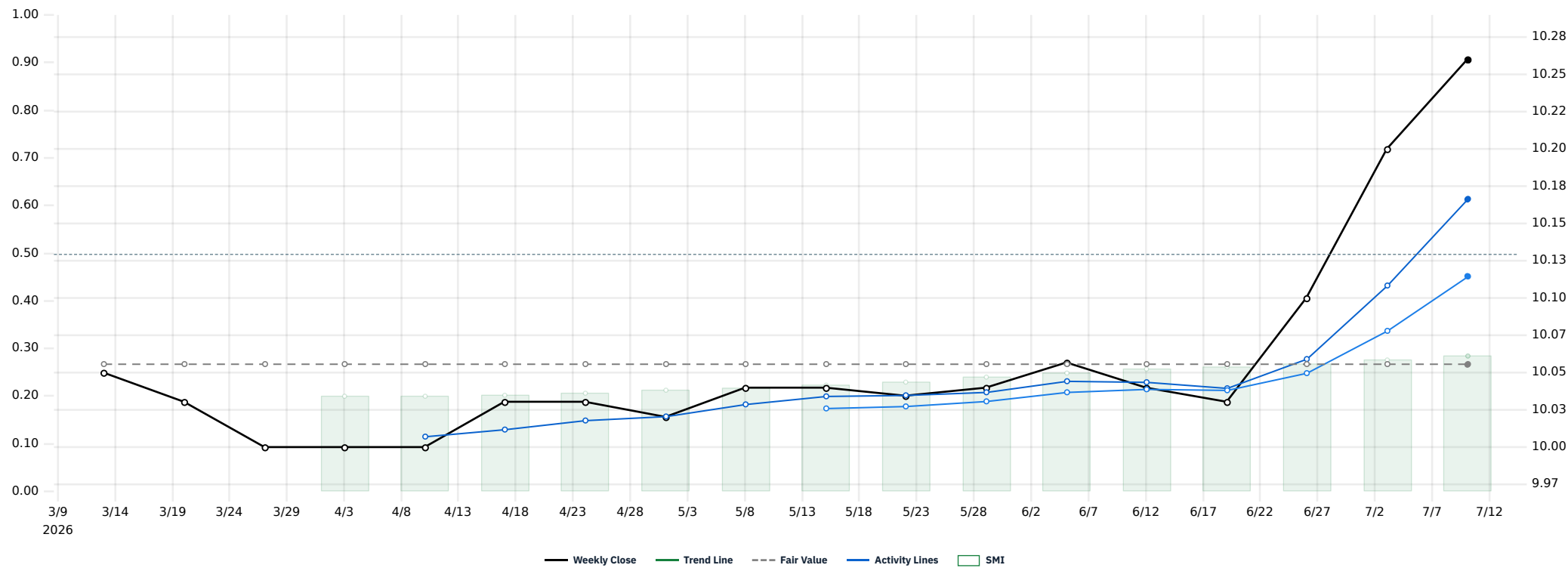

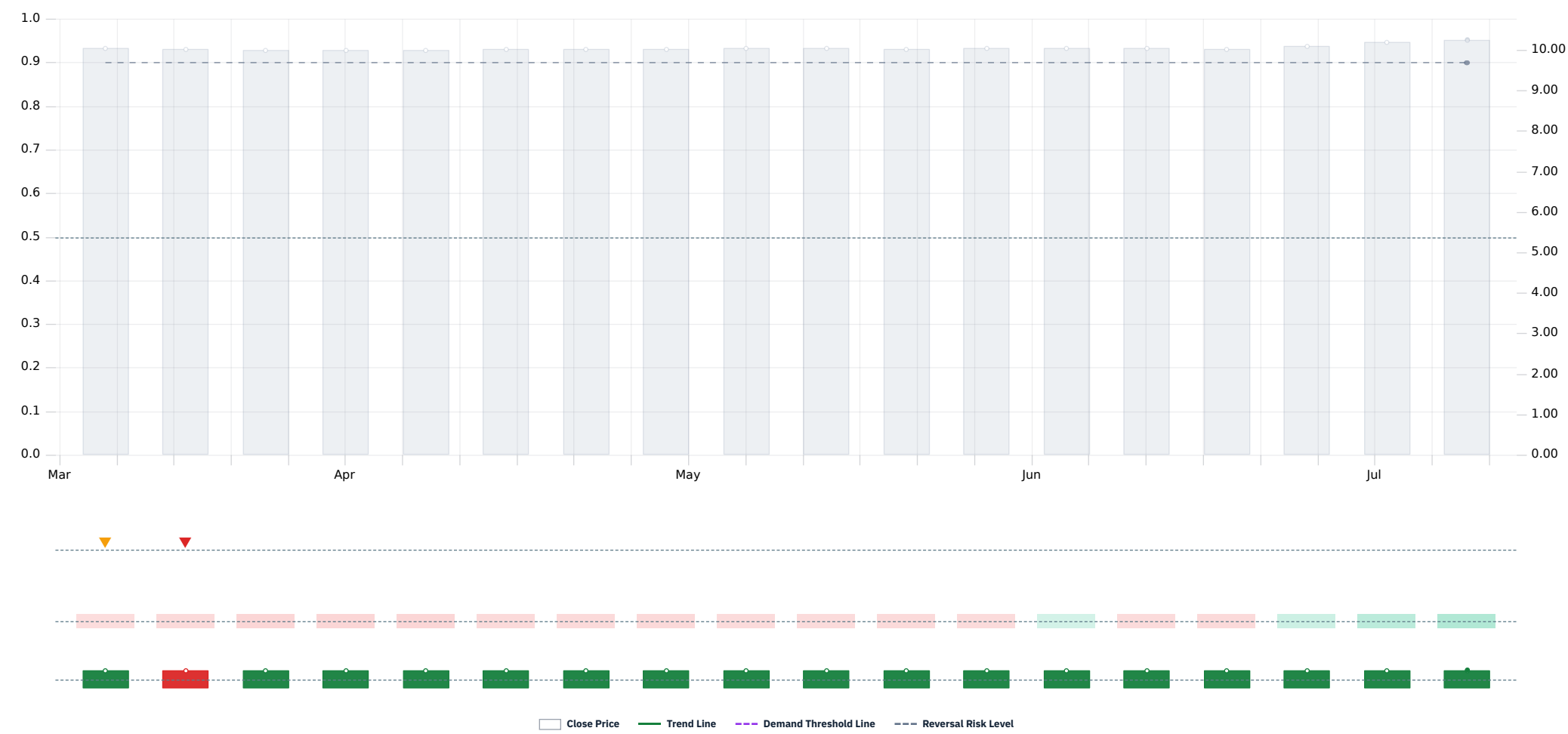

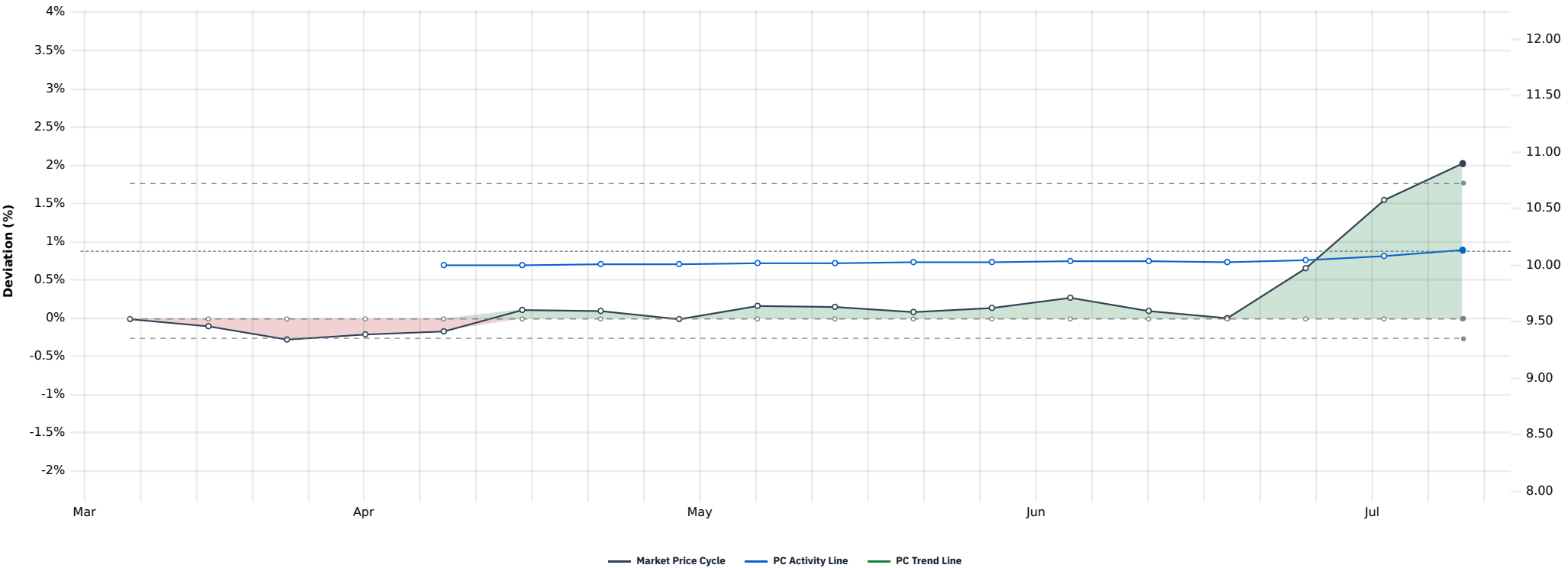

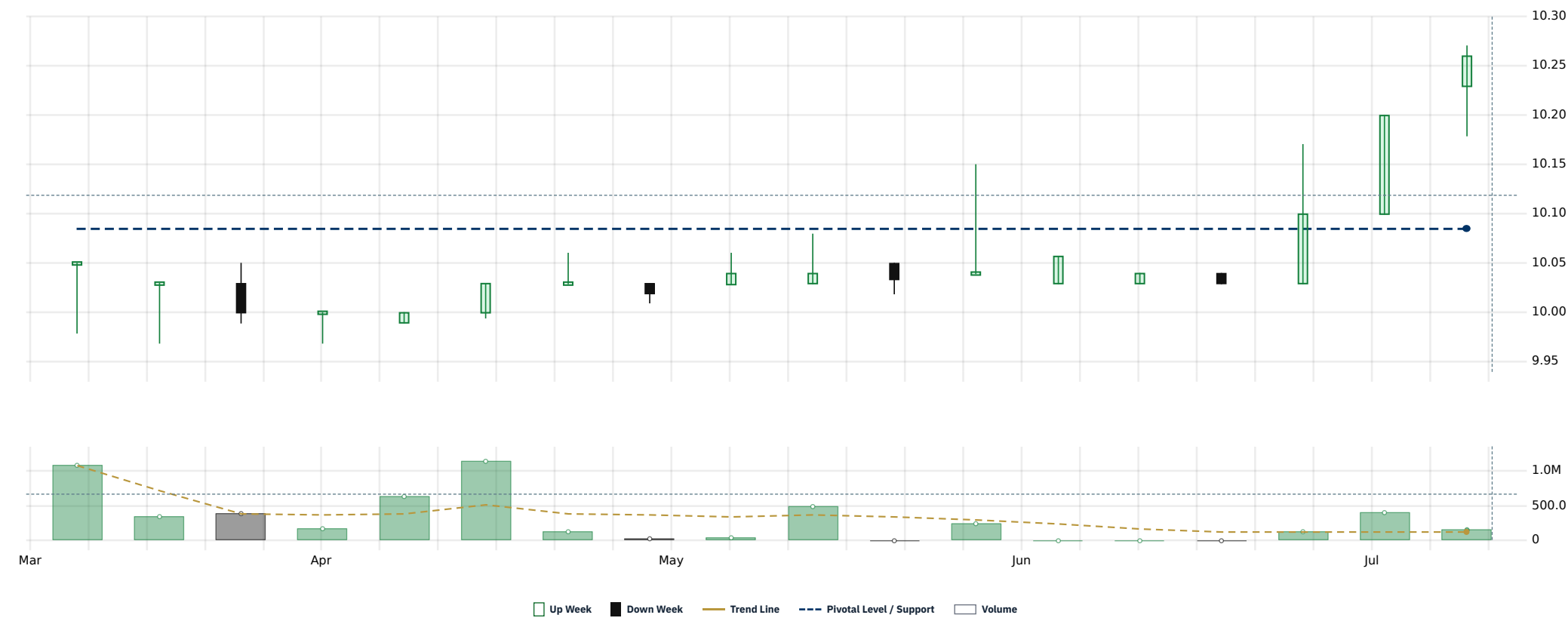
Price Cycle

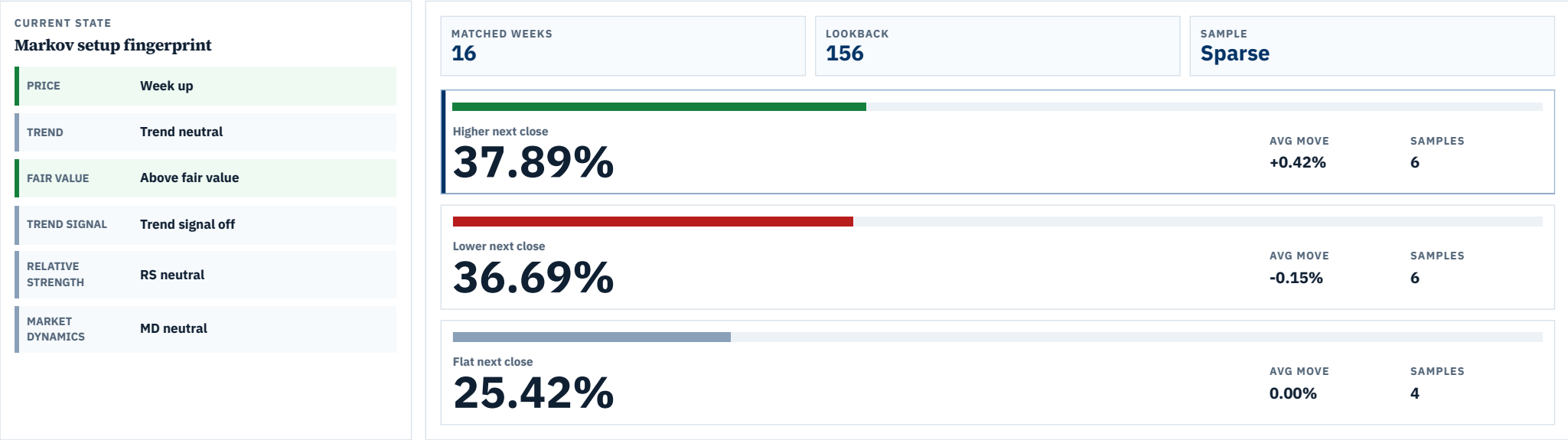
