Weekly setup

The latest factor snapshot indicates quality is middle-of-the-pack; growth ranks strongly; valuation is expensive relative to peers. Options positioning is bullish with 42/100 conviction, while the latest news-sentiment score is 60/100. Near-term considerations: price is close to its 52-week high; earnings are due in 0d.

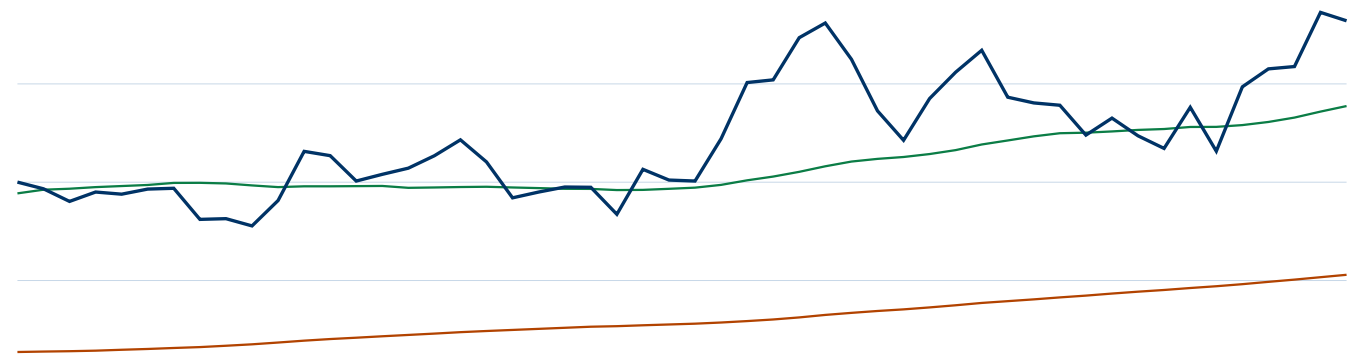

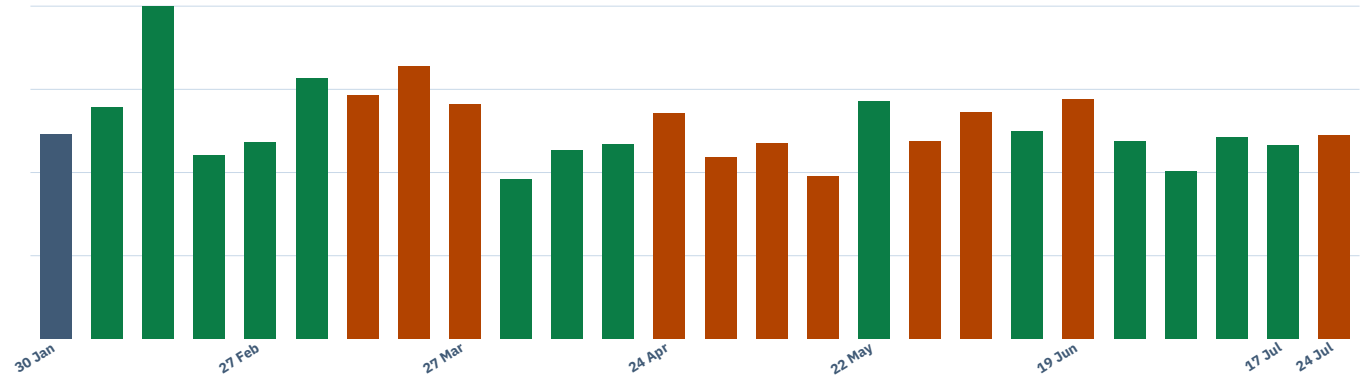

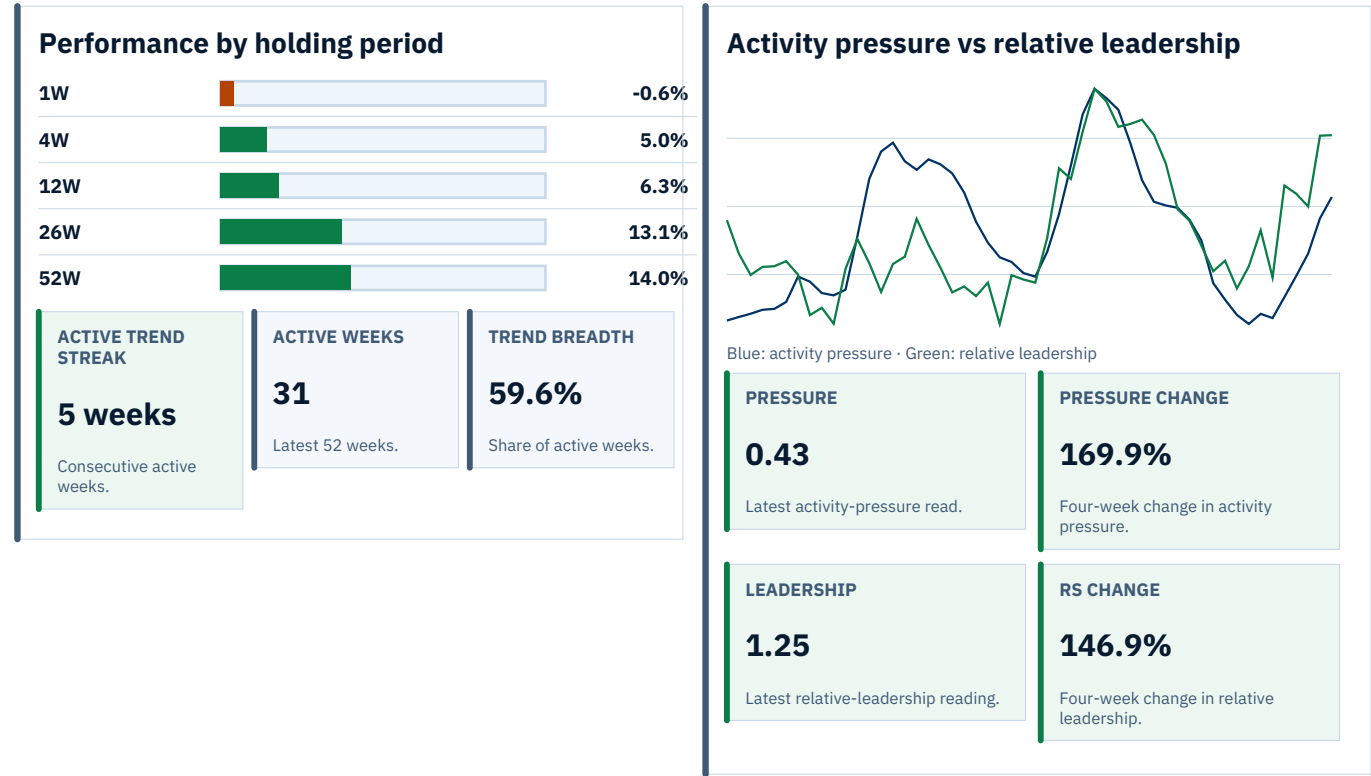

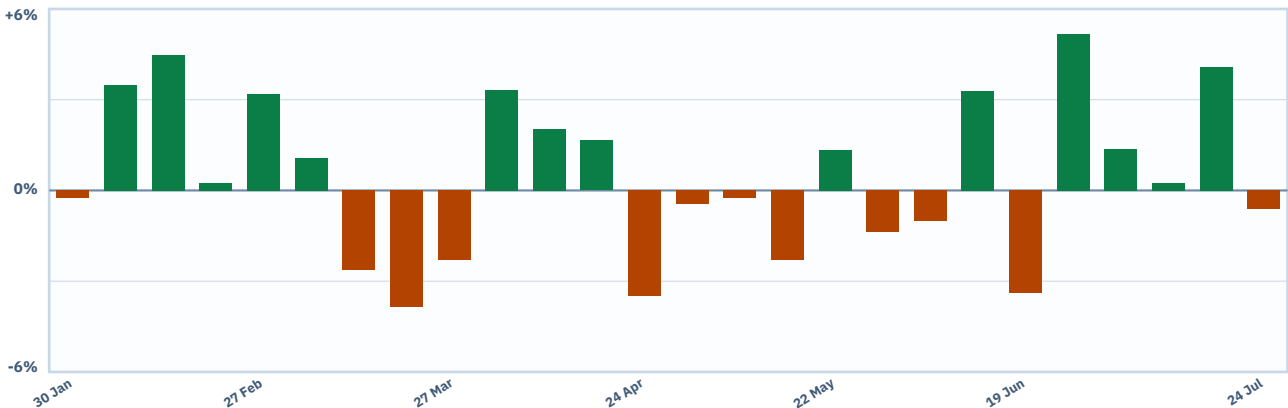
