Options positioning is volatility with 55/100 conviction, while the latest news-sentiment score is 55/100. Near-term considerations: earnings are due in 83d.

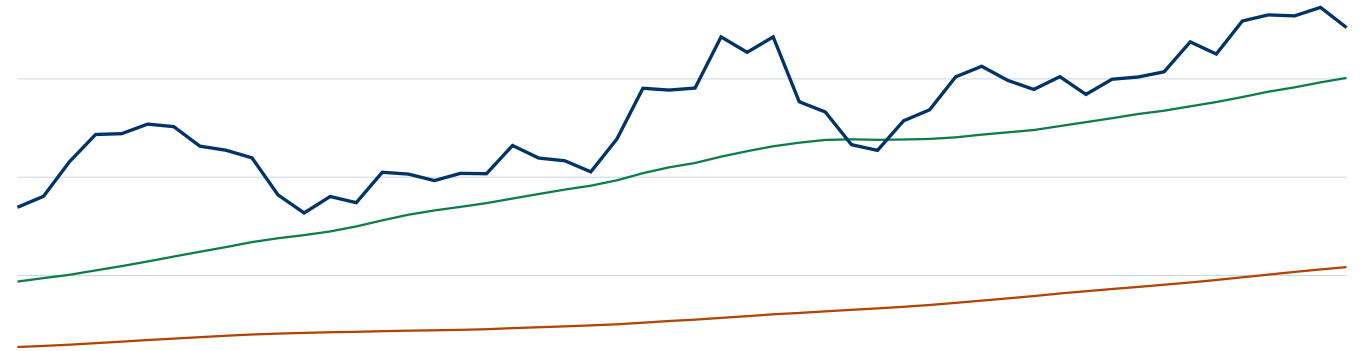

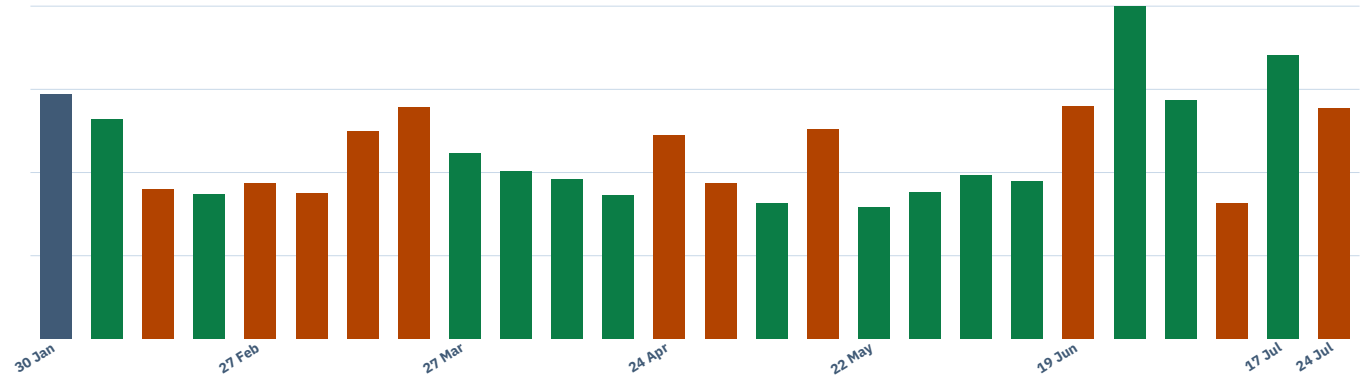

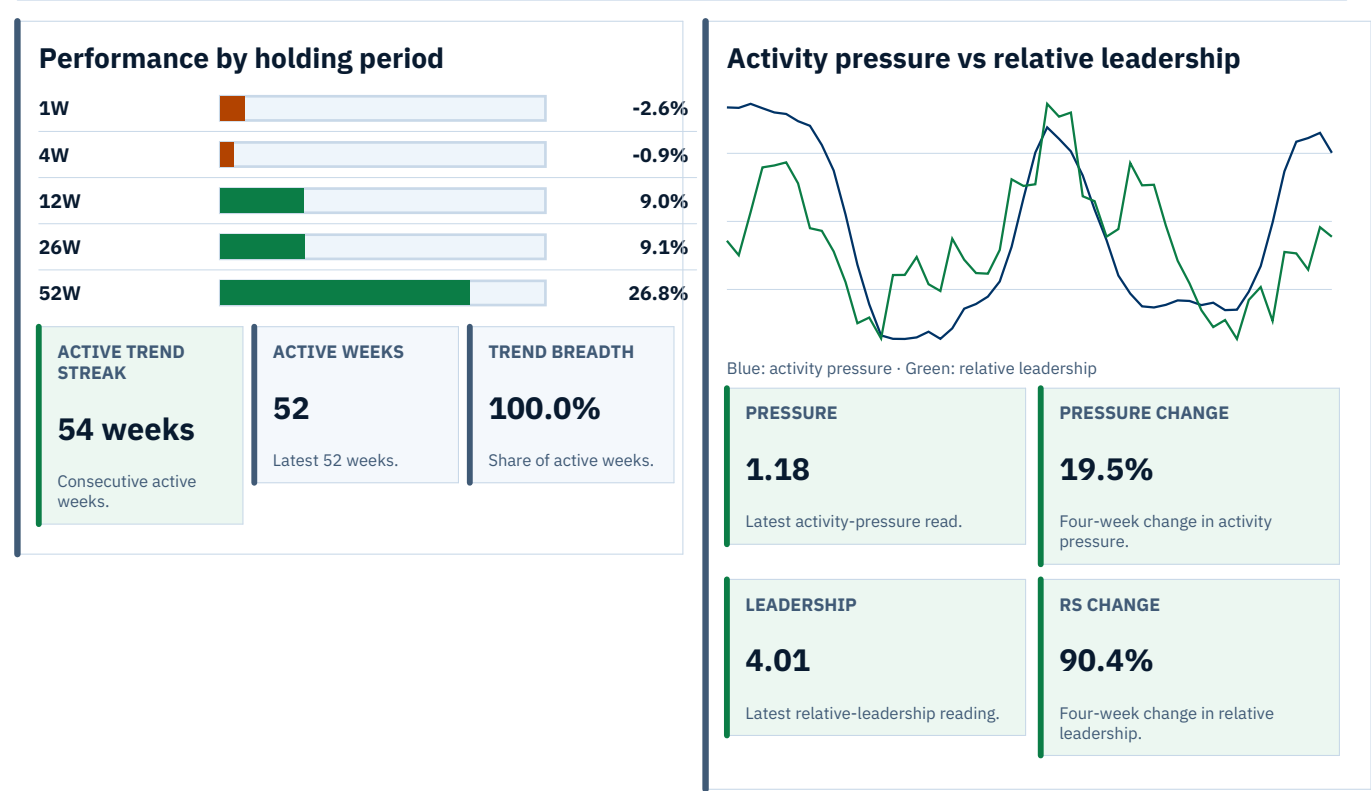

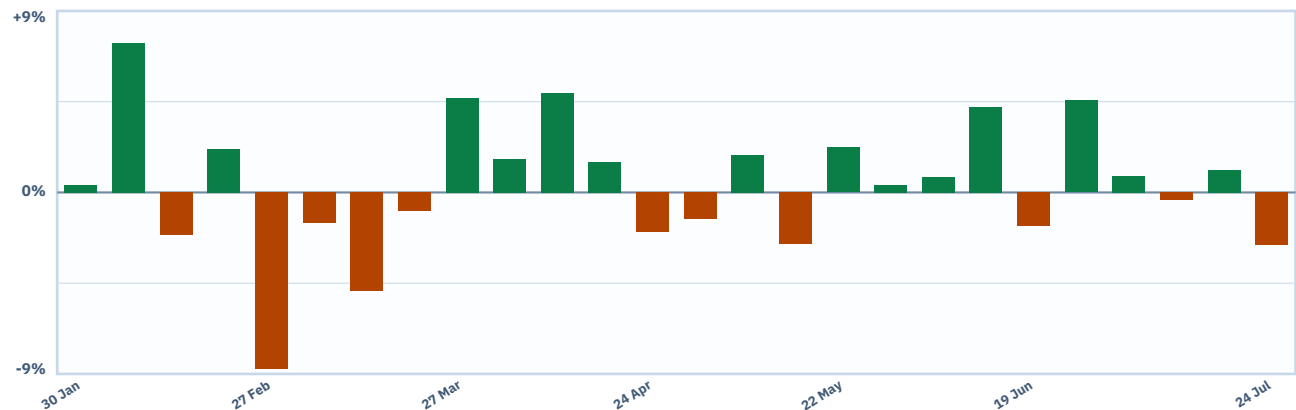
