Weekly setup

Constructive, but selective

The weekly trend is active. Price is 32.8% above the Trend Line and sits at 93.2% of its 52-week range. The latest completed week returned -2.1%, after a 1.4% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth is moderate; valuation is neither clearly cheap nor expensive. Options positioning is volatility with 56/100 conviction, while the latest news-sentiment score is 51/100. Near-term considerations: price is close to its 52-week high; volume confirmation is below normal; earnings are due in 11d.

Technical setup score 67/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

What to watch next

- Activity pressure is the gauge to monitor for confirmation or fade.
- A volume ratio above 1.5x would show stronger participation in the next move.

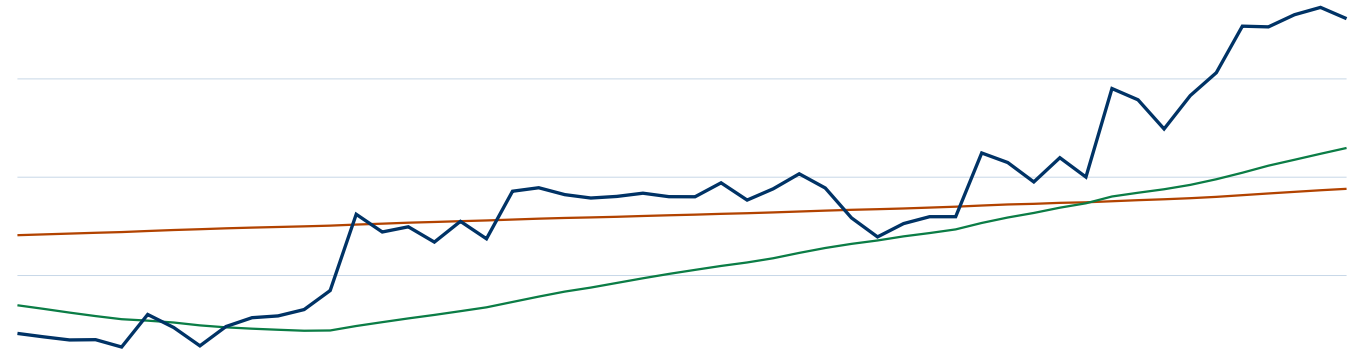

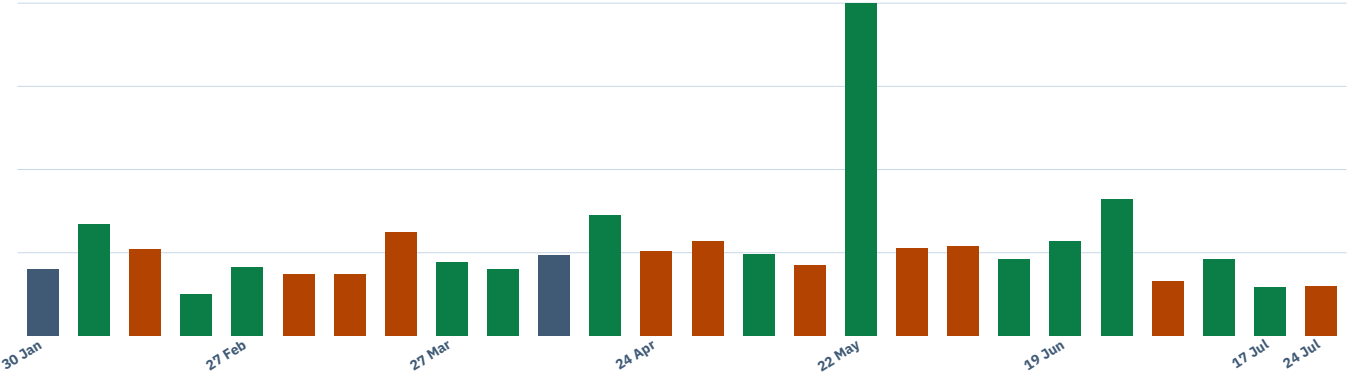
02 · VOLUME AND DEMAND

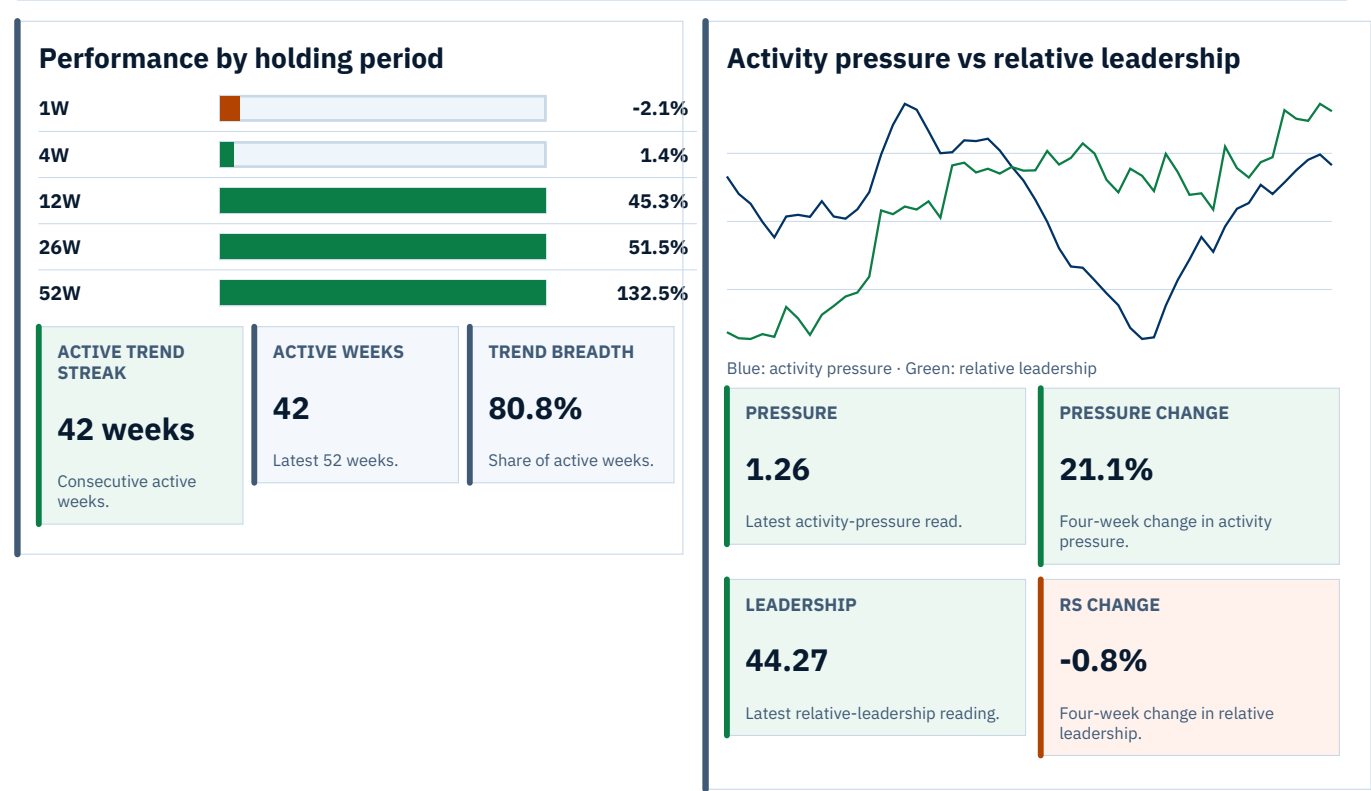

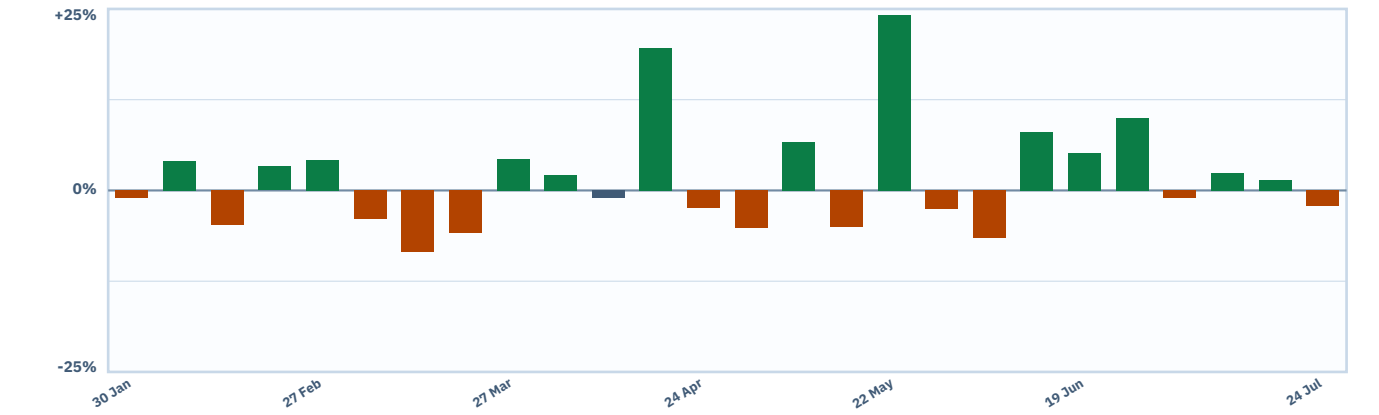
