Weekly setup

Constructive, but selective

The weekly trend is active. Price is 9.4% above the Trend Line and sits at 88.3% of its 52-week range. The latest completed week returned -1.2%, after a 1.7% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth ranks weakly; valuation is inexpensive relative to peers. Options positioning is bullish with 55/100 conviction, while the latest news-sentiment score is 52/100. Near-term considerations: volume confirmation is below normal; earnings are due in 1d.

Technical setup score 65/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

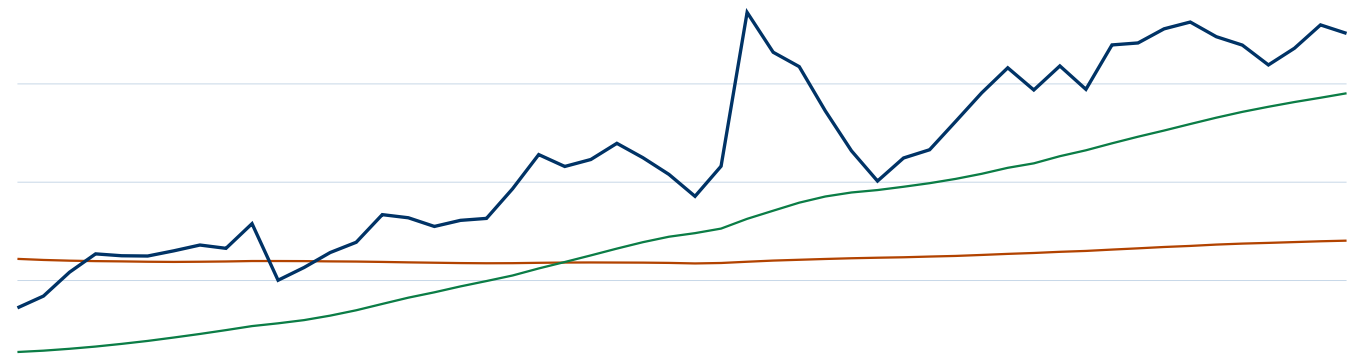

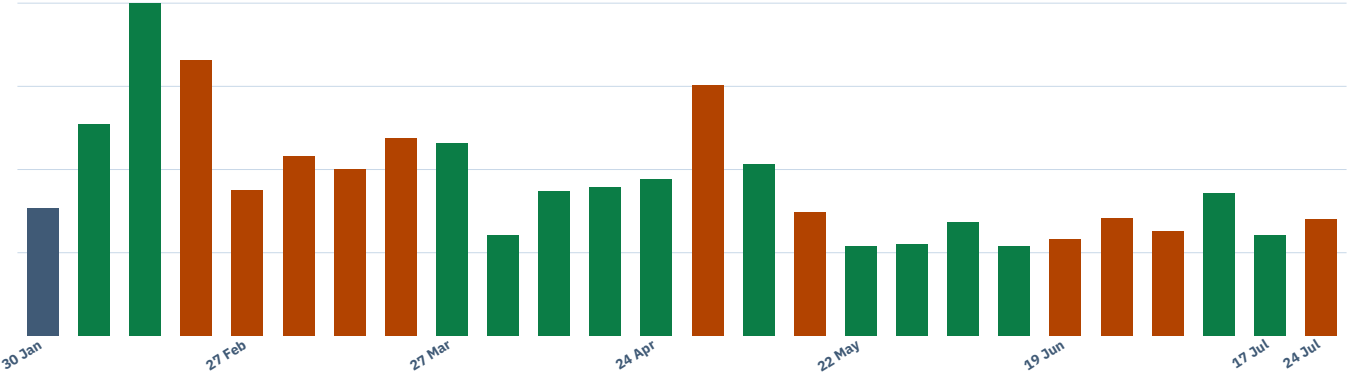
02 · VOLUME AND DEMAND

Latest weekly volume is 0.9x the 13-week average. Participation is below its recent norm, so price strength is not receiving full volume confirmation.

Activity pressure and institutional-style signals

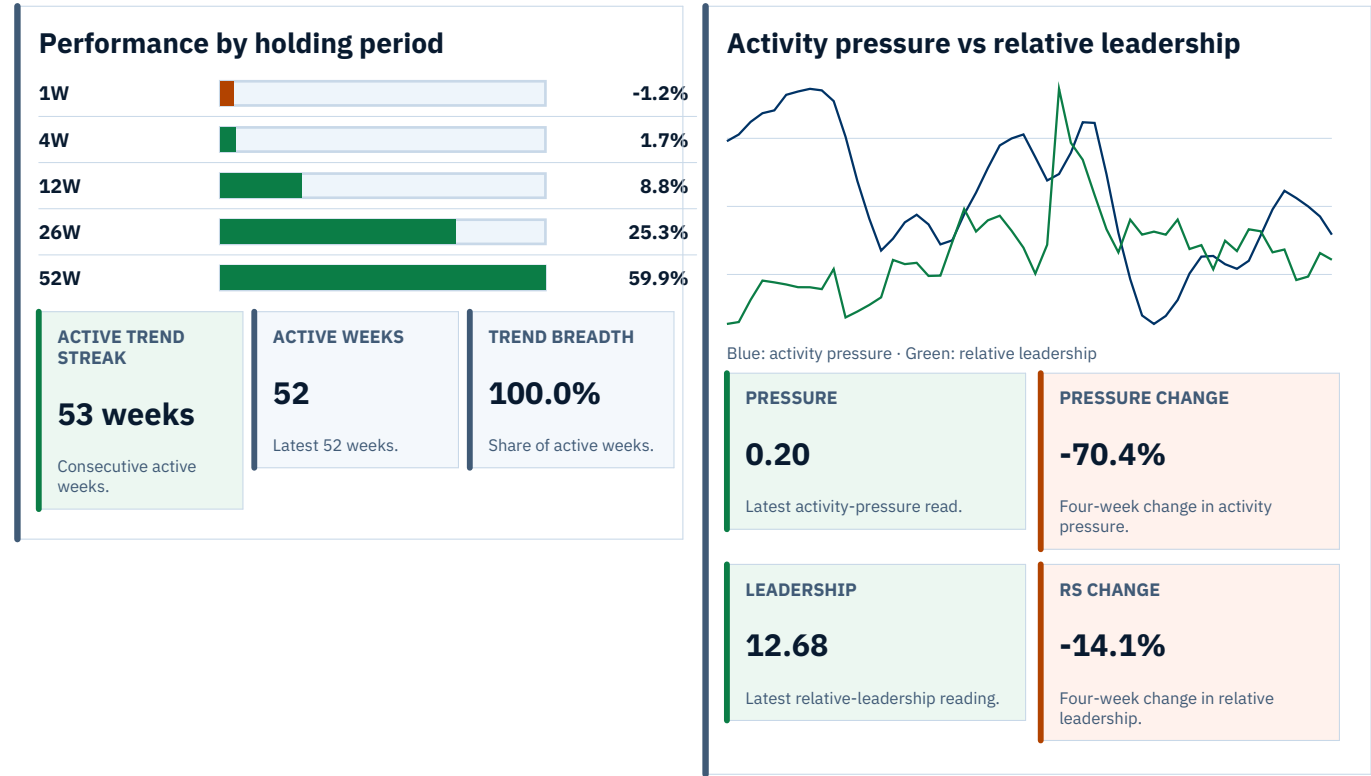

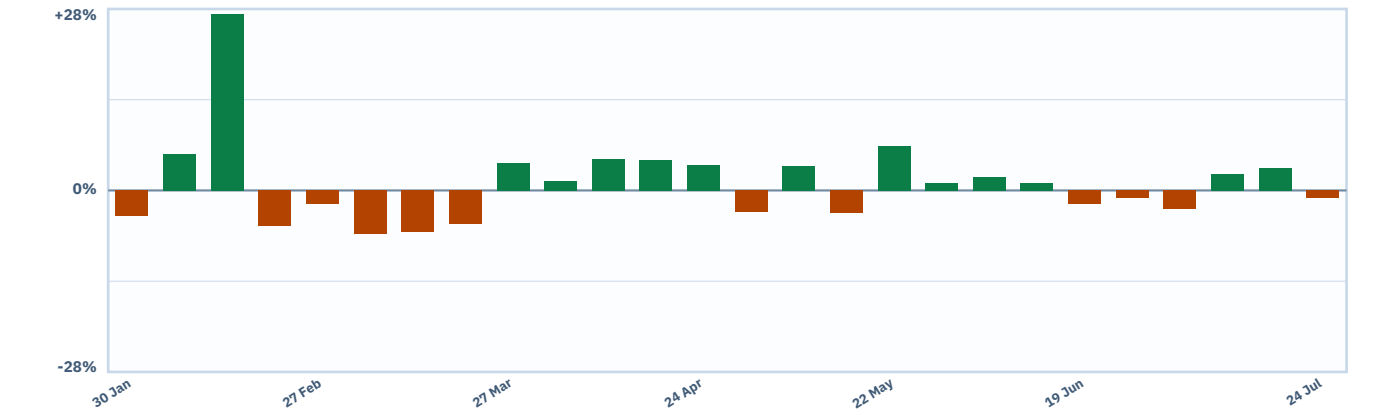
