Weekly setup

Constructive, but selective

The weekly trend is active. Price is 18.2% above the Trend Line and sits at 95.5% of its 52-week range. The latest completed week returned 7.0%, after a 10.3% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth is moderate; valuation is neither clearly cheap nor expensive. Options positioning is volatility with 45/100 conviction, while the latest news-sentiment score is 52/100. Near-term considerations: price is close to its 52-week high; volume confirmation is below normal; earnings are due in 8d.

Technical setup score 68/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

- A volume ratio above 1.5x would show stronger participation in the next move.

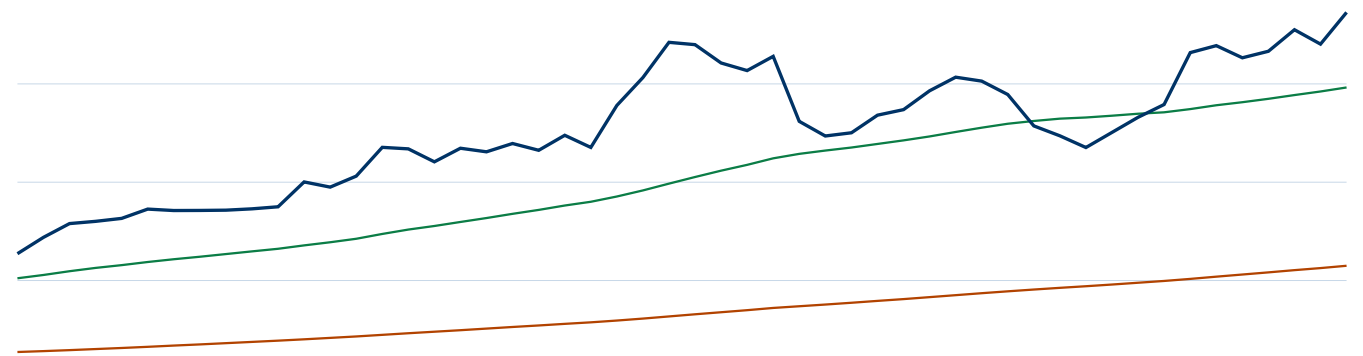

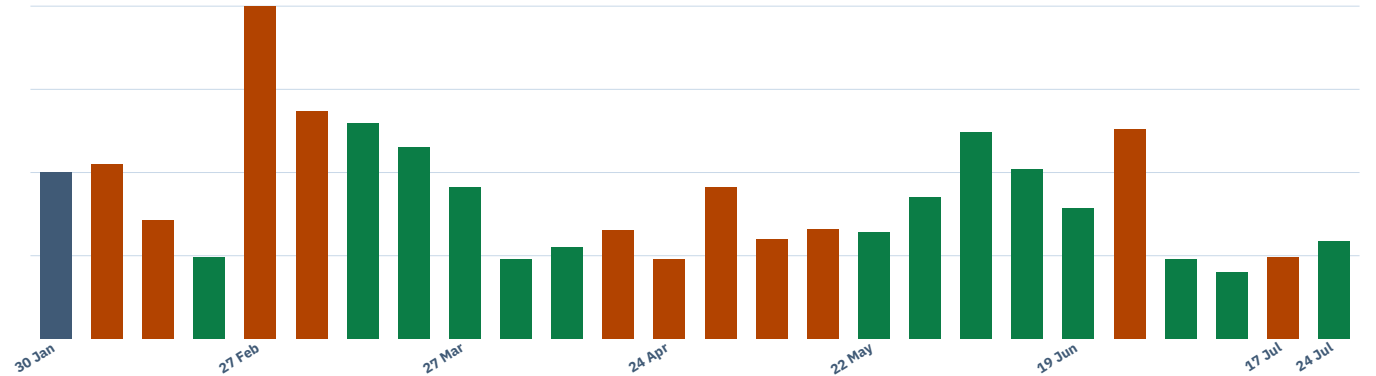
02 · VOLUME AND DEMAND

Activity pressure and institutional-style signals

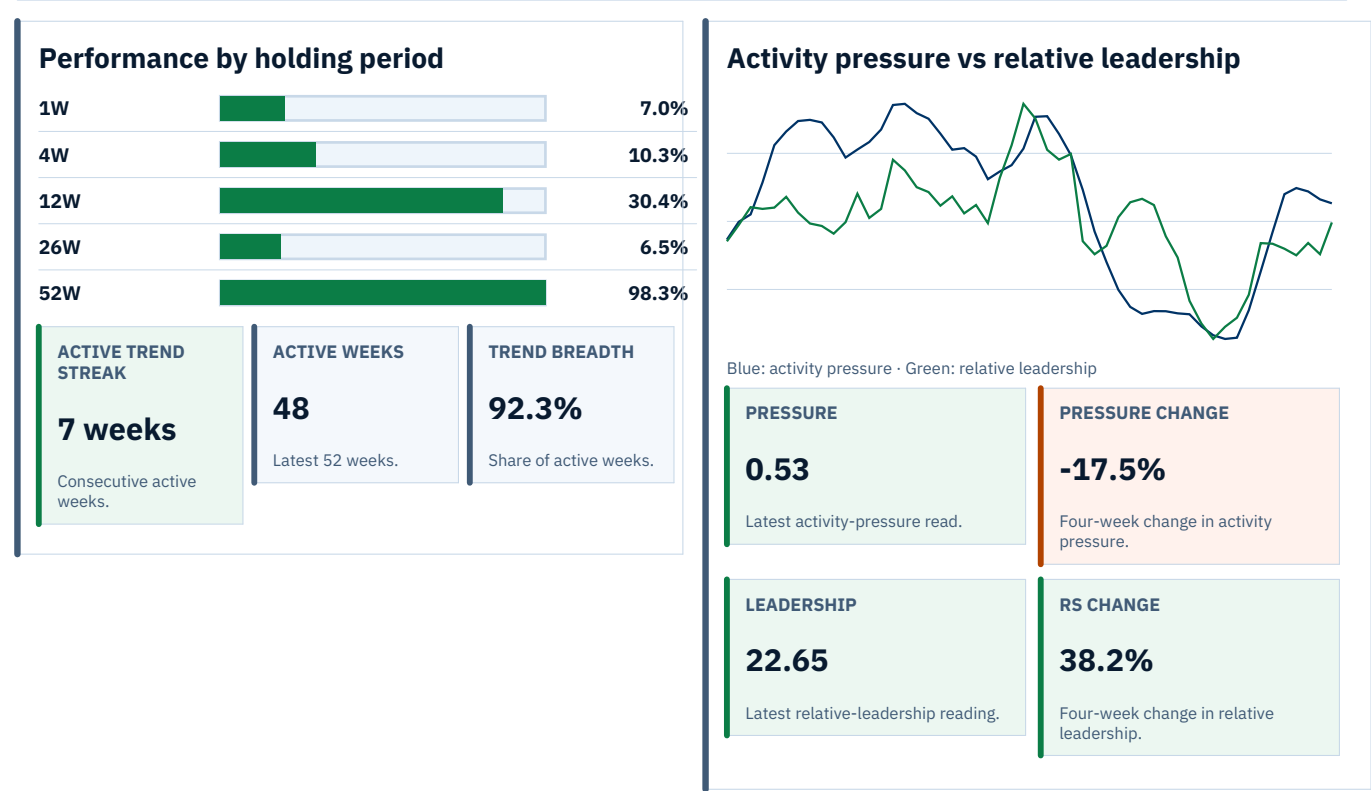

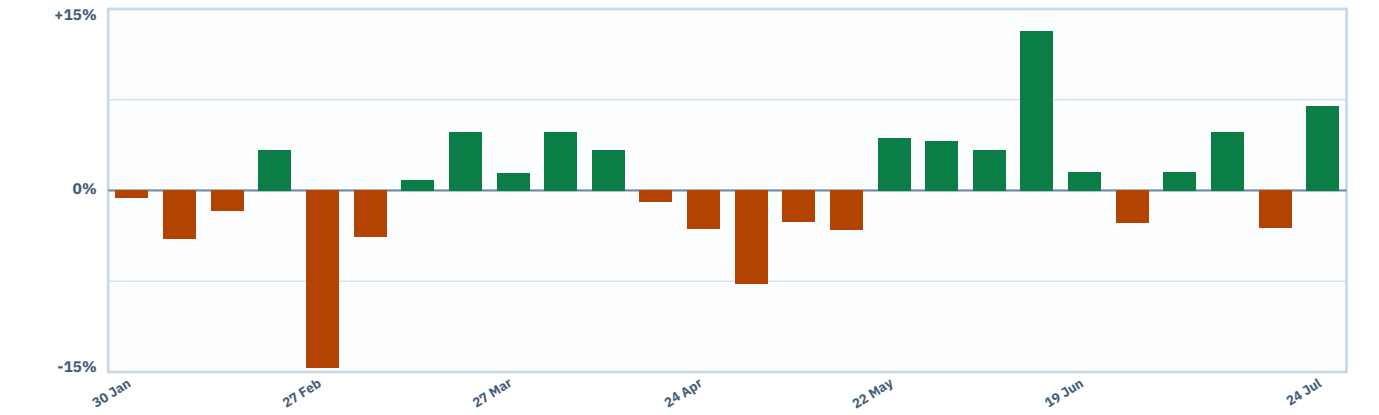
