Near-term considerations: volume confirmation is below normal; earnings are due in 12d.

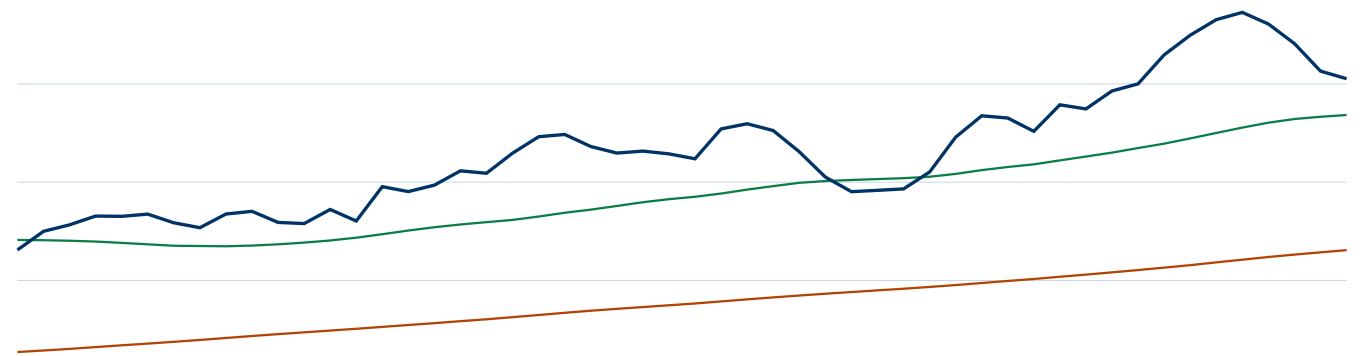

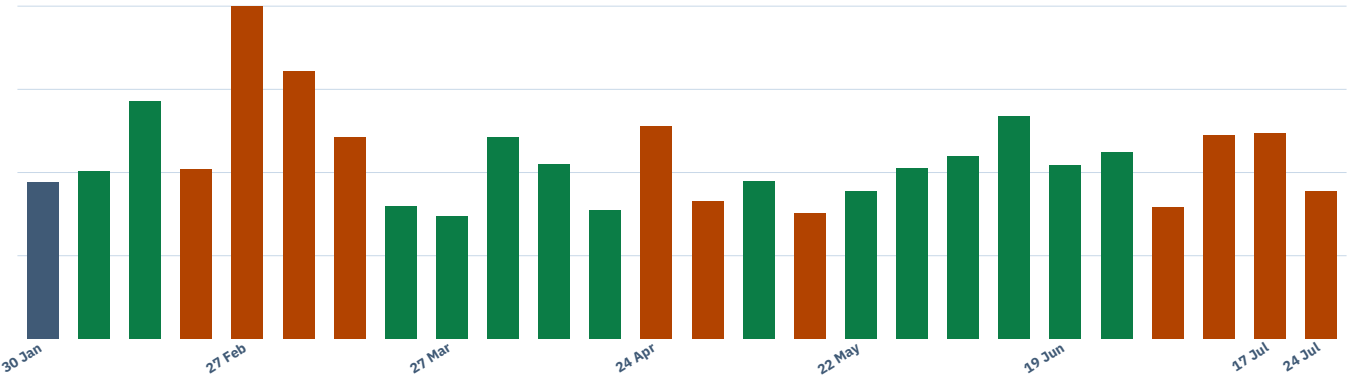
02 · VOLUME AND DEMAND

Activity pressure and institutional-style signals

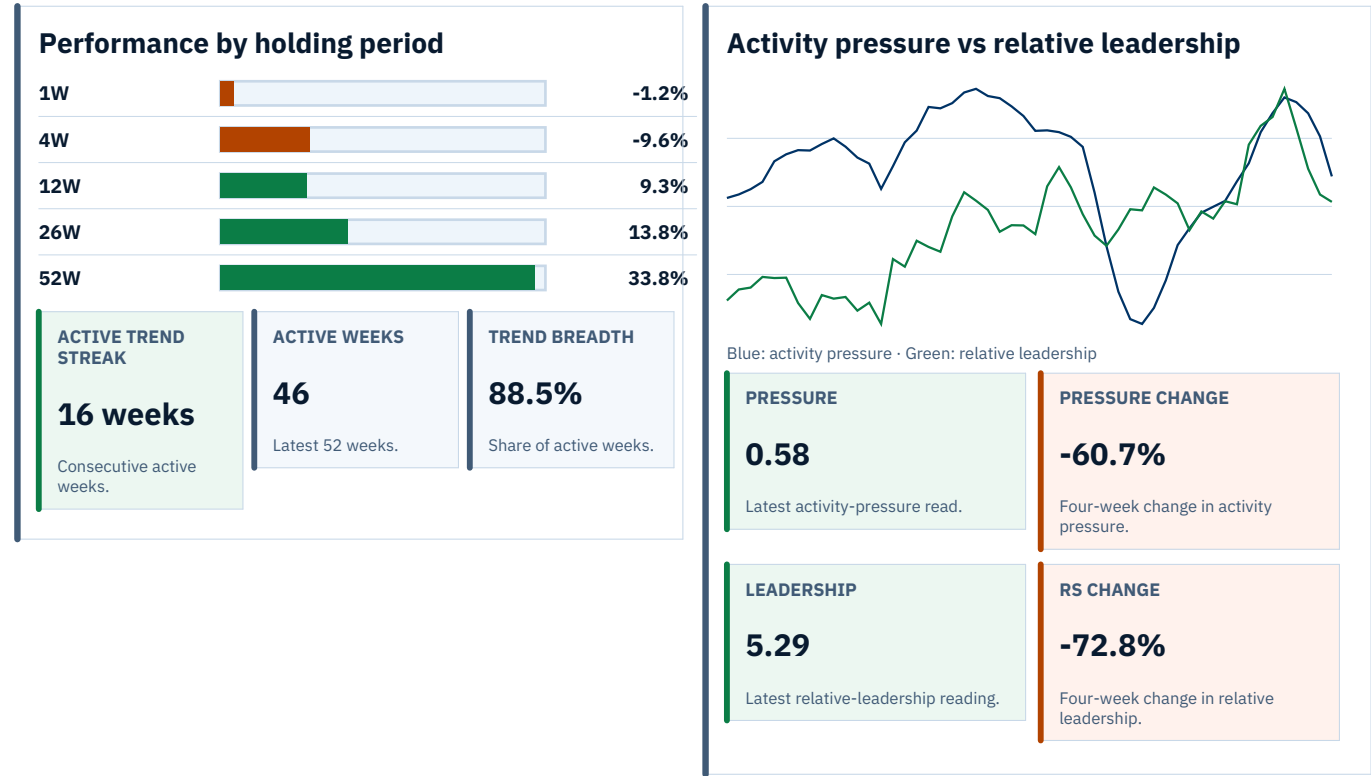
These indicators assess whether participation is improving beneath price. They are supporting evidence, not proof of institutional buying.

How to read this

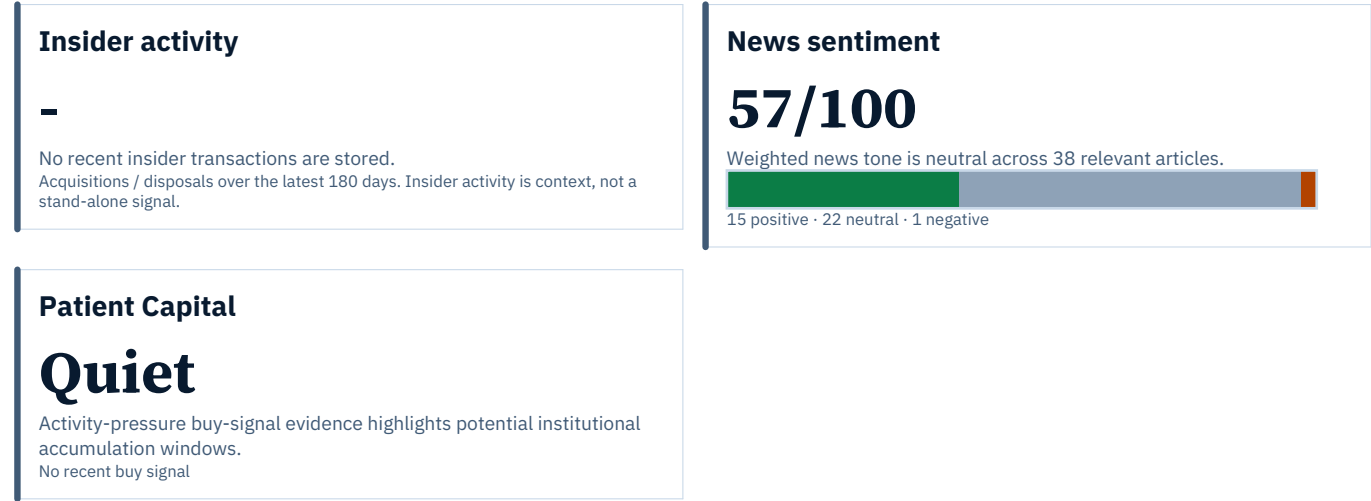

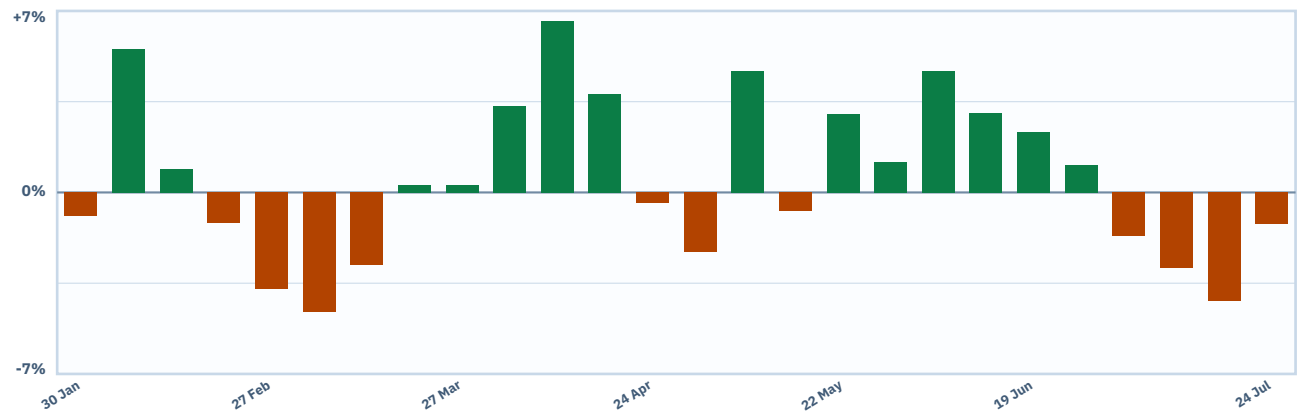
