Weekly setup

Constructive, but selective

The weekly trend is active. Price is 15.7% above the Trend Line and sits at 84.4% of its 52-week range. The latest completed week returned -4.0%, after a 7.8% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth is moderate; valuation is neither clearly cheap nor expensive. Options positioning is mixed with 34/100 conviction, while the latest news-sentiment score is 59/100. Near-term considerations: earnings are due in 84d.

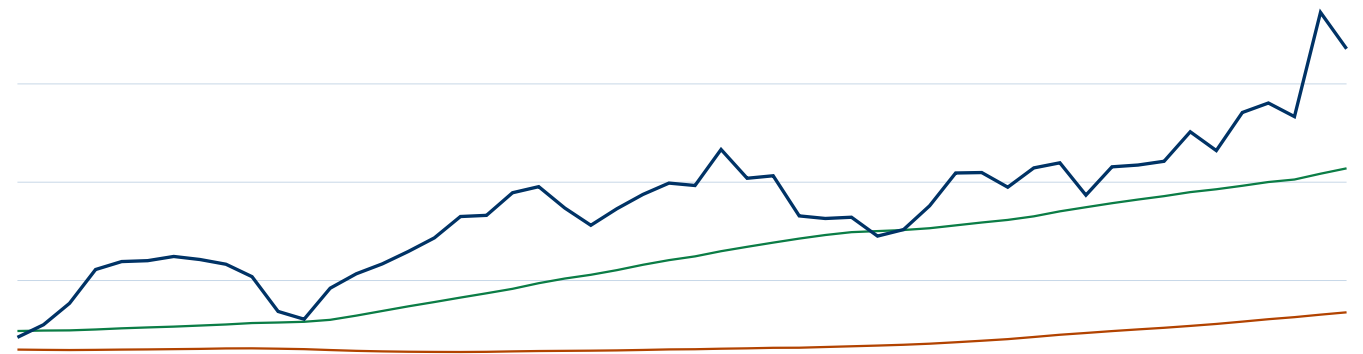

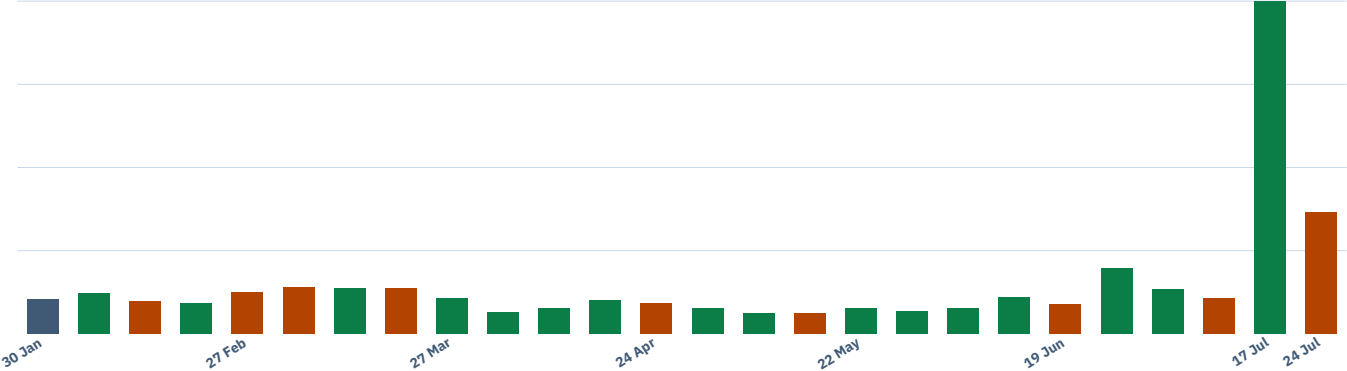
02 · VOLUME AND DEMAND

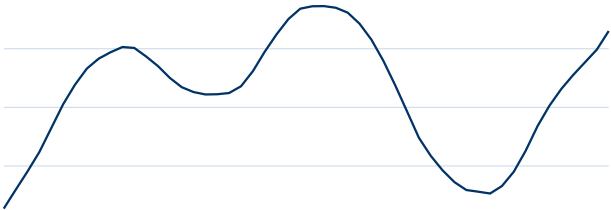

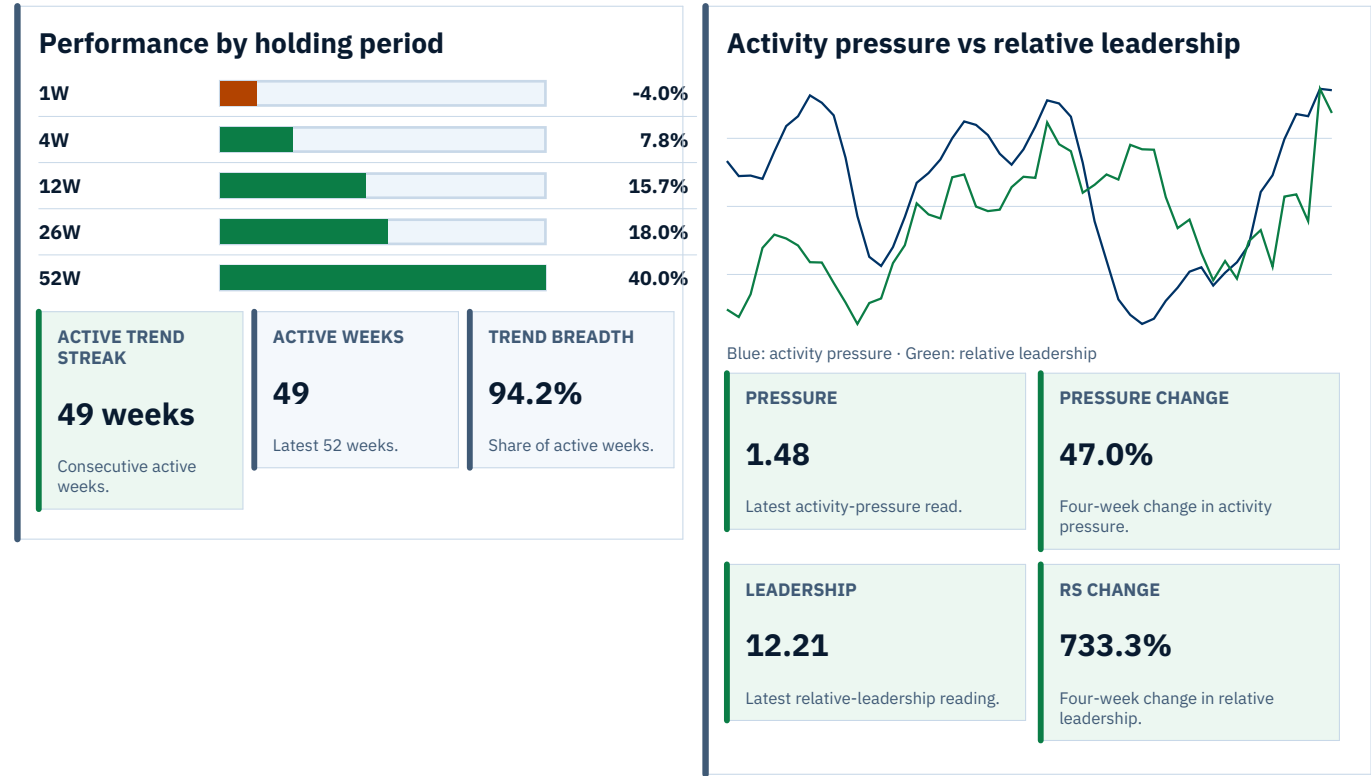

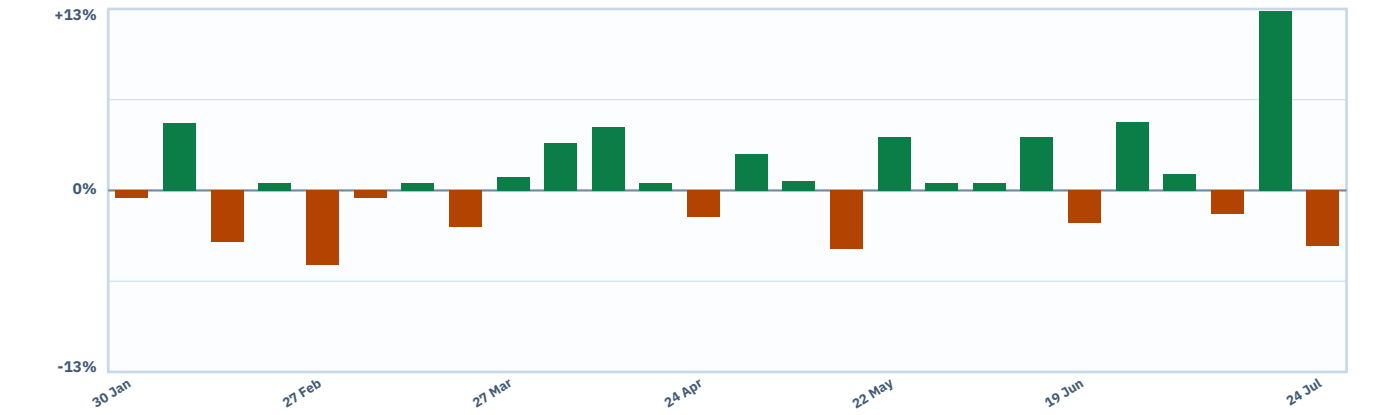
