- Price is above Fair Value, showing premium demand versus the model.

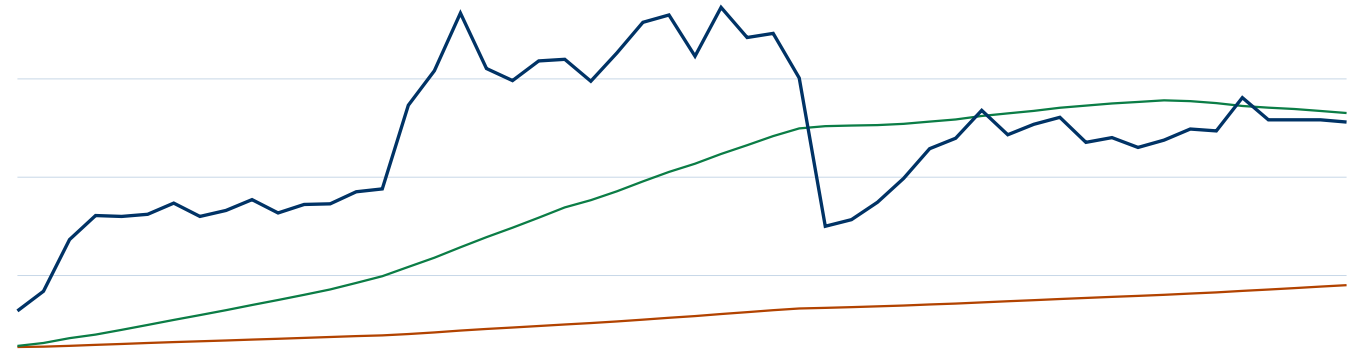

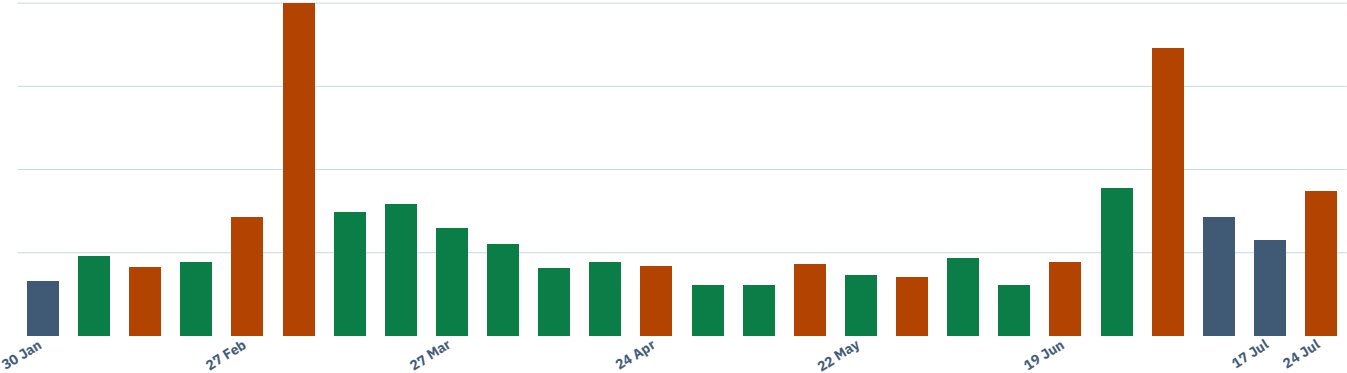
02 · VOLUME AND DEMAND

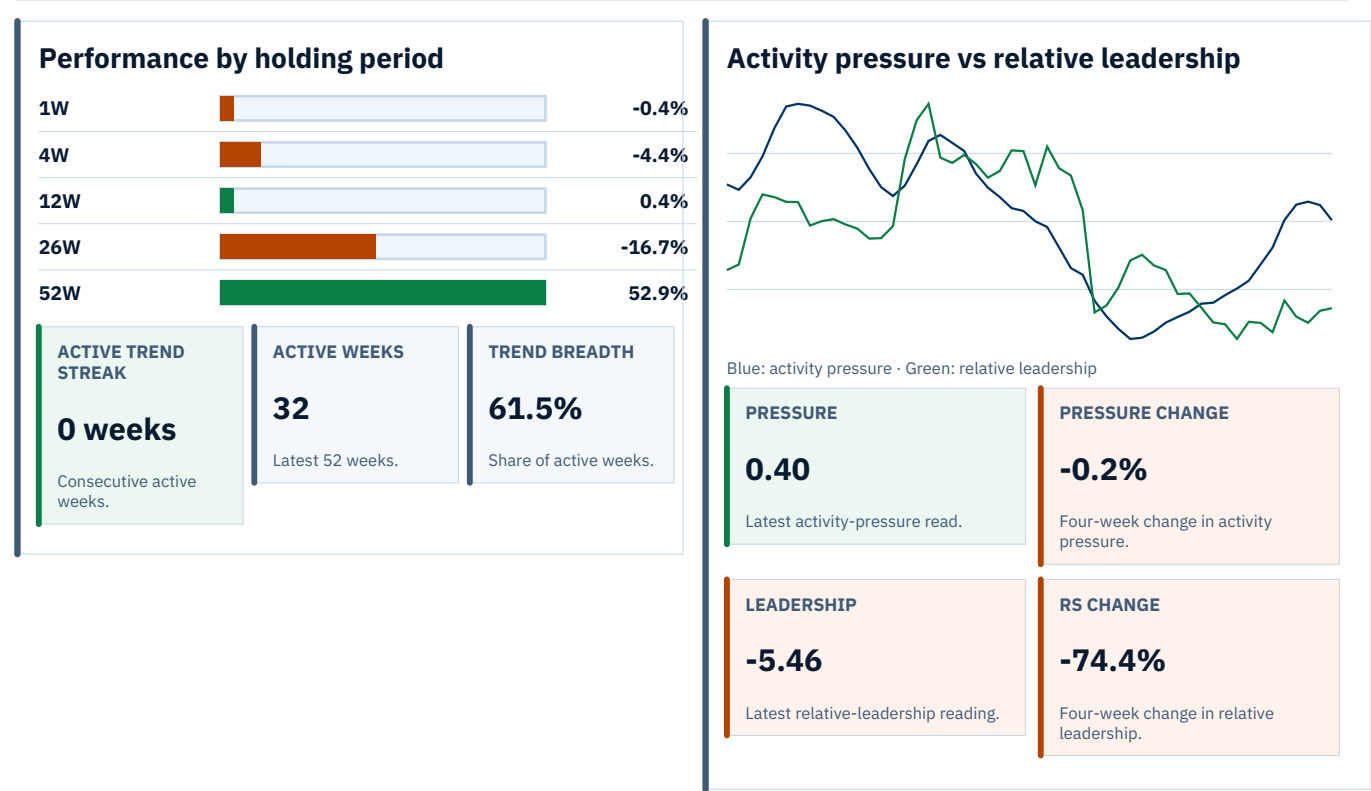

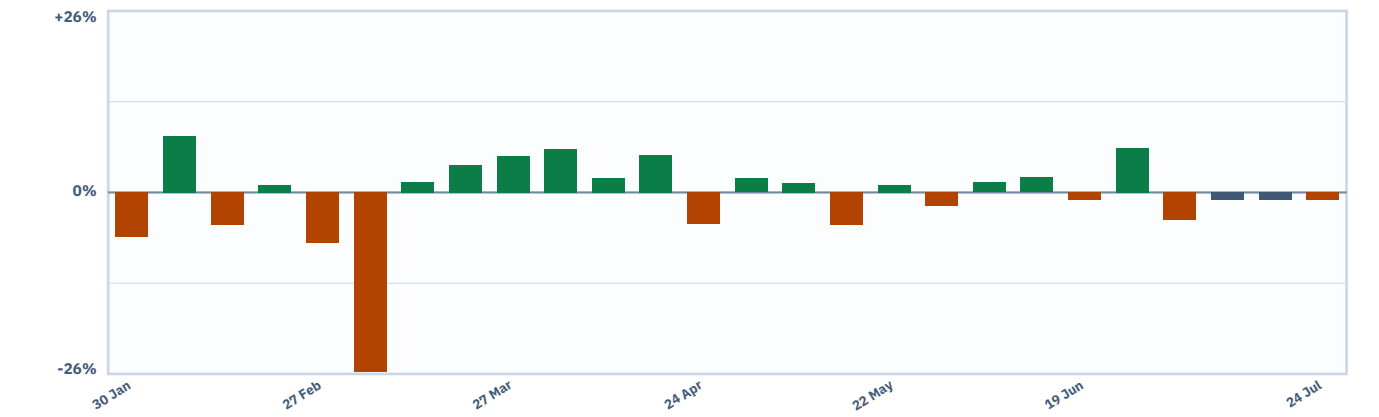
