Weekly setup

Constructive, but selective

The weekly trend is active. Price is 22.0% above the Trend Line and sits at 98.1% of its 52-week range. The latest completed week returned 7.4%, after a 13.5% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth is moderate; valuation is neither clearly cheap nor expensive. Options positioning is bullish with 42/100 conviction, while the latest news-sentiment score is 54/100. Near-term considerations: price is close to its 52-week high; earnings are due in 5d.

Technical setup score 77/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

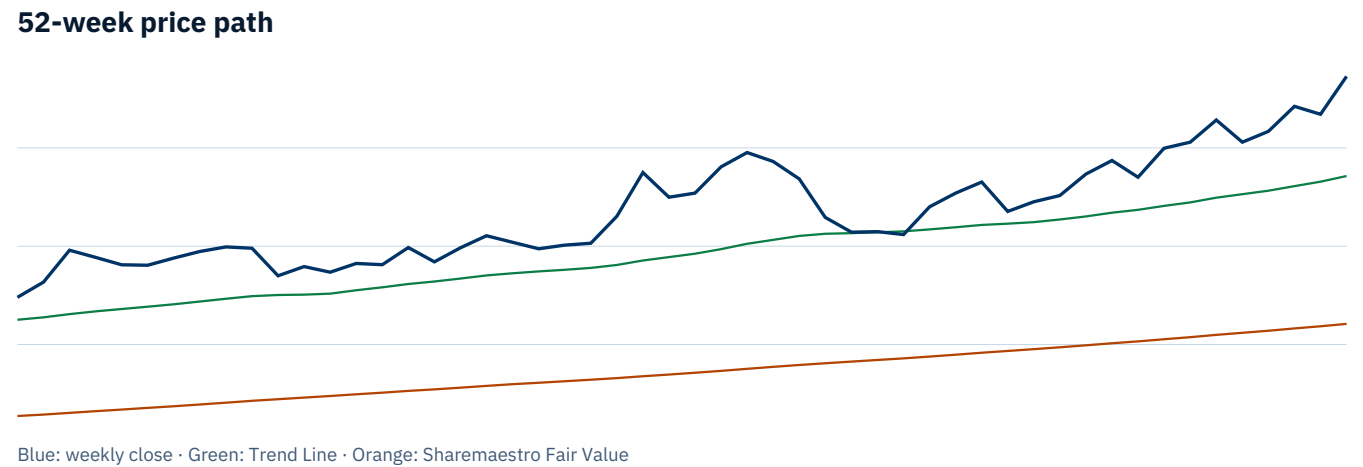

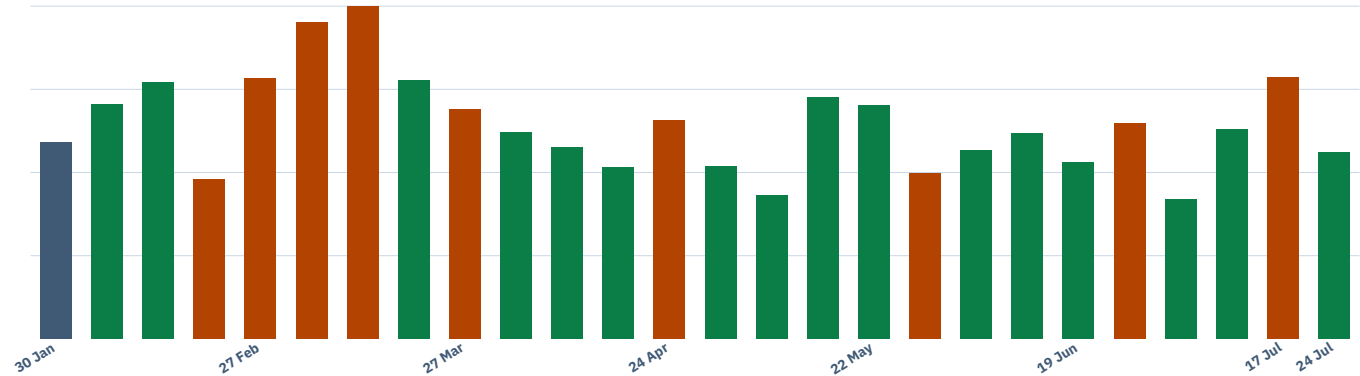
02 · VOLUME AND DEMAND

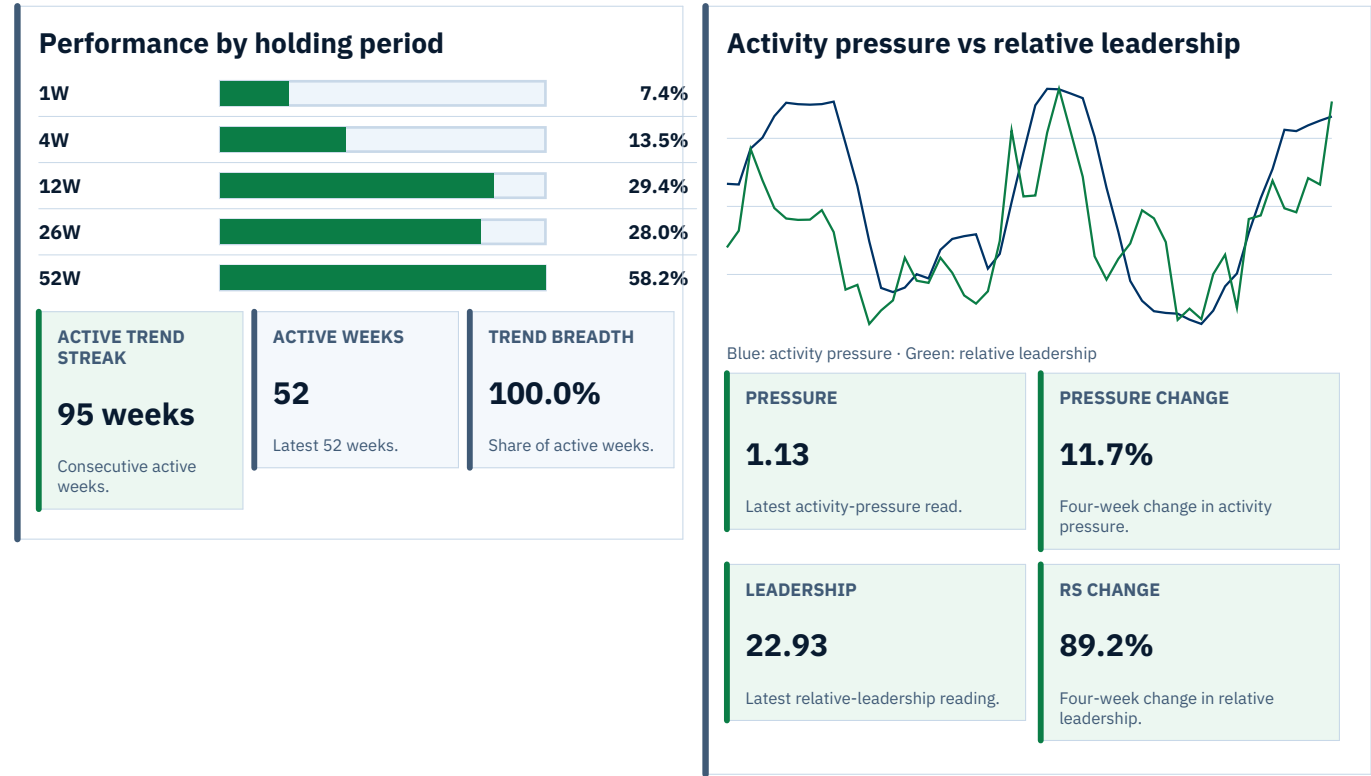

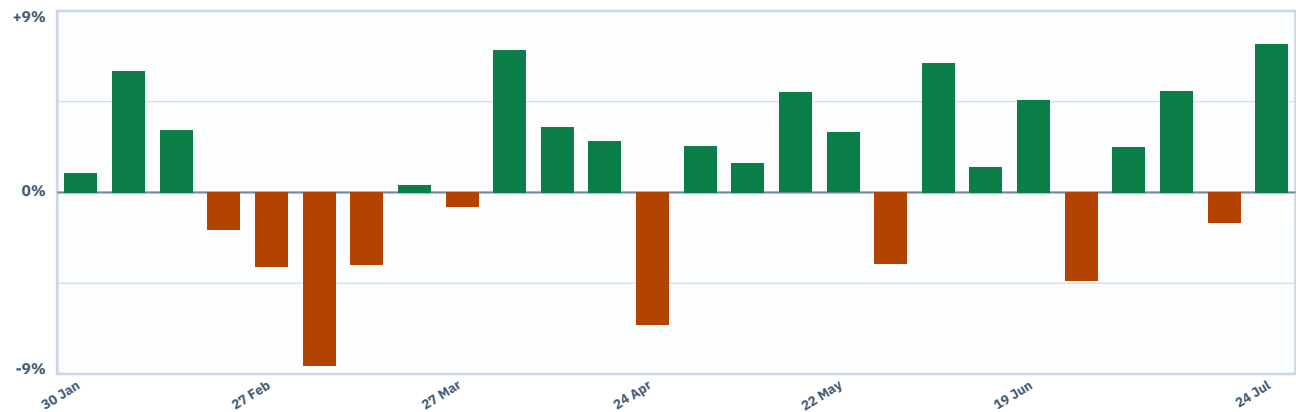
