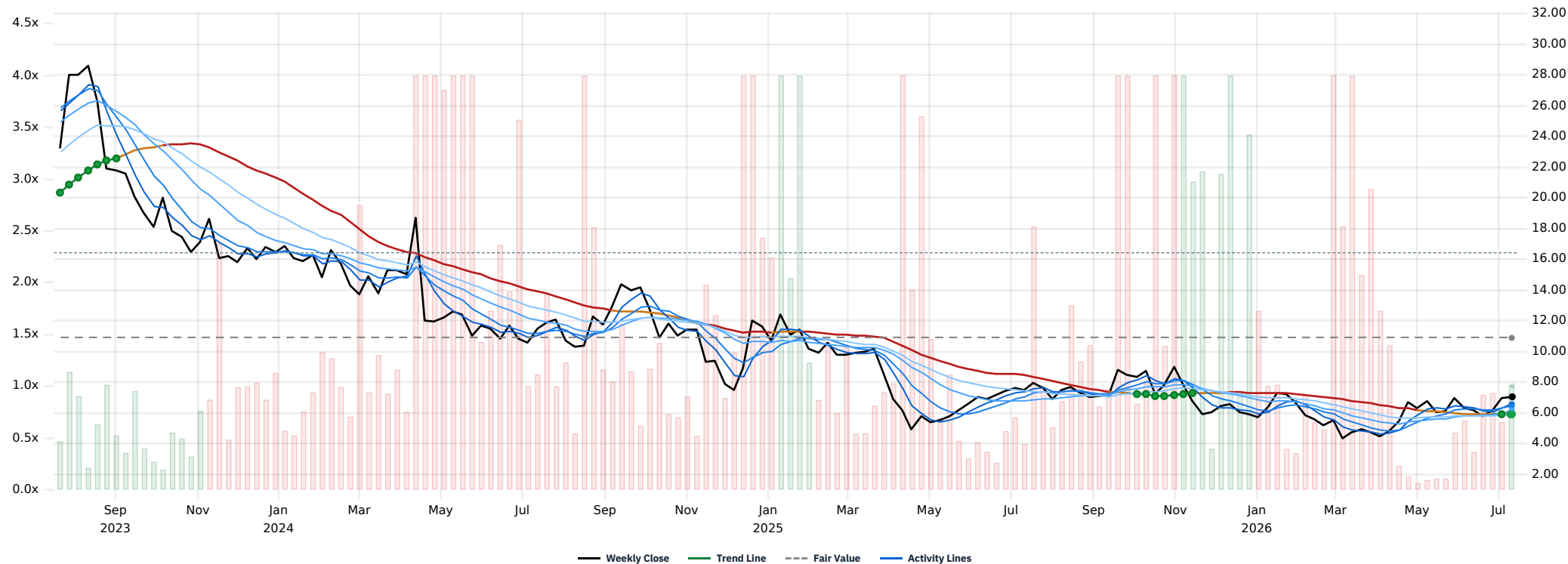

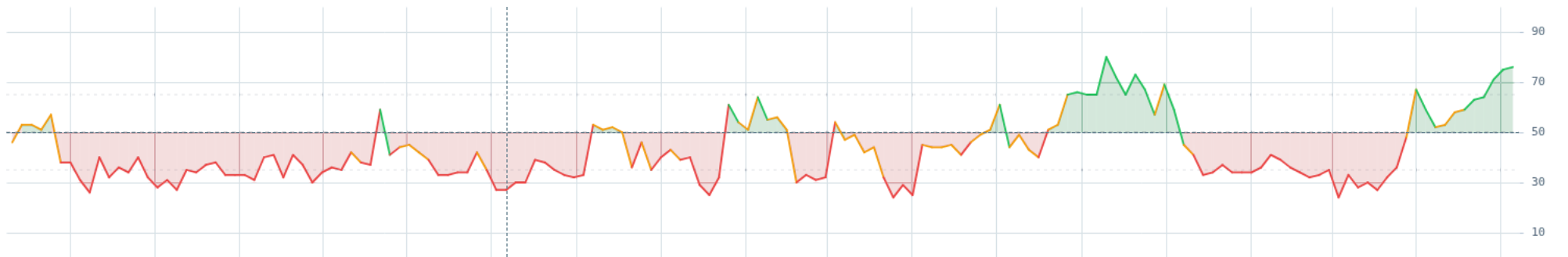

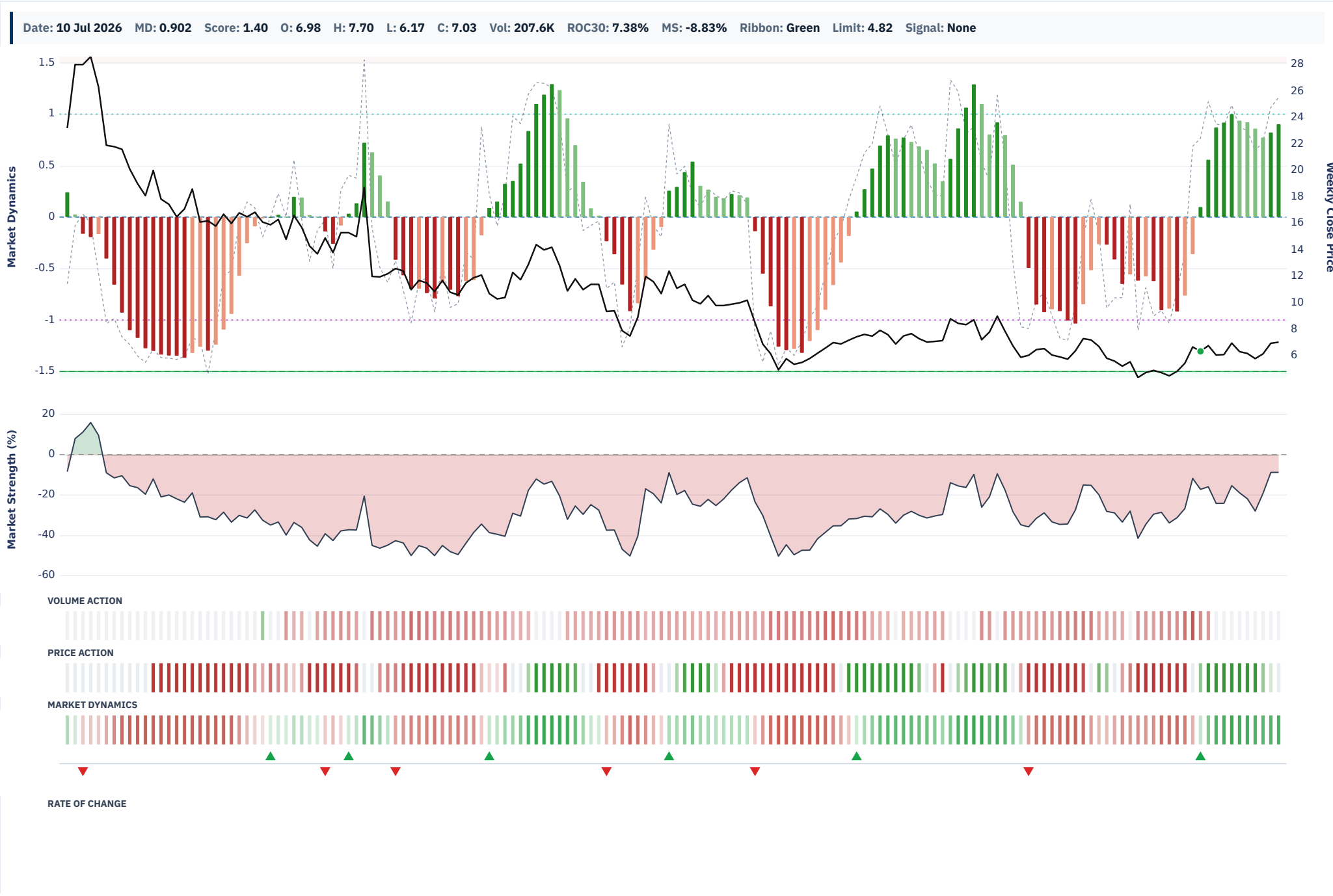


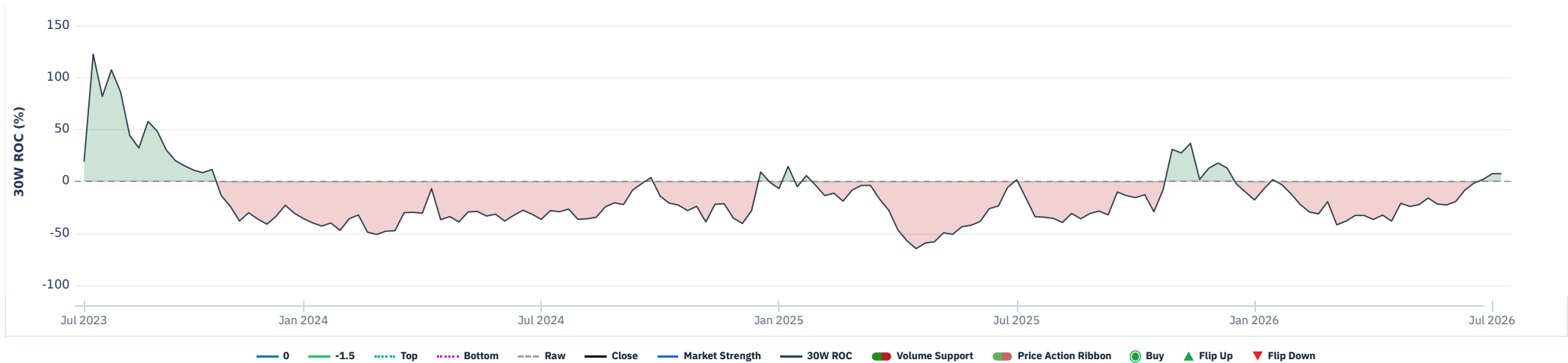
Volume Profile · Auction Structure

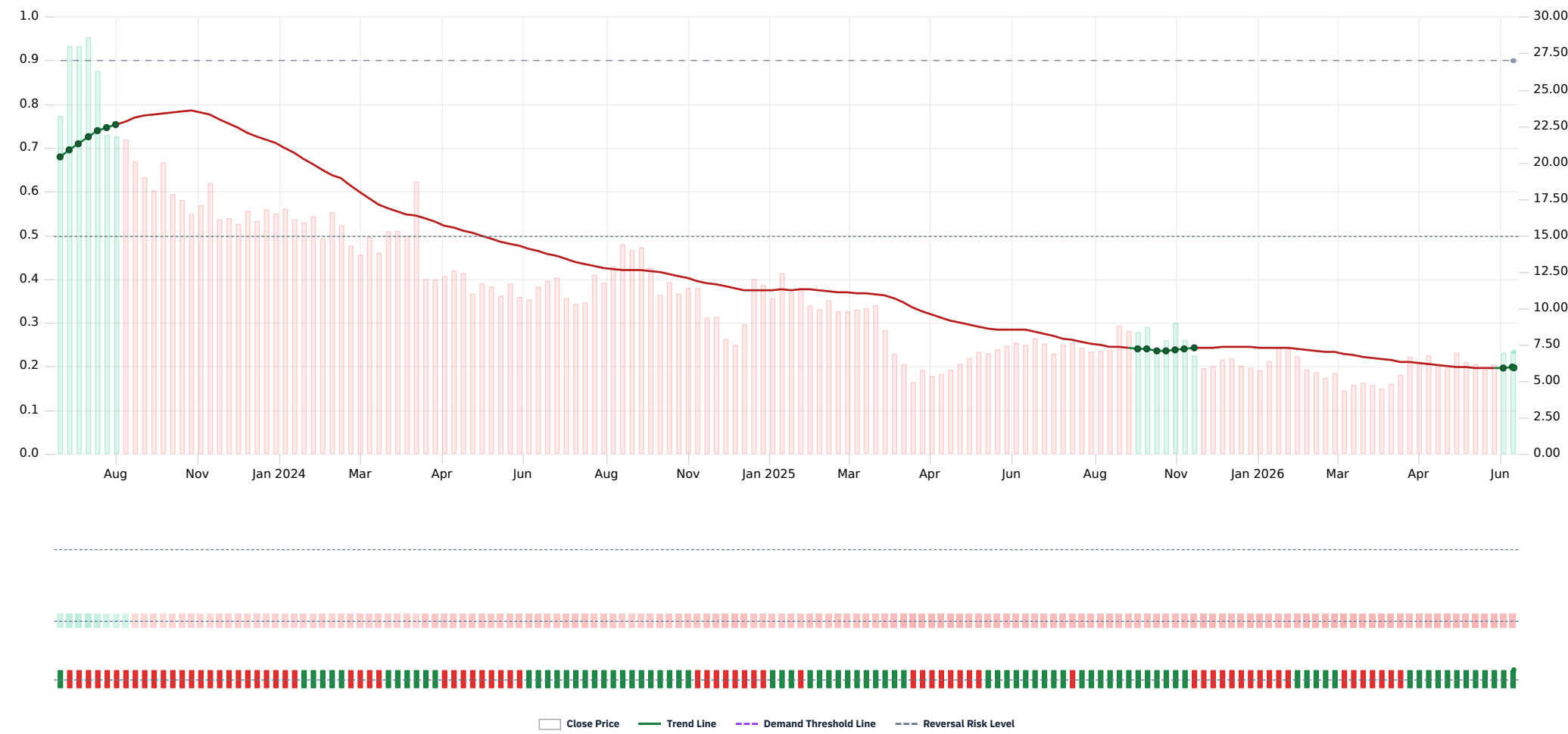

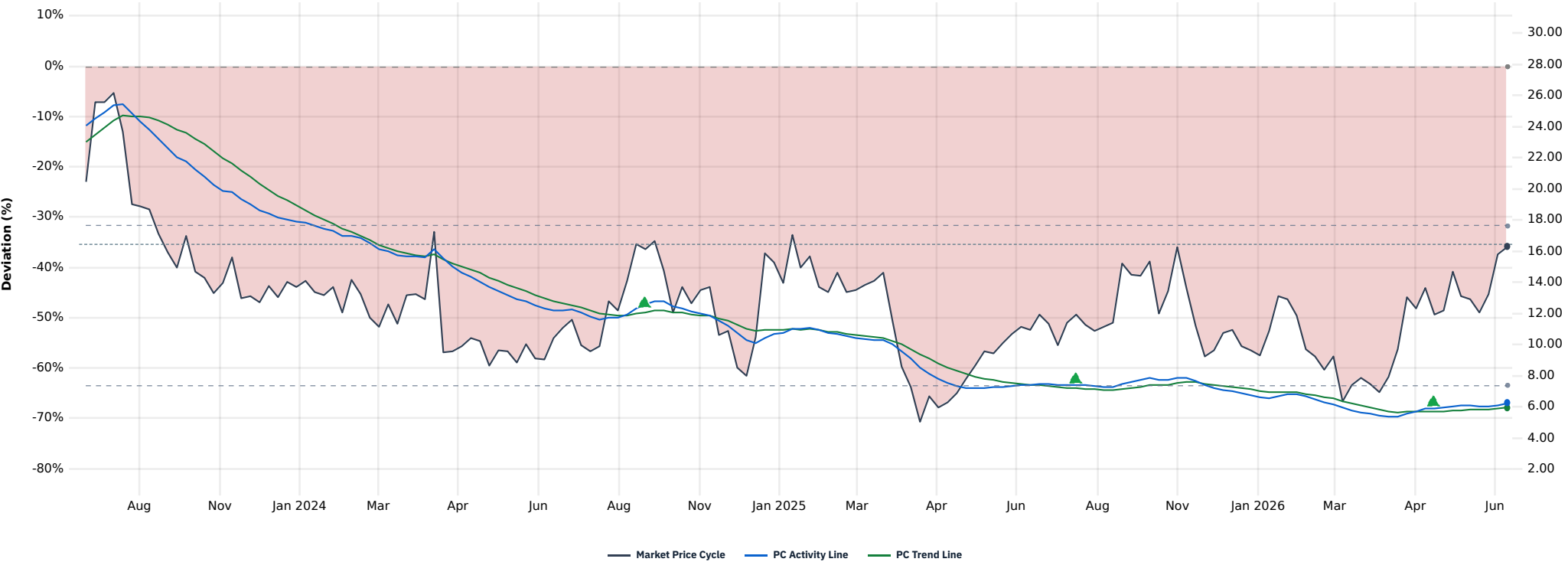

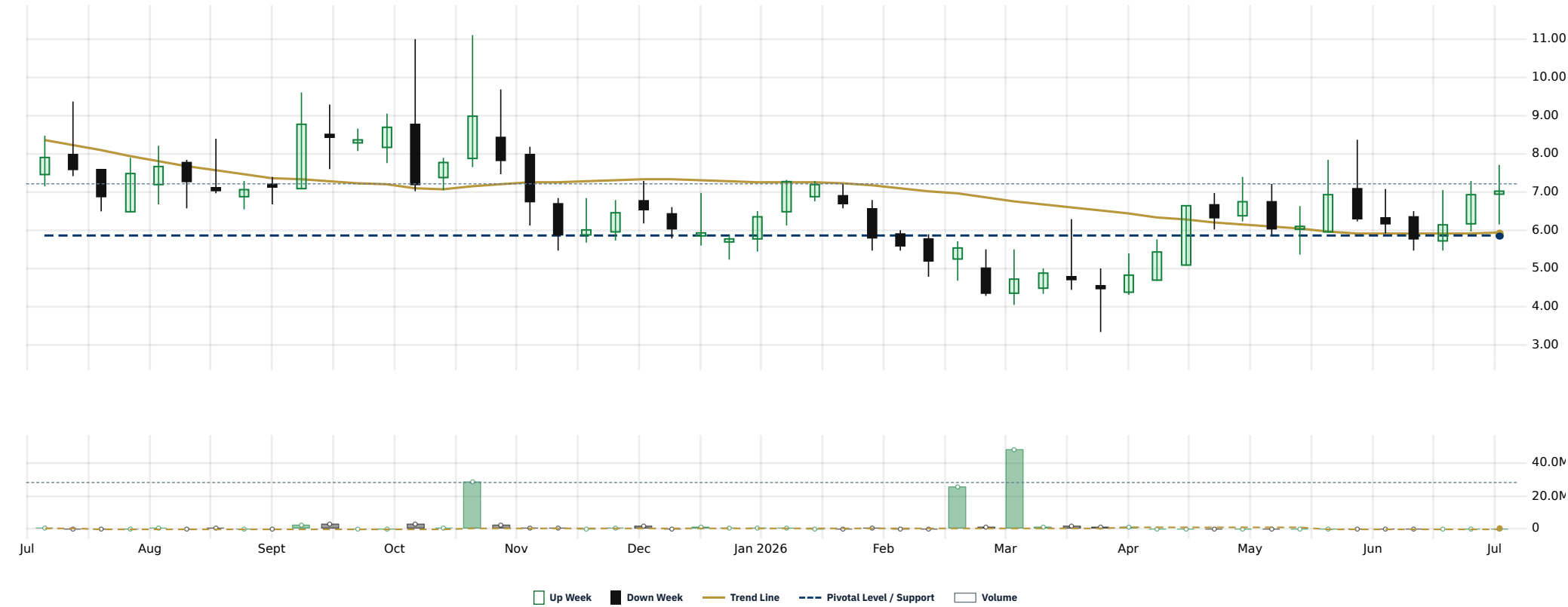
Price Cycle

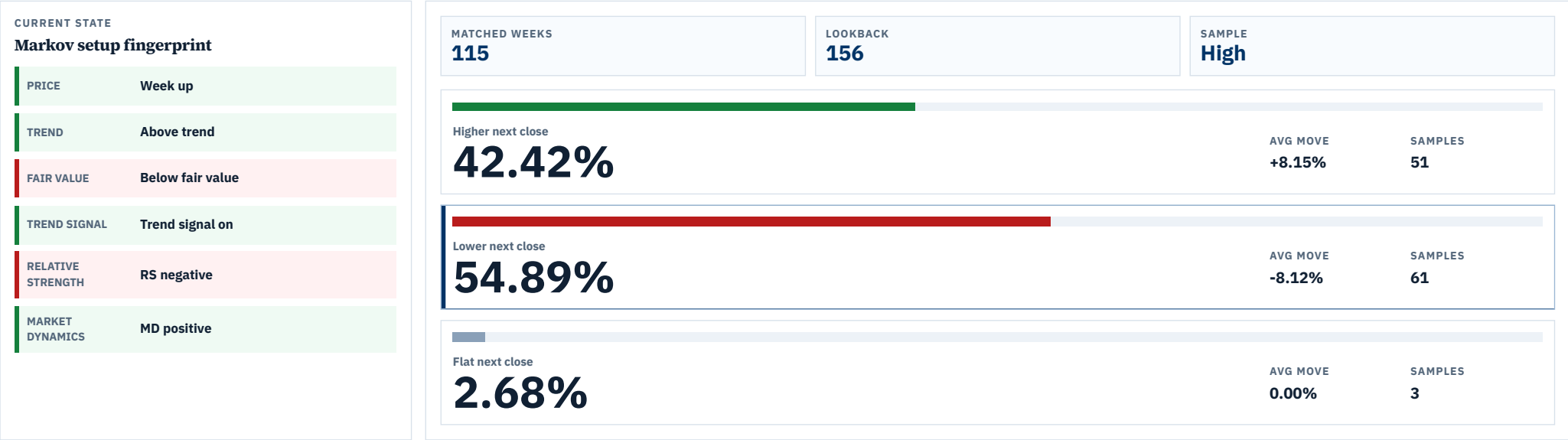
