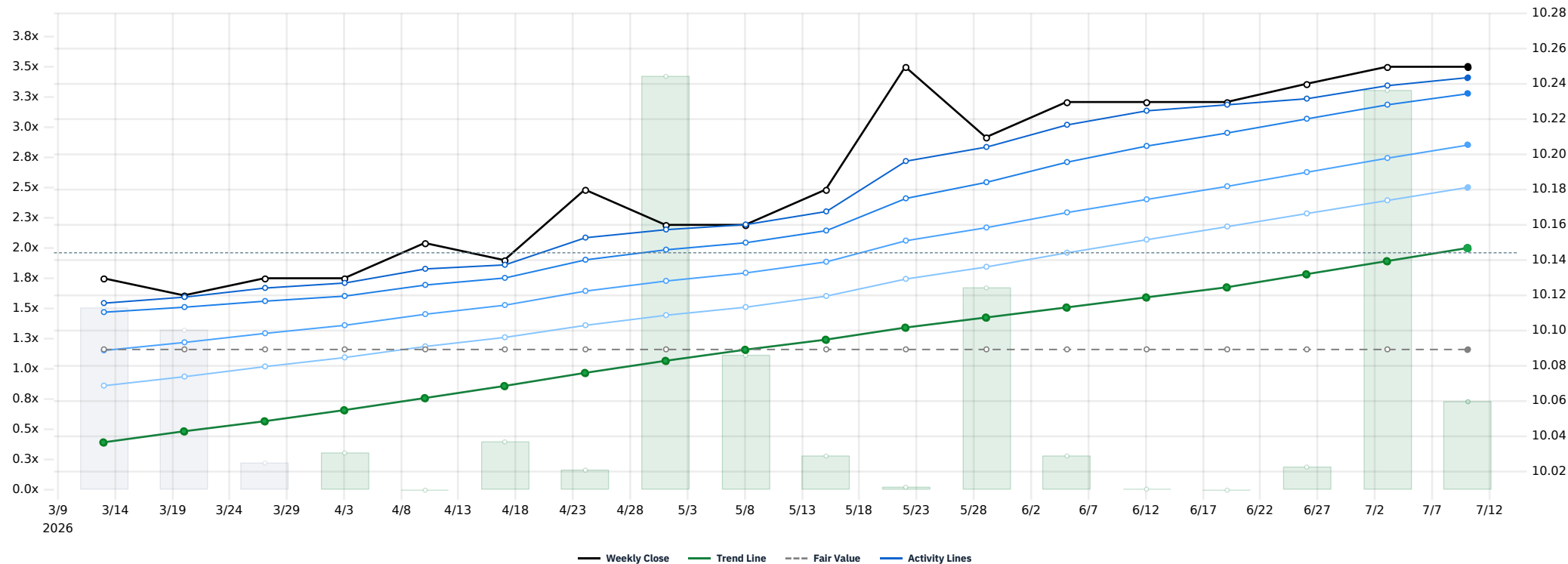

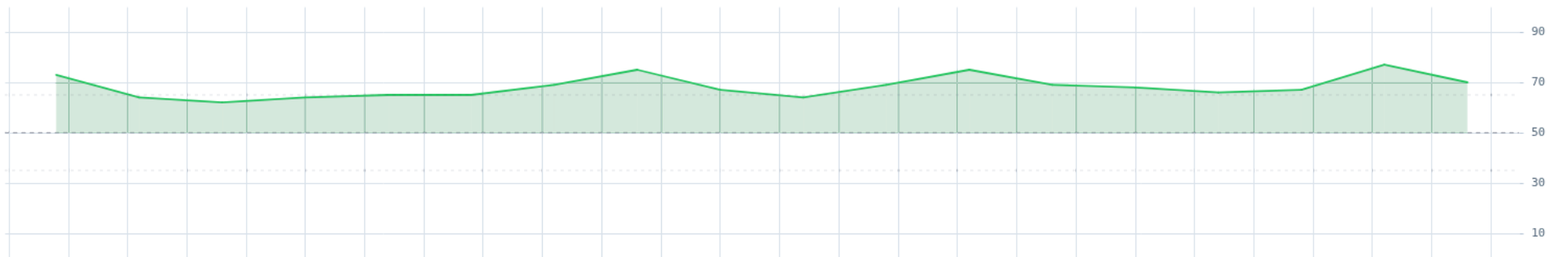

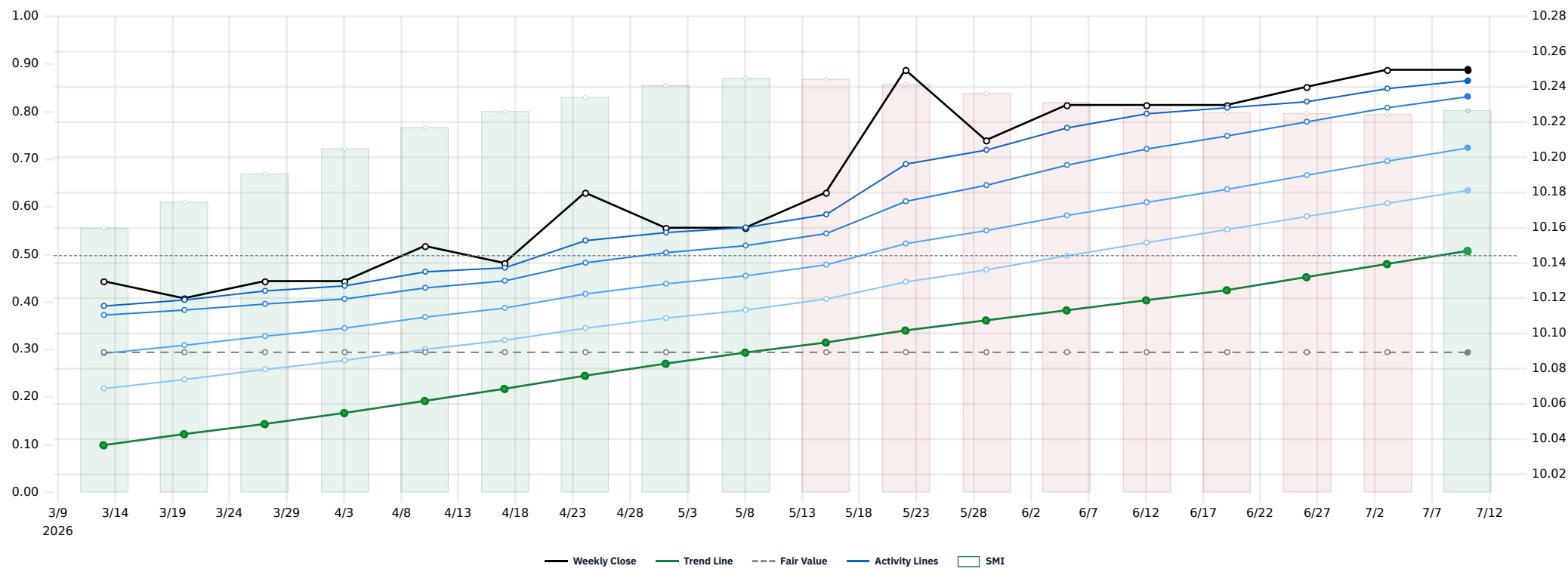

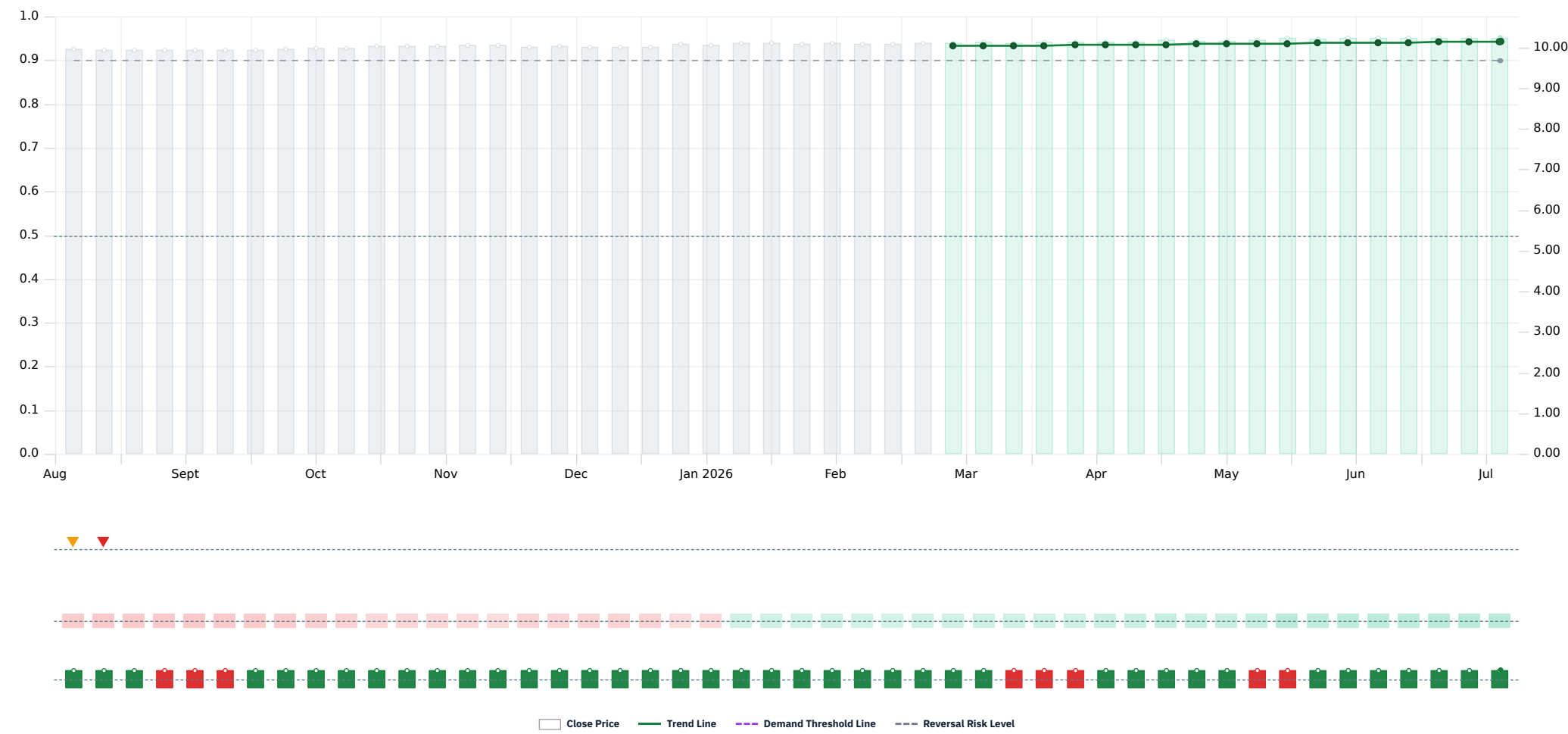

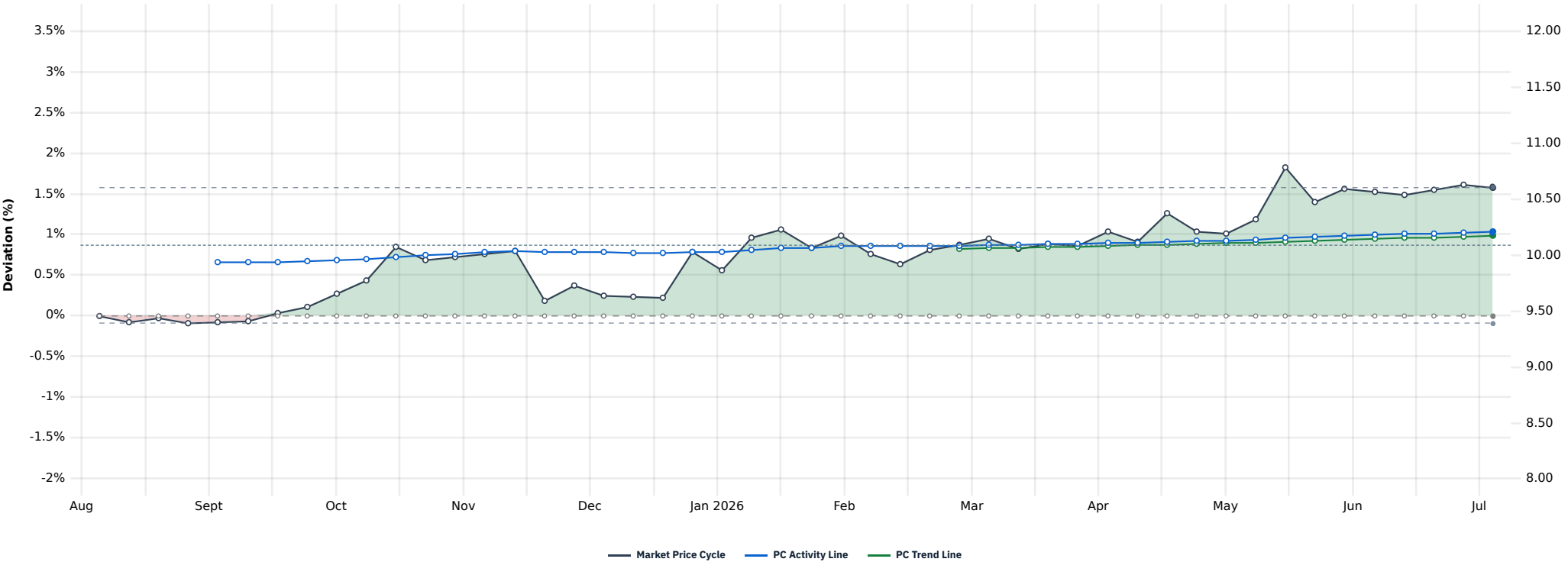

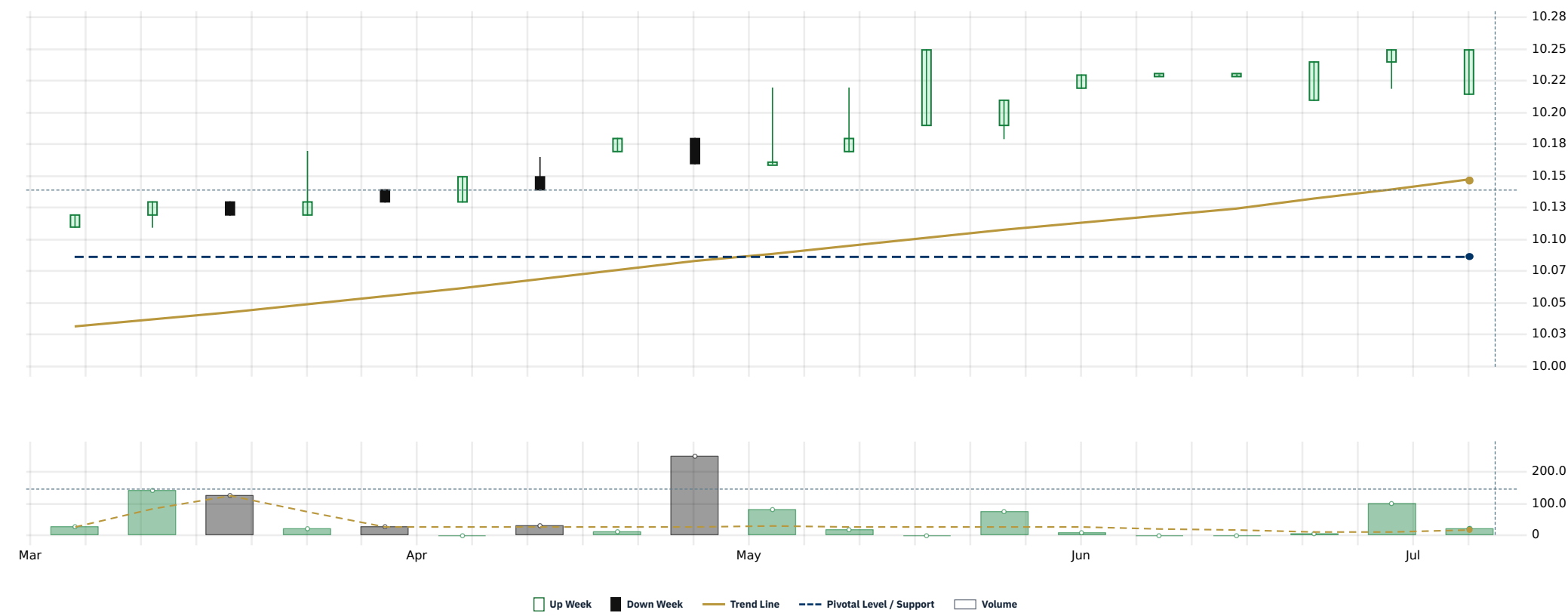
Price Cycle

Next-State Map

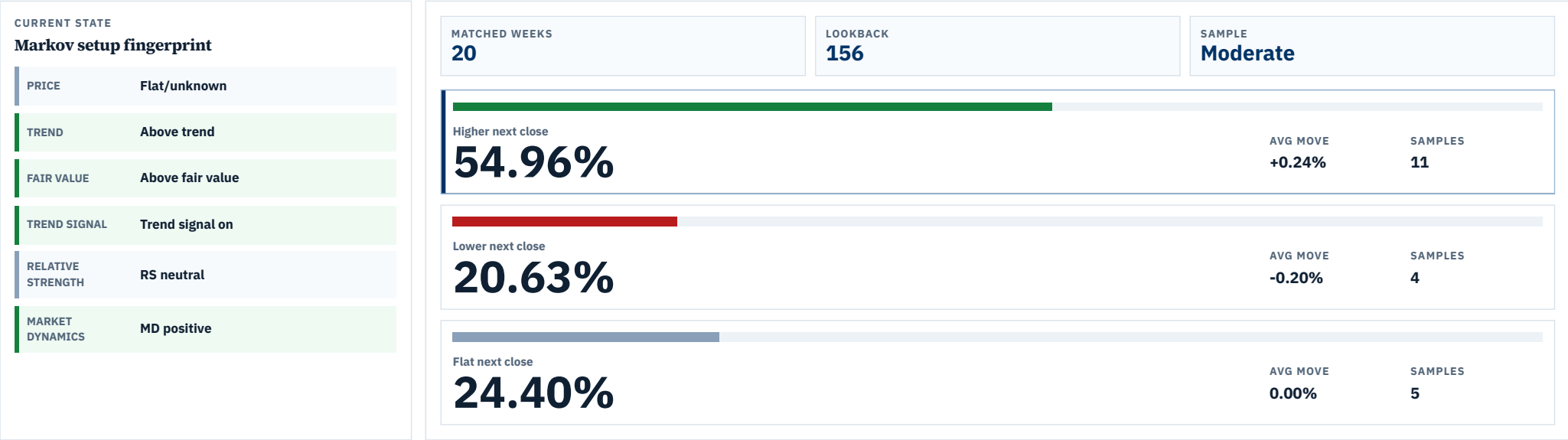
