Weekly setup

Constructive, but selective

The weekly trend is active. Price is 14.8% above the Trend Line and sits at 84.5% of its 52-week range. The latest completed week returned 4.3%, after a 4.2% four-week move. The latest factor snapshot indicates quality ranks weakly versus its universe; growth ranks weakly; valuation is neither clearly cheap nor expensive. Options positioning is bullish with 46/100 conviction, while the latest news-sentiment score is 53/100. Near-term considerations: volume confirmation is below normal; earnings are due in 7d.

Technical setup score 67/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

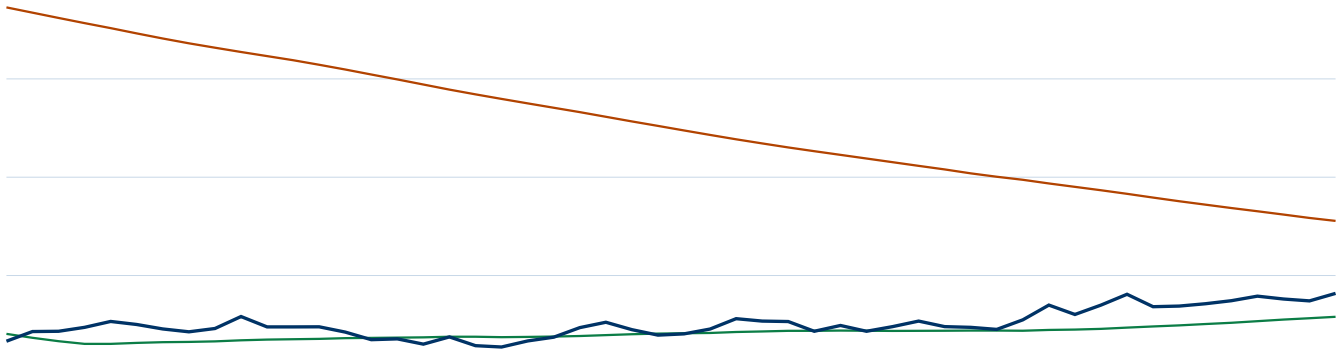

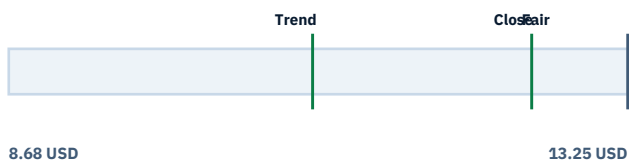

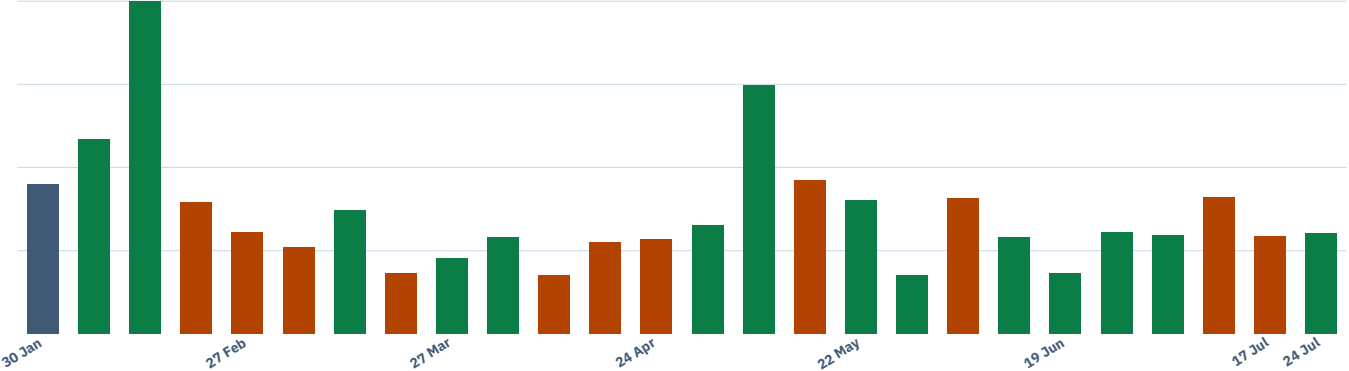
02 · VOLUME AND DEMAND

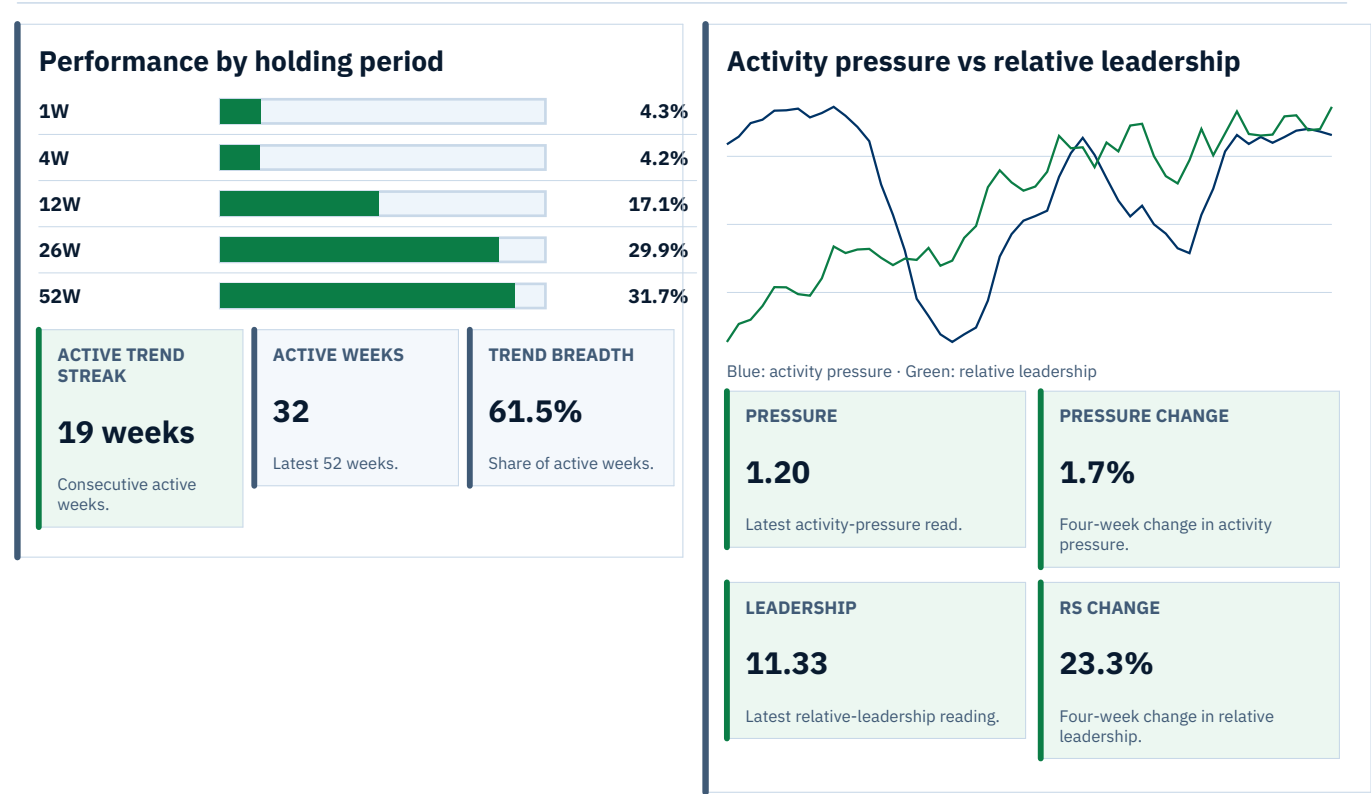

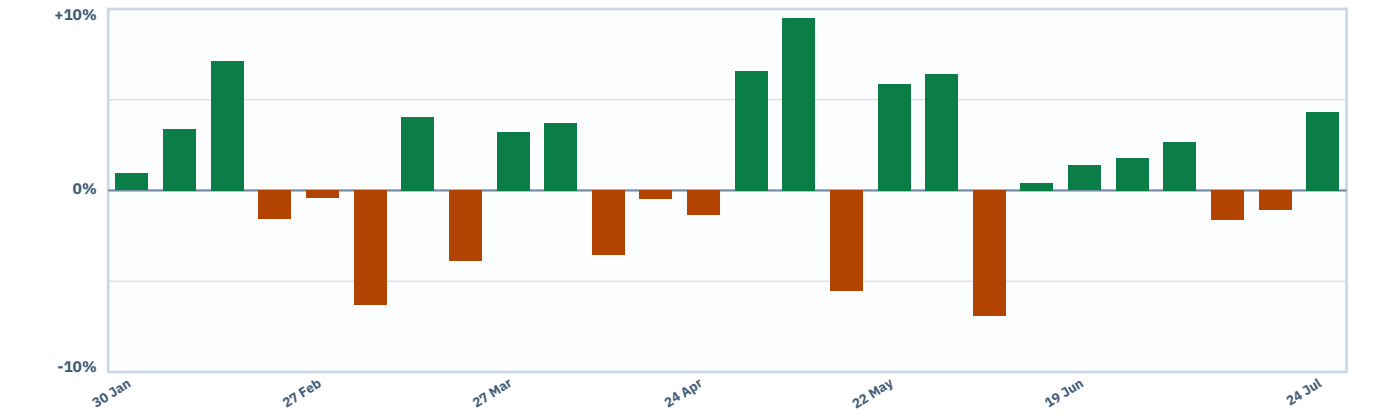
