Weekly setup

Weak trend

The weekly trend is not active. Price is -17.9% below the Trend Line and sits at 2.5% of its 52-week range. The latest completed week returned -7.6%, after a -8.4% four-week move. The latest factor snapshot indicates quality ranks weakly versus its universe; growth ranks weakly; valuation is neither clearly cheap nor expensive. Options positioning is bullish with 41/100 conviction, while the latest news-sentiment score is 47/100. Near-term considerations: volume confirmation is below normal; earnings are due in 34d.

- Activity pressure is positive on the latest completed week.

- Next-week expectancy is negative at 40.85% based on similar historical setup states.

What to watch next

- Trend Line remains the key weekly regime level.
- Activity pressure is the gauge to monitor for confirmation or fade.
- A volume ratio above 1.5x would show stronger participation in the next move.

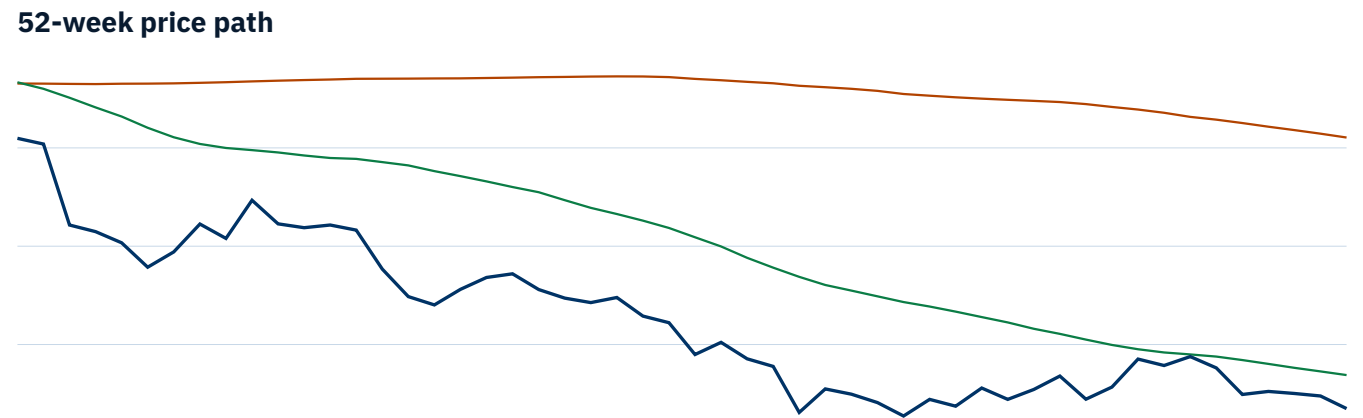

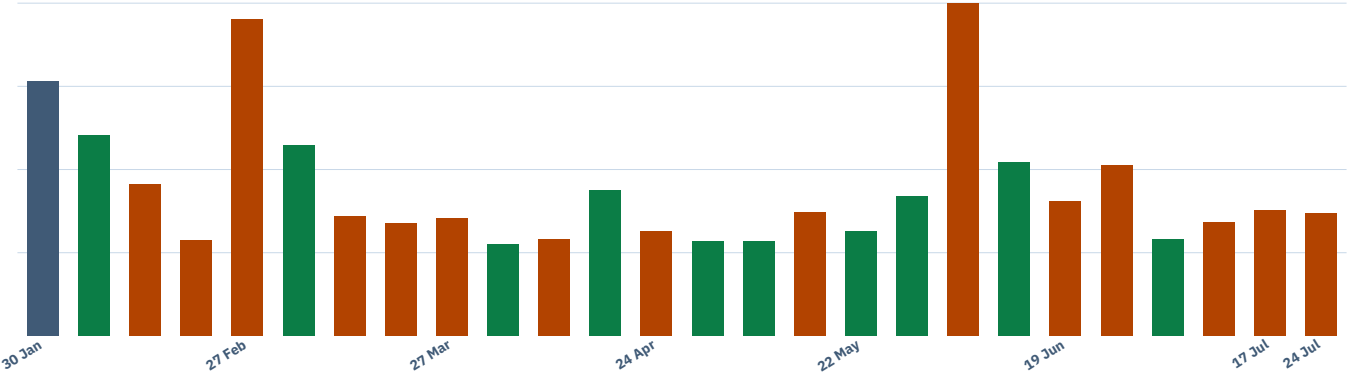
02 · VOLUME AND DEMAND

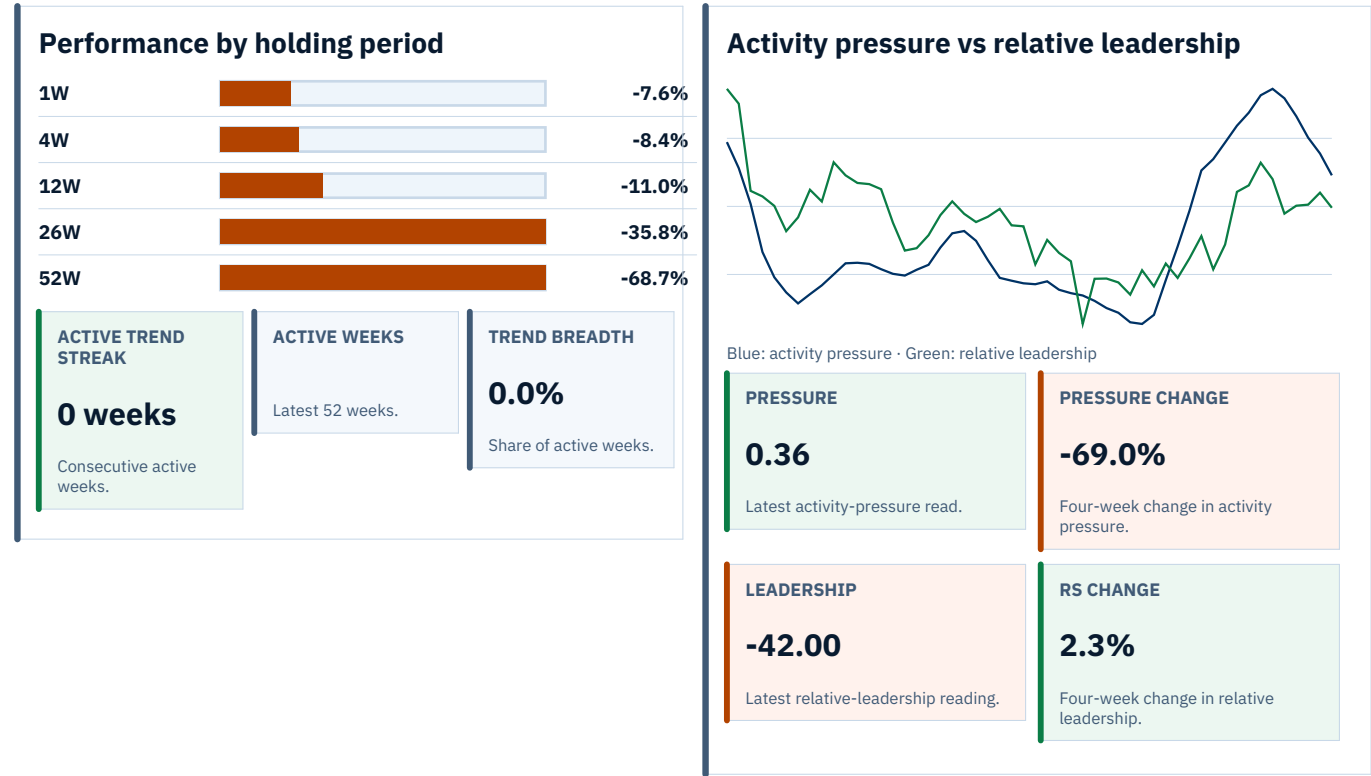

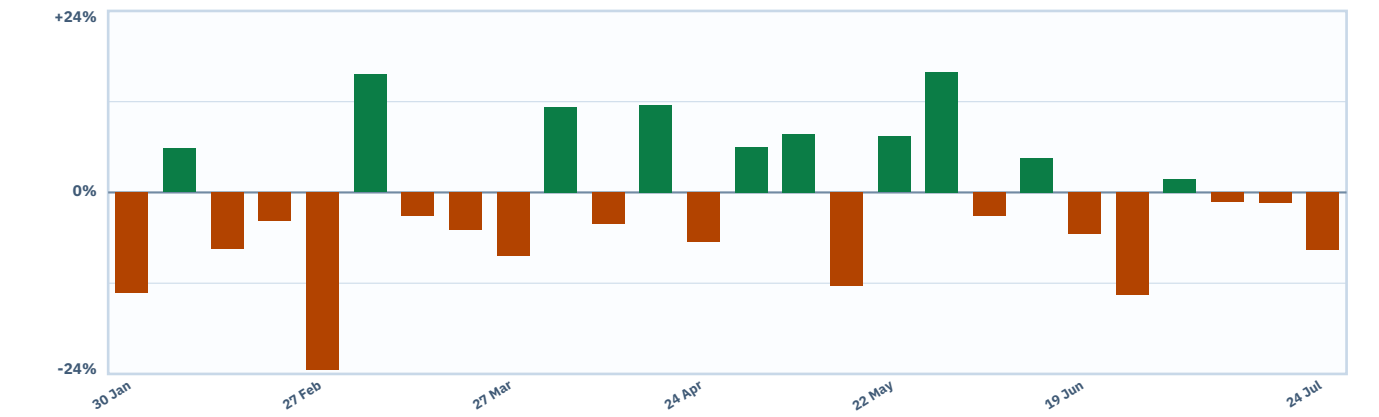
