Weekly setup

Constructive, but selective

The weekly trend is active. Price is 13.6% above the Trend Line and sits at 98.1% of its 52-week range. The latest completed week returned 0.7%, after a 8.3% four-week move. The latest factor snapshot indicates quality is middle-of-the-pack; growth ranks strongly; valuation is inexpensive relative to peers. Options positioning is bullish with 56/100 conviction, while the latest news-sentiment score is 57/100. Near-term considerations: price is close to its 52-week high.

Technical setup score 66/100. This score describes the weekly technical setup; the conclusion above also considers fundamentals, positioning, sentiment, and event risk.

- Next-week expectancy is negative at 42.17% based on similar historical setup states.
- 1 reversal markers appear in the recent smart-money tape.

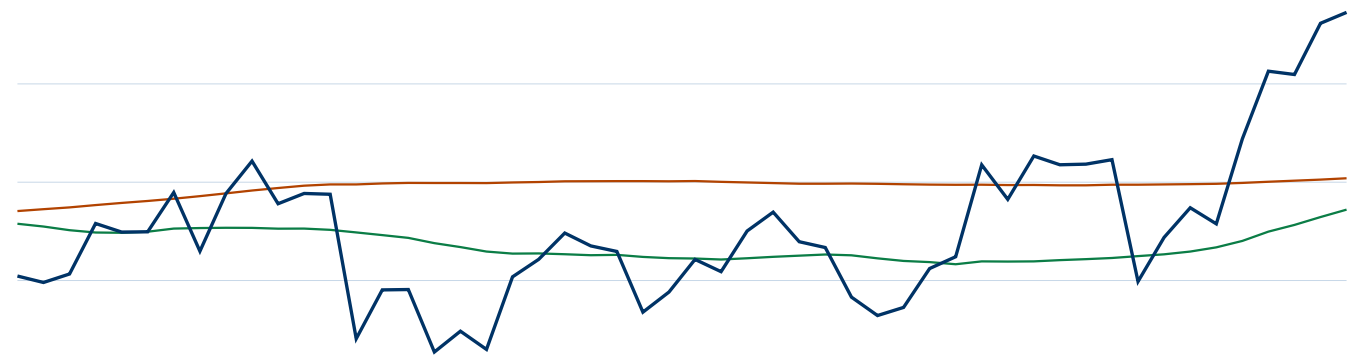

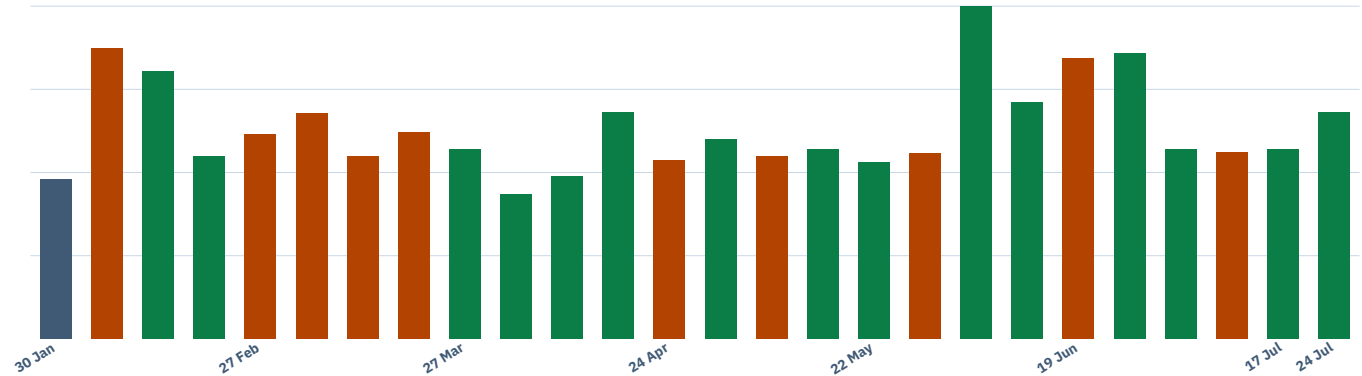

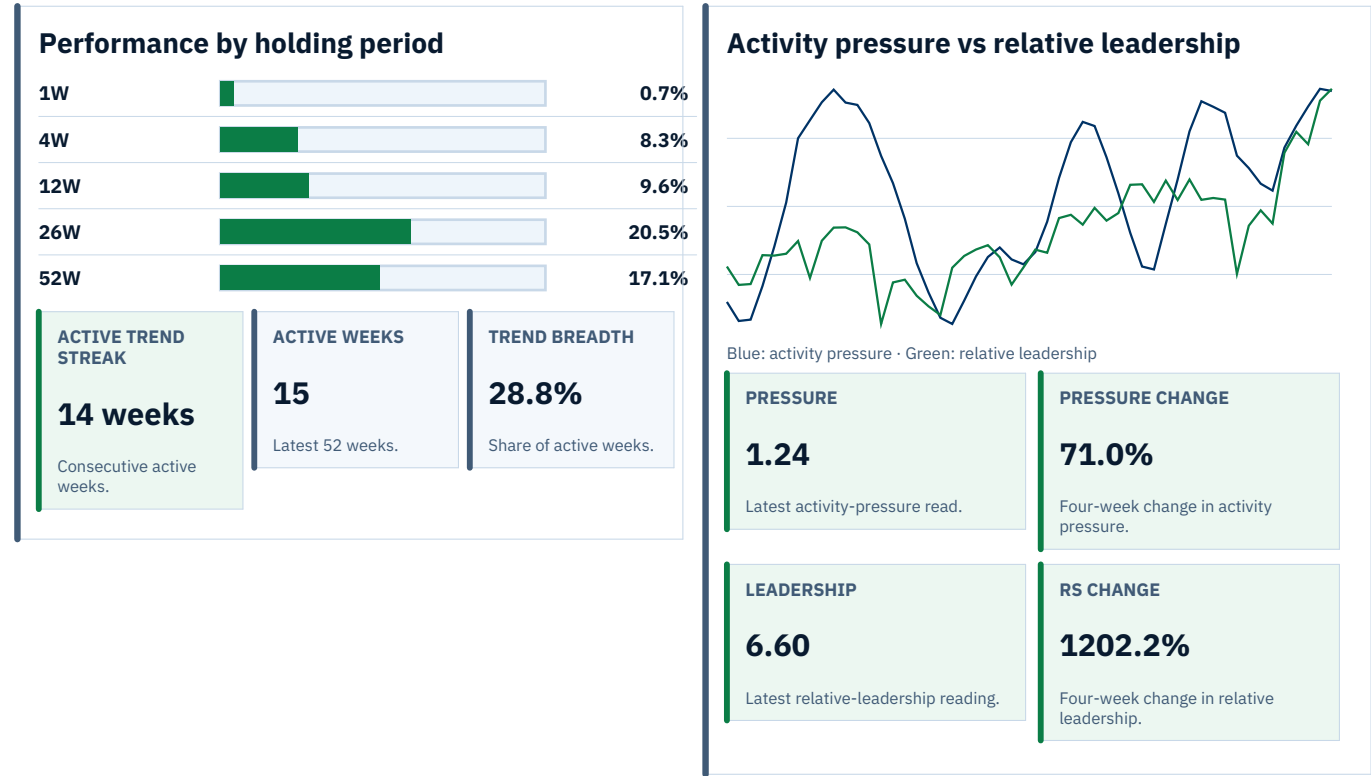

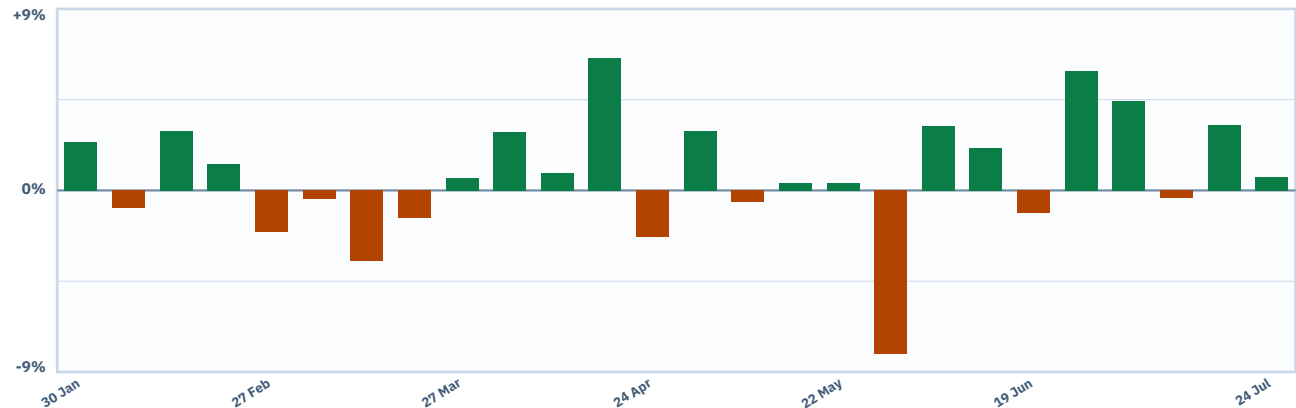
