Near-term considerations: volume confirmation is below normal; earnings are due in 22d.

What is working

- The trend backdrop is active with a 5-week active streak.
- Activity pressure is positive on the latest completed week.

What could go wrong

- Price is below the Trend Line, which keeps downside pressure in focus.
- Price is below Fair Value, so the market is still discounting the latest tape.
- Next-week expectancy is negative at 36.98% based on similar historical setup states.
- Activity pressure is weak, so confirmation is not yet broad enough.

What to watch next

- Trend Line remains the key weekly regime level.
- Activity pressure is the gauge to monitor for confirmation or fade.
- A volume ratio above 1.5x would show stronger participation in the next move.

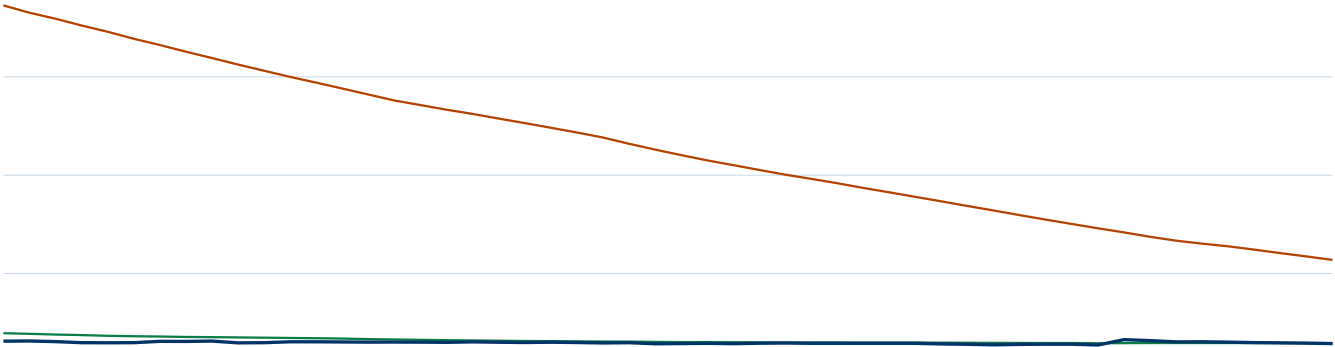

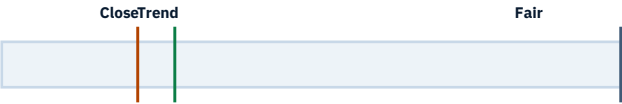

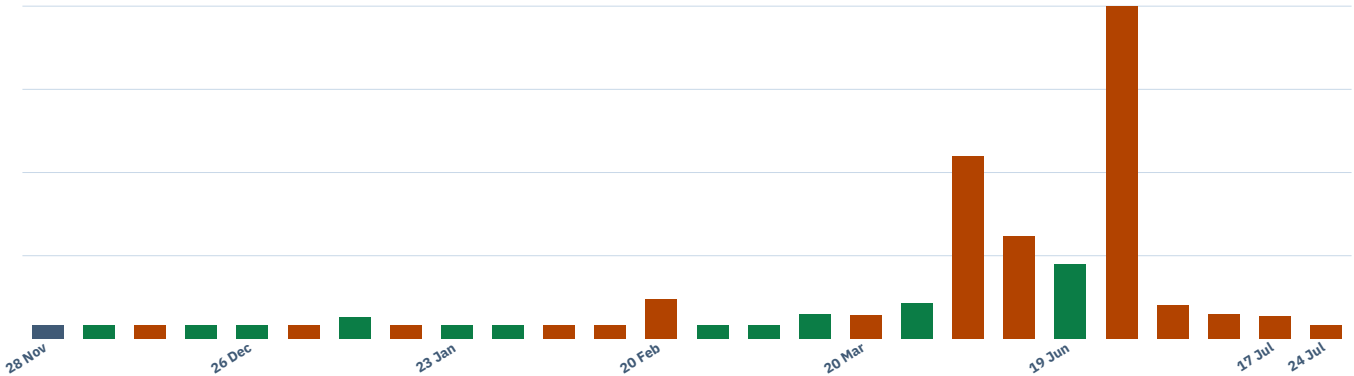
02 · VOLUME AND DEMAND

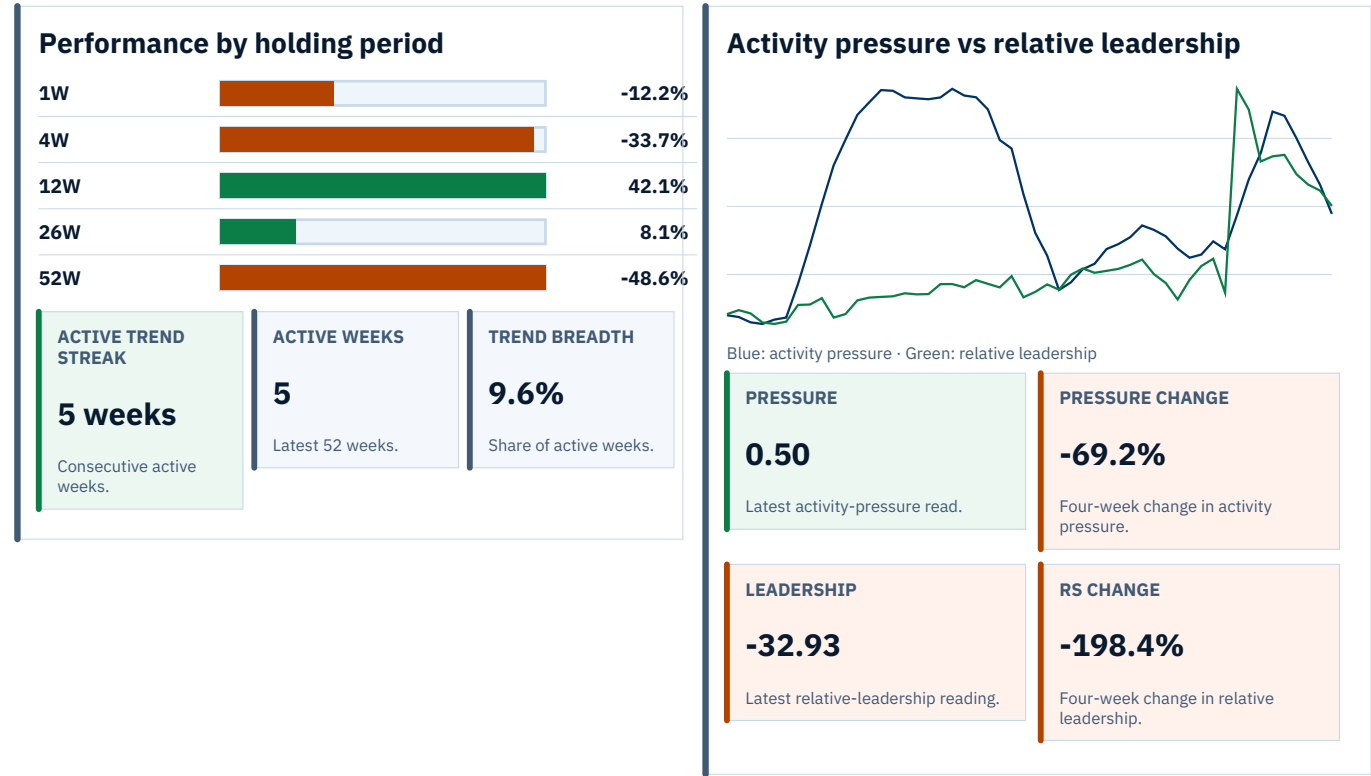

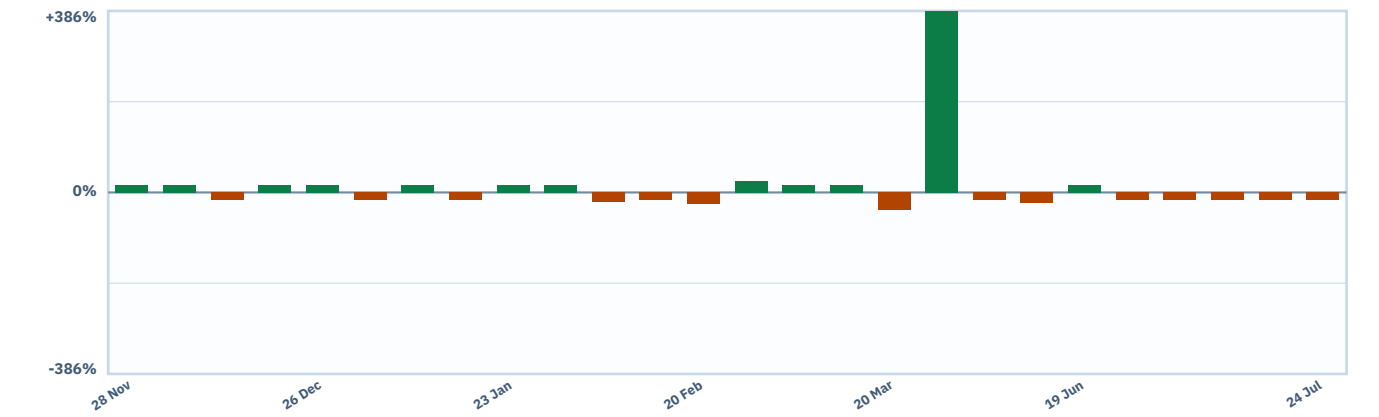
