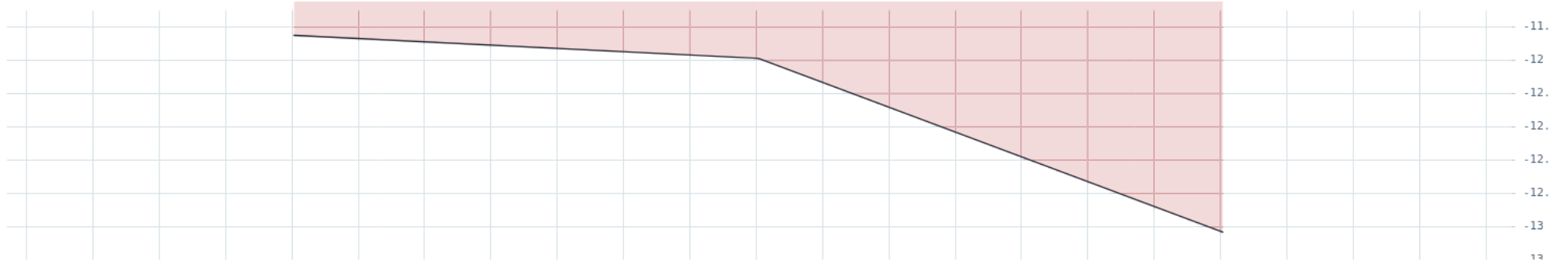

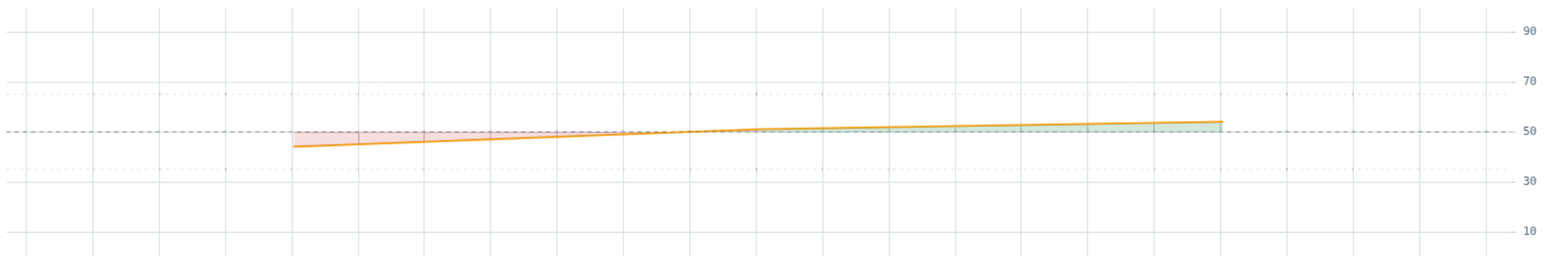

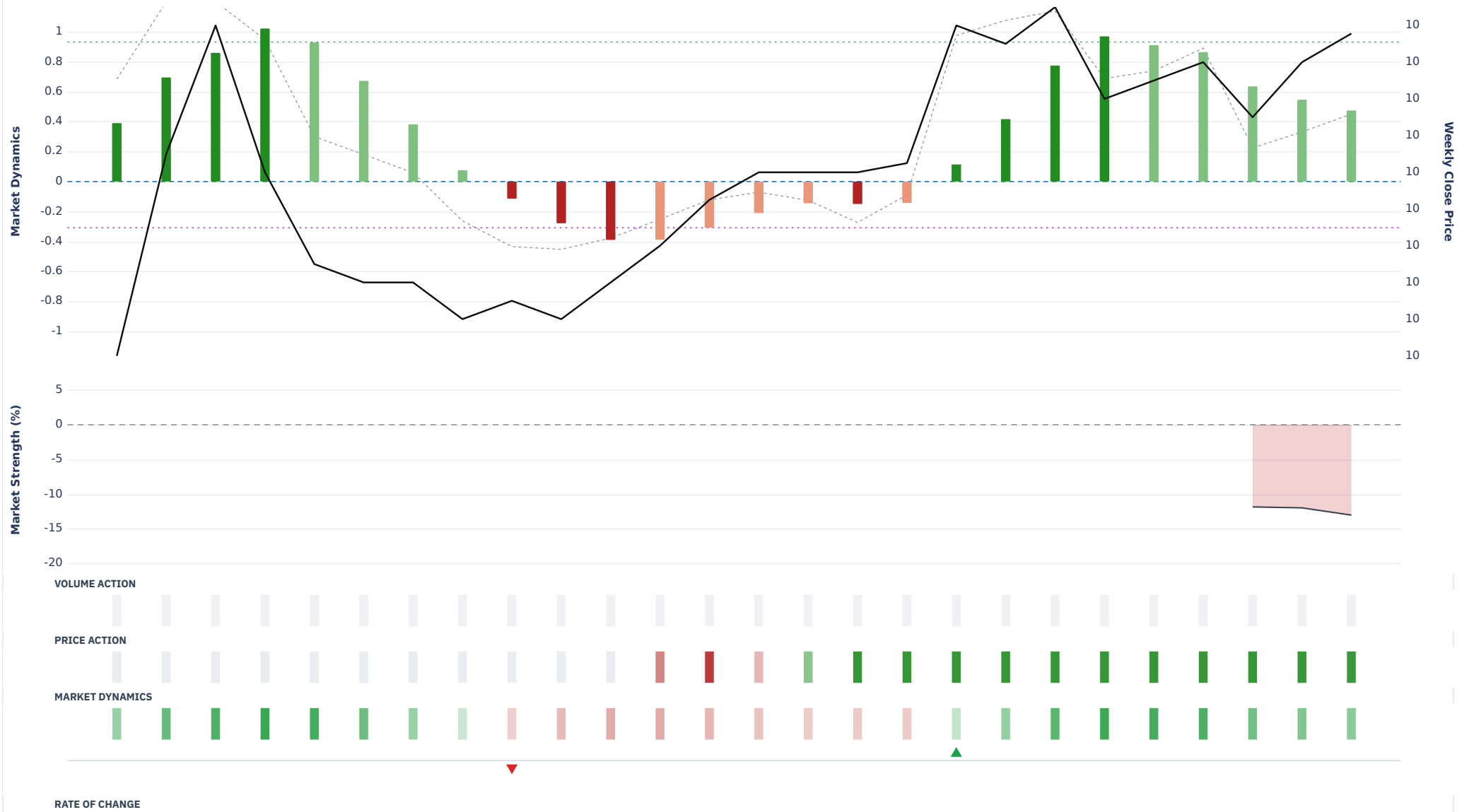

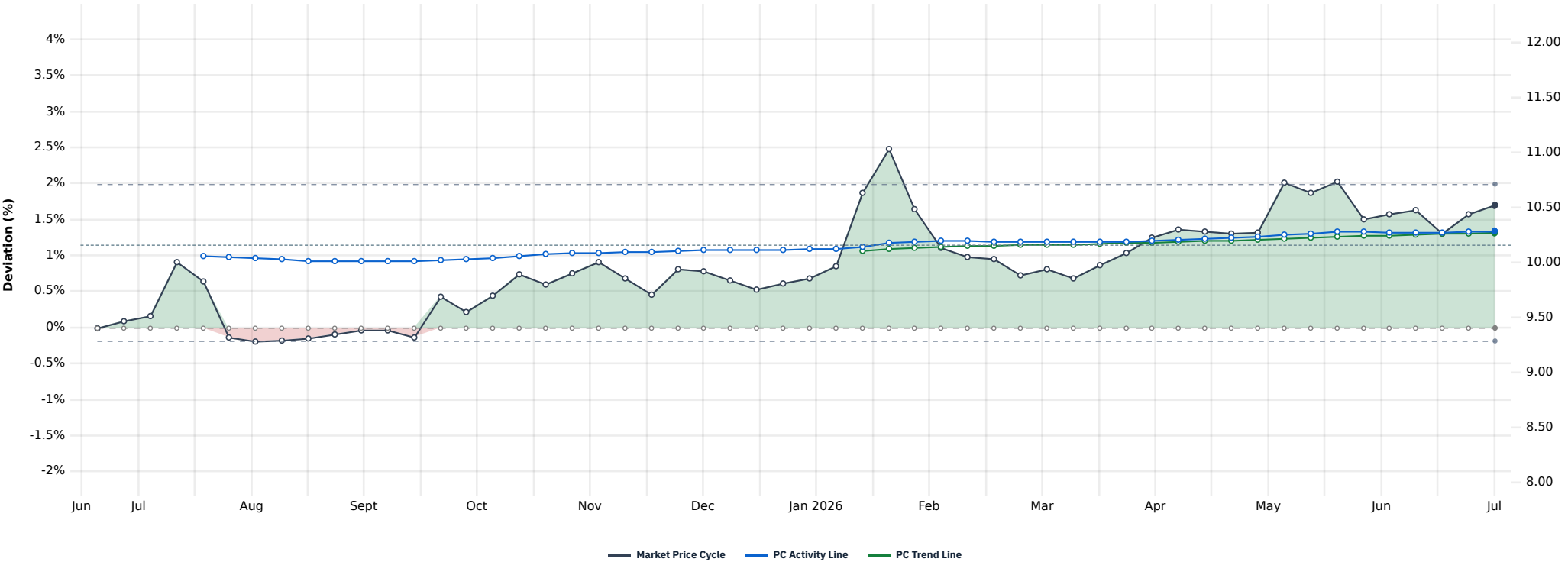

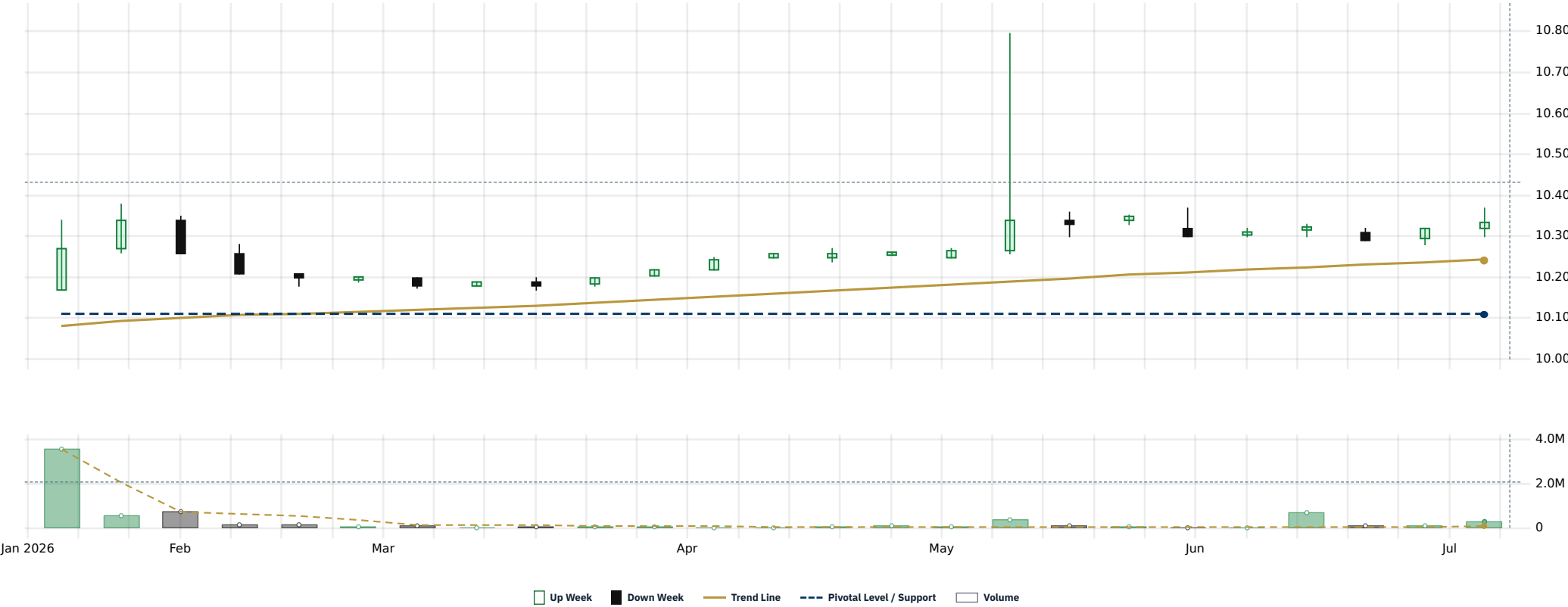
Price Cycle

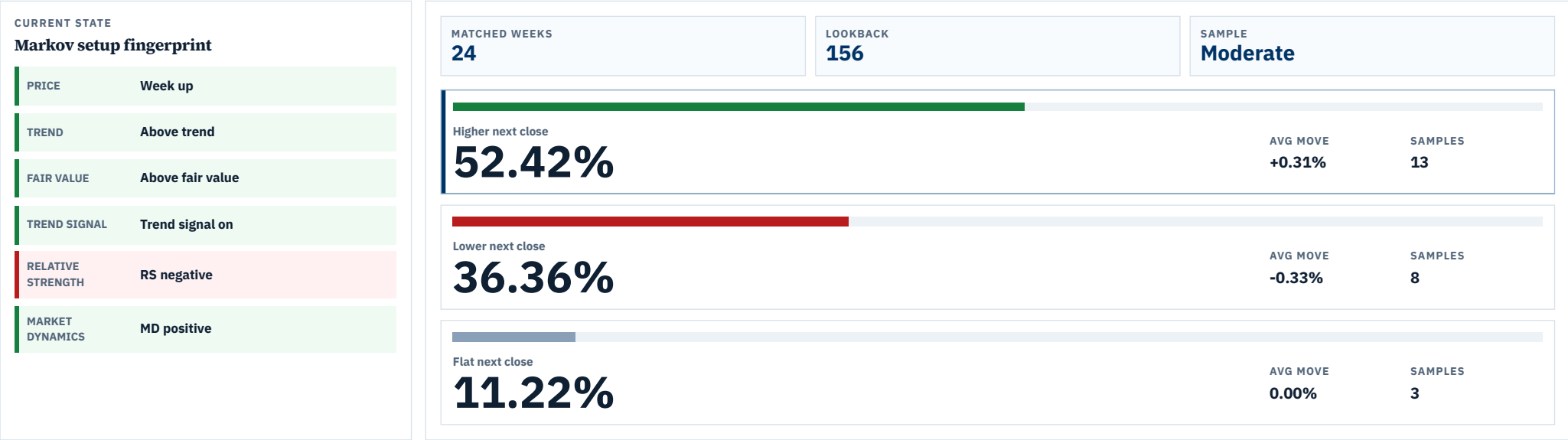
