- A volume ratio above 1.5x would show stronger participation in the next move.

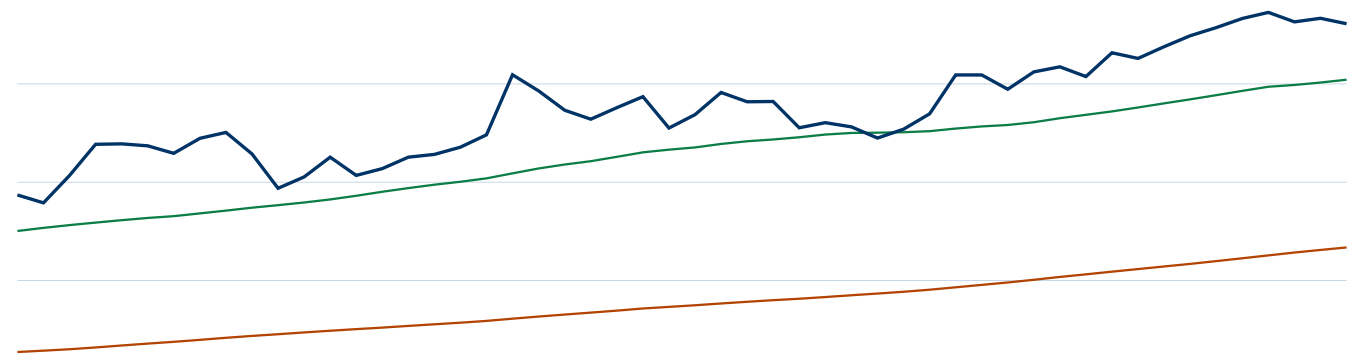

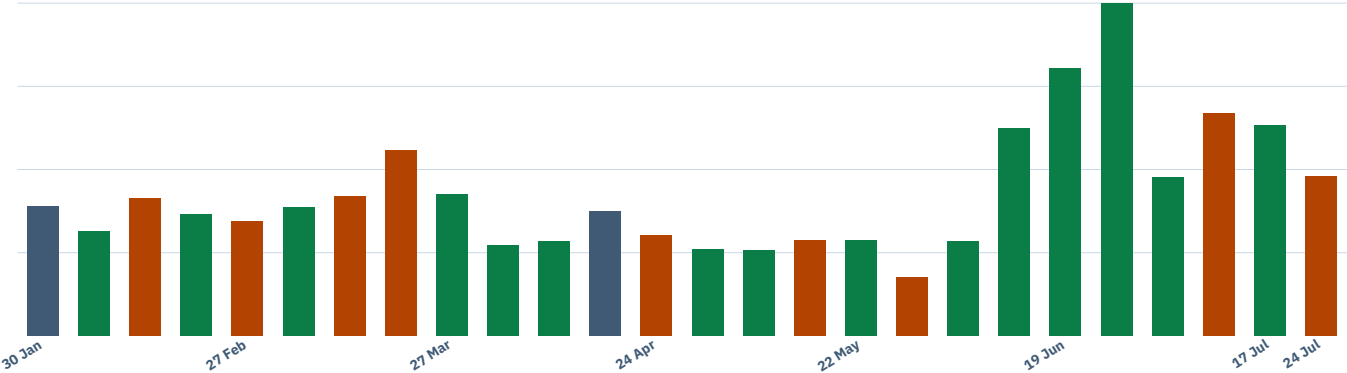
02 · VOLUME AND DEMAND

Activity pressure and institutional-style signals

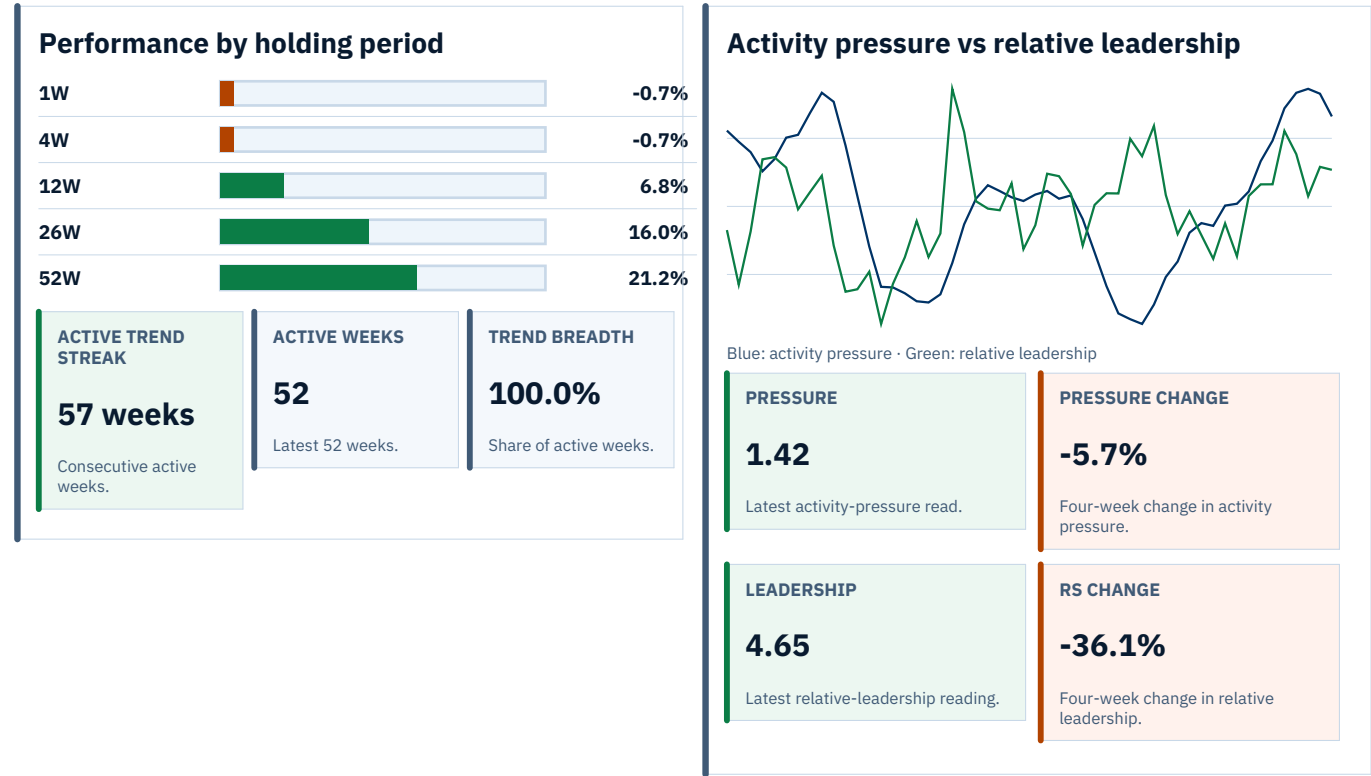

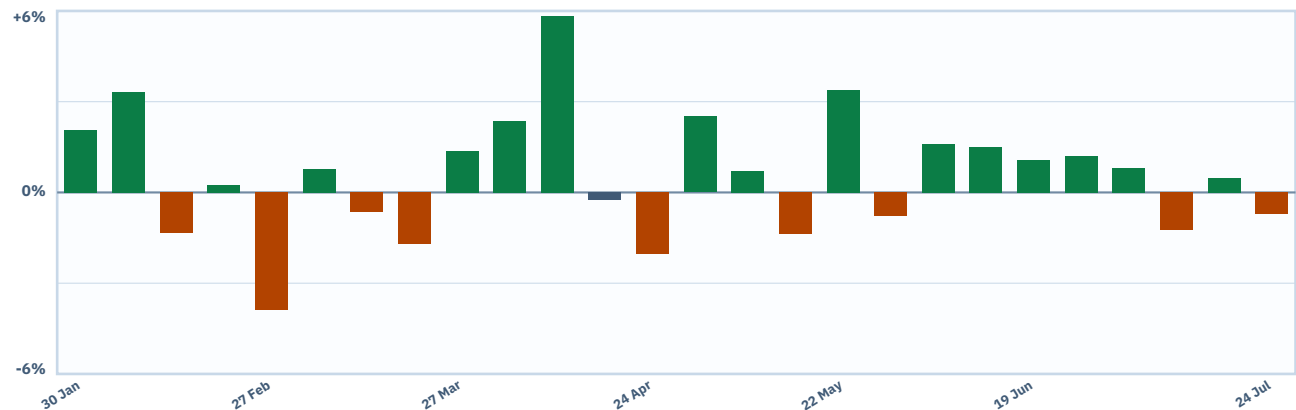
