Options positioning is volatility with 48/100 conviction, while the latest news-sentiment score is 60/100. Near-term considerations: earnings are due in 78d.

- A volume ratio above 1.5x would show stronger participation in the next move.

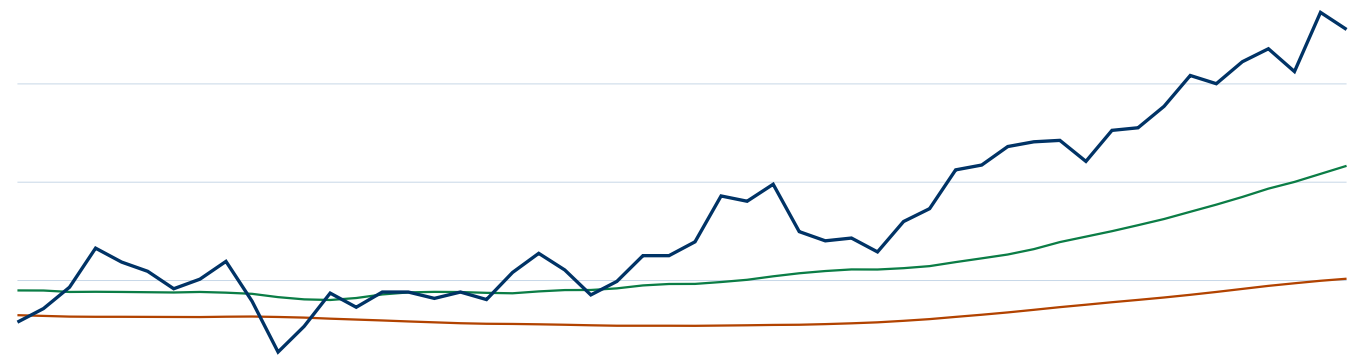

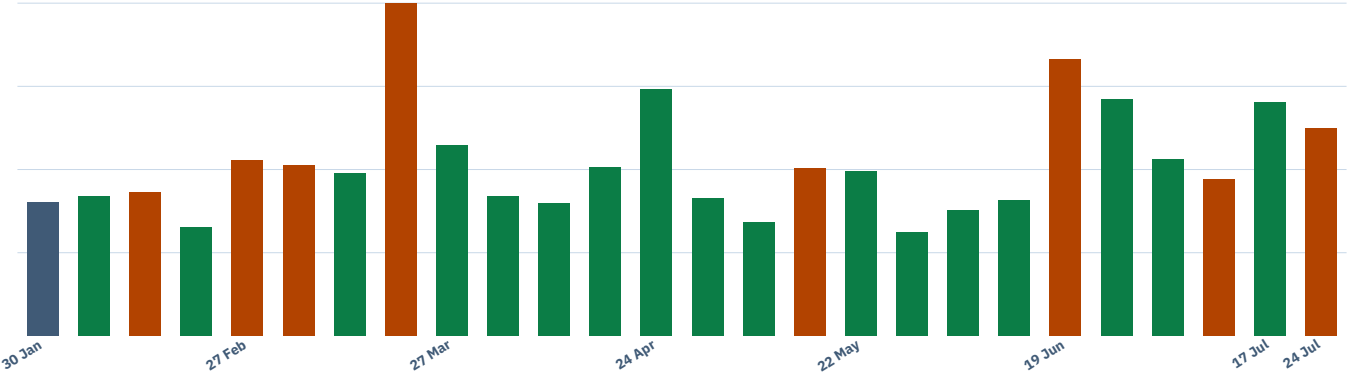

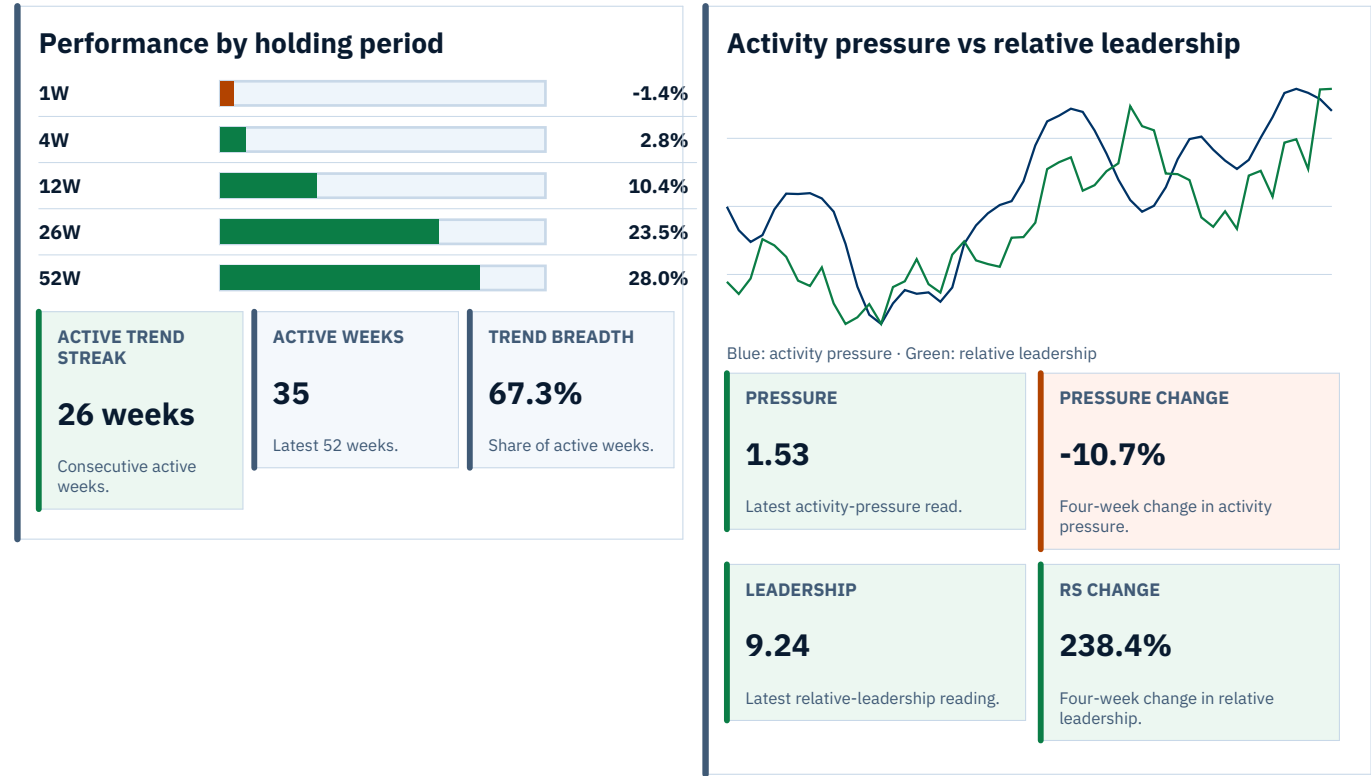

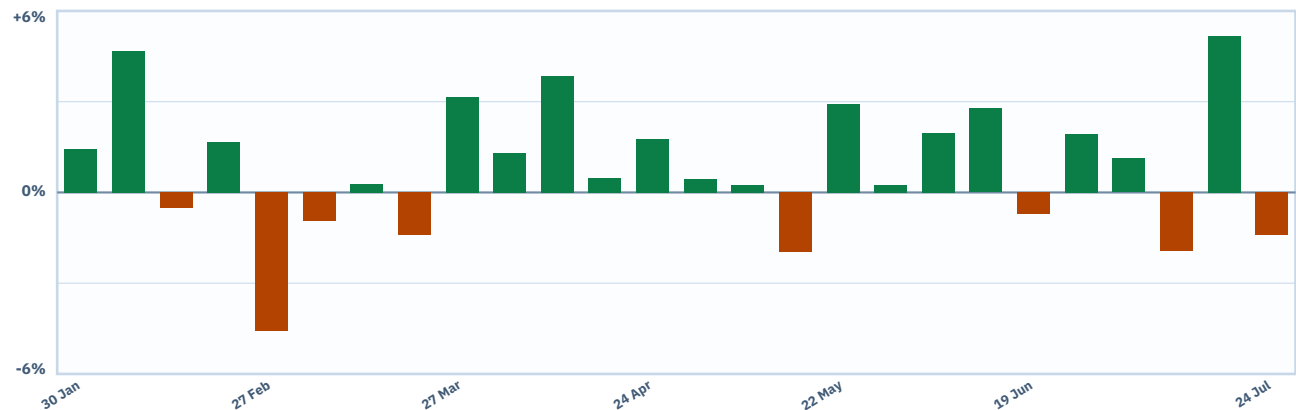
